**Scope of Work**

Abbey's Creative Designs agrees to deliver 3D rendering services to the Client, which may include but are not limited to:

- Still image renders of interior design projects in the form of JPEG or PNG files.
- Animated video walkthrough in the form of an mp4 video file.

Final deliverables will be provided via email or OneDrive (for larger files). Abbey's Creative Designs is not responsible for maintaining backups after delivery. The Client is responsible for downloading and securely storing all deliverables upon receipt.

**Illustrative Purpose Only**

The Client acknowledges and agrees that all 3D renderings, animations, layouts, and visual materials provided by Abbey's Creative Designs are for illustrative and presentation purposes only. Due to software limitations and the inherent nature of digital modeling, renderings are approximations and may not precisely reflect final built results.

All renderings are artistic interpretations and are not construction documents, technical drawings, or legally binding design plans. The Client is solely responsible for verifying all measurements, dimensions, layouts, and specifications with a licensed architect, designer, engineer, or contractor prior to fabrication, installation, or construction.

Abbey's Creative Designs assumes no liability for design accuracy, measurement errors, construction outcomes, or costs resulting from the use of its visual materials.

If the Client requires assistance converting concepts into 2D drafting or plans, such services may be provided for an additional fee, subject to the same limitations stated above.

### **Design Assistance & Conceptual Services**

If Abbey's Creative Designs provides design assistance, all provisions and limitations of this Agreement apply in full.

Abbey's Creative Designs may provide 3D renderings and a selection sheet identifying proposed materials, finishes, and furnishings. All design services are **conceptual only** and intended for visual guidance. Project implementation, purchasing, scheduling, and execution are the sole responsibility of the Client and will occur on the Client's own timeline.

Abbey's Creative Designs does not procure, order, or manage materials, furnishings, or labor. Selection assistance and product recommendations may be provided.

If a client requests in-person or out-of-town assistance for material selection or furniture shopping, such services will be billed at an additional hourly rate of \$45, plus any applicable travel expenses. For a site visit to discuss a new project and/ or take measurements of a space, a flat fee of \$150 will apply.

### **Requirements**

To complete the Services, the Client agrees to provide all necessary materials in a timely manner, which may include but are not limited to:

- PDF or AutoCAD files containing construction documents and detailed plans, including accurate dimensions for walls, doors, windows, and ceiling heights.
- Finish, fixture, and furniture specifications, including images, dimensions, fabric selections, and product details.
- Existing photos of the space (if applicable).
- Any additional drawings or information necessary for accuracy, such as elevations, sections, or casework details.

Work will not begin until all required materials are received and the deposit is paid.

## **Revisions/Feedback**

Upon initial completion, Abbey's Creative Designs will provide renderings for review via email or during a scheduled meeting. The Client is entitled to one (1) round of minor revisions.

Any additional revisions beyond this round, or revisions that materially alter the approved scope of work, will incur additional fees at a rate determined by Abbey's Creative Designs.

## **Process Overview**

**Step 1:** Initial consultation via phone (30 minutes) or email inquiry.

**Step 2:** Delivery of quote and this Agreement with payment terms and estimated timeline.

**Step 3:** Collection of all required materials and receipt of deposit.

**Step 4:** Review of draft renderings and minor revisions.

**Step 5:** Final invoice issued and release of final deliverables upon payment.

## **Compensation and Payment Terms**

- Total project fee will be determined based on scope, room type, and complexity.
- A non-refundable deposit of 50% is required before work begins.
- The remaining balance is due upon project completion.
- Final deliverables will not be released until full payment is received.

## **Ownership and Social Media Protection**

All renderings, images, videos, and visual materials created by Abbey's Creative Designs remain the intellectual property of the Provider.

Abbey's Creative Designs retains the right to display completed work in portfolios, marketing materials, websites, and social media platforms unless the Client provides written notice prior to project commencement.

When posting any of Abbey's Creative Designs' work publicly, the Client must provide proper attribution, including the business name and/or designated social media handle (e.g., "@abbeyscratedesigns").

The Client may not alter, crop, apply filters, overlay text, or otherwise modify any imagery or video without prior written consent from Abbey's Creative Designs.

Failure to comply with this section may result in a request for immediate removal of the content.

### **Confidentiality**

Both parties agree to keep confidential any non-public, project-related information exchanged during the course of this Agreement, except for materials covered under the social media and promotional use provisions above.

### **Limitation of Liability**

To the fullest extent permitted by law, the total liability of Abbey's Creative Designs for any and all claims arising out of or related to this Agreement shall be limited to the total amount paid by the Client under this Agreement.

In no event shall Abbey's Creative Designs be liable for any indirect, incidental, consequential, special, or punitive damages, including but not limited to loss of profits, construction costs, delays, or business interruption.

### **Indemnification**

The Client agrees to indemnify and hold harmless Abbey's Creative Designs from any claims, damages, losses, or expenses arising from inaccurate or incomplete information, drawings, measurements, or specifications provided by the Client, or from the Client's use or misuse of the renderings.

### **No Warranty**

Abbey's Creative Designs makes no warranties, express or implied, regarding the Services or deliverables, including but not limited to implied warranties of merchantability or fitness for a particular purpose.

### **Force Majeure**

Abbey's Creative Designs shall not be liable for delays or failure to perform caused by events beyond reasonable control, including but not limited to illness, power outages, software or hardware failure, internet disruptions, or natural disasters.

### **Termination**

Either party may terminate this Agreement upon written notice. In the event of termination by the Client, the non-refundable deposit shall be retained to cover work performed up to the termination date.

**Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of Louisiana.

**Entire Agreement**

This Agreement constitutes the entire agreement between the parties and supersedes all prior discussions or understandings. Any amendments must be made in writing and signed by both parties.
