### A Plea for Liberalism

Looking back one can say that 2018 was economically not as bad as expected. International trade developed rather well. The exchange of goods between India and Germany showed good signs of recovery after considerably slowing down after 2011. However, it seems too early to interpret this as a breakthrough. Quite contrary, the unholy alliance of nationalism and protectionism celebrates happy resurrection. Wherever one looks - to the UK Brexiters, Brazil, the Phillippines, Poland, Hungary, Turkey, etc. - it is evident that ideologies like "America first" are not restricted to the US President and his followers.

We are still far away from a renaissance of liberal and free trade. Neoliberalism has become a term of abuse, especially for the generations born after 1970. Countries which achieve surpluses in foreign trade are offended and treated like hoodlums who threaten the world. The advantages of a free world economy are apparently forgotten in the same way as the times of scarcity of food and everything else. Nearly nobody still remembers the system of rationing and apportionment through inefficient government bodies.

It needed great economists like John Maynard Keynes to end the times of war economics and short sighted nationalism. Thanks to them the wisdom of Adam Smith and Ricardo was recovered. They had the strength to push for multilateral solutions with strong organizations. The flourishing of the western world and the up-coming of many newly independent countries would not have been possible without the GATT system and the International Monetary Fund.

But that seems to be totally forgotten. Scarcity is for too many an unknown phenomenon. Instead of GATT the World Trade Organization was created; at best a toothless tiger! Multilateral agreements were substituted by so-called Free Trade Agreements in which nearly nothing is free, particularly for outsiders. Free movement of people and protection for refugees seems to be dangerous; obviously for those who have everything. Instead of looking here for improvement one evokes the end of the world because of every day new pseudo problems. It is high time to change this. The classic economists have still many messages which are worth to be seriously considered. And the wheel has not to be reinvented!

# INDO-ASIA BULGARIAN CHAMBER OF COMMERCE (IABCC)

IGEP is now running the office of Indo-Asia Bulgarian Chamber of Commerce (IABCC). The new chamber was launched at the end of 2017 by H.E. Petko Doykov, Ambassador of Bulgaria in India. Dr. Dietrich Kebschull was nominated as Chairman, Mrs. Sharda Subramaniam and Mr. Sridhar Subramonyan were appointed as Directors.

IABCC is a business chamber which aims to foster and promote mutually beneficial relations between India and Bulgaria through investment and trade. It will provide a platform for facilitating partnerships and networking opportunities between Indian and Bulgarian companies. It also aims to promote and to develop cultural and academic relations between the

two countries. In addition, it will offer Indian companies new possibilities to use Bulgaria as a springboard to the European Union, neighbouring Balkan countries and other markets in Eastern Europe.

#### **About Bulgaria**

The total population in Bulgaria is estimated at 7.1 million people in 2018. The per capita income has passed the US \$ 9,000 mark. The Gross Domestic Product (GDP) at present estimated to be US \$ 64 Billion.

The GDP per capita is growing at a stunning pace of 12.32% within the last five years. Exports rose at 7.4% annually. In addition to the business-friendly environment the well-educated and comparatively cheap workforce are magnets for foreign investments. More and more foreign companies are therefore going there, making significant investments with new production units and branches.





#### **Major Sectors**

Primary industrial exports are clothing, iron and steel, machinery and refined fuels.






#### Why Bulgaria?

The first India Business Day in the Federal State of Schleswig Holstein, Germany was held in the beautiful city of Luebeck on 12 December, 2018.


The event was organised by the Hamburg based India Business Forum e.V and the Consulate General of India together with Luebeck Chamber of Industry and Commerce.

The Little Keb-School is a project of the IGEP Trust with a mission to provide basic education to children belonging to deprived sections of society. Currently, there are 4 schools operating in India - one in Neb Sarai in Delhi and the others in the villages of Pancharukhi, Barkitand and Sapahi in the Federal State of Jharkhand. The children in these schools get free education (up to class V) as well as uniforms, books and nutritional mid-day meals. The schools in Jharkhand are also provided with a health and a vocational training centre. The Little Keb-School in Delhi has among others been supported by friends from many countries and by the Rotary Club of Delhi Midtown. The schools in Jharkhand are sponsored by the German pharmaceutical company Merck, our partner in Mica.

In addition to these schools six schools are run on behalf of IGEP's sister organisation Rugmark.



# Official Studies: No Child Labour in the Indian Granite Industry

There is no evidence for child labour in the Indian granite industry! This is the main result of a fact finding mission comprising the National Commission for the Protection of Child rights (NCPCR) and UNICEF India which was supported by representatives of the child relevant government ministries and institutions on federal state level.

The mission was carried out because of articles and other publications by foreign media and nongovernment organizations (NGOs) which portray the Indian granite industry in an extremely negative light; as a sector that encourages and employs child labour. To see for itself the ground realities the mission was undertaken in the leading granite states Andhra Pradesh, Telangana, Tamil Nadu and Karnataka in two phases in September 2017 and in February 2018. Two reports covering Andhra Pradesh and Telangana, respectively Tamil Nadu and Karnataka were prepared by NCPCR comprising audits of quarries and processing units, interviews with villagers, local administration heads, teachers and other decision makers. For all controls and visits the ISES 2020 standard of IGEP was used as the generally binding tool. IGEP provided the necessary technical advice and support.

The findings and recommendations which are obliging for government authorities as well as for manufacturers and exporters explicitly emphasize that there is no scope for child labour and no child labour could be found because "all processes of the granite industry are completely mechanized." They underline the responsibility to stick to the existing laws and to take care for implementing the rights of children for free and compulsory education. They also should provide and upgrade vocational skilling to the village communities.

## Press Conference on Granite Industry in Delhi and Nuernberg

The Indian granite industry and government authorities are making important steps for improving the international image of stone exports and protecting the employees of this industry. The two official studies of the National Commission for the Protection of Child Rights (NCPCR) and UNICEF India on the "Status of Child Labour in the Granite Industry" were released on 31 May, 2018 in a press conference in New Delhi.

The audience consisting of journalists and representatives of various organizations was

informed by NCPCR member Mr. Priyank Kanoongo, by Mr. Sunil R. Zode, High Powered Monitoring Committee of the Ministry of Micro, Small and Medium Enterprises and by R. Veeramani, Chairman of the Chemical and Allied Export Promotion Council of India (CAPEXIL).

The key message of the two study reports that the Indian granite industry is free of child labour was also emphatically given to international buyers, suppliers associations and media persons in a press meeting at the leading international fair Stone+tec on 13.June, 2018 in Nuernberg/Germany. The presentation was made by the Indian Consul General from Munich, Mr. Sugandh Rajaram. IGEP chairman, Dr. Kebschull, moderated the intensive discussion.

# Understanding of the Use of Health and Safety Equipment

Health and safety of the employees are key elements of the rules and regulations for corporate social responsibility. But time and again auditors as well as supervisors, managers and entrepreneurs realize that workers do not use dressings and equipments to protect themselves. The reasons are simple: workers, who have never seen such things before, do not like this "modern nonsense". They fail to understand how important it is for their own life and health and for avoiding serious violations which can endanger their working ability.

This phenomenon is not restricted to one industry. It can be found everywhere —in the engineering sectors, in the production of handicrafts, in dyeing units, tanneries, all types of mines etc. After many discussions IGEP's partner in mica mining, the German Merck Group, proposed to organize a workshop and training session to increase the use of health and safety equipment in mines and to safeguard the proper utilization.

The first round for the mica sector took place on 28 October, 2018 in the Little Keb-School in Sapahi/Jharkhand. The twenty five participants were company owners and managers, supervisors and selected auditors because they are responsible for introducing a better working culture and are the most important multipliers. The next round of this very lively and well accepted session will be the training of specially selected workers. IGEP will prepare this and also do the monitoring in the mines.

## **Survey and Action Plan for Mica Mining Areas**

The gathering was extremely high! Some thousand people from northern Jharkhand and many

organizations and politicians had come to the city of Koderma to attend a function arranged by non-government organizations of Peace Noble Price Laureate, Kailash Satyarthi for the Jharkhand Chief Minister, Shri Raghubar Das. The meeting on 28 October, 2018 dealt with concepts and proposals for abolishing child labour.

All speakers underlined the need of wiping out such violations of human rights. They convincingly promised their willingness to do whatever is possible against their intolerable activities, mainly by guaranteeing adequate school education and providing vocational training as prescribed in India's laws and administrative regulations.

The National Commission for Protection of Child Rights (NCPCR) had made much a "Survey on Education &Well Being of Children in Mica Mining Areas of Jharkhand & Bihar" for the event in Koderma. The new NCPCR chairman, Mr. Priyank Kanoongo, requested IGEP's Dr. Kebschull to hand over the summary of this survey to the Chief Minister. He explained that this was done because NCPCR used the tools of IGEP's International Social and Environmental Standard (ISES 2020) which were developed by IGEP for the whole survey. He announced that the action plan which is based on the findings of the survey is under preparation and will officially be given to the Chief Minister and all relevant authorities.

#### **Health Camps in Jharkhand**

Believing and abiding by the saying,"Health is Wealth", the IGEP Trust regularly organises health camps for remote villages in the state of Jharkhand. People living in the rural areas fundamentally lack on access to quality medical health care. They are forced to spend an enormous amount of money from their savings to visit nearby towns for medical



ailments and even for simple check-ups. The need for medical help increases in the monsoon season (June-September) as diseases such as malaria, dengue and tuberculosis spread rapidly due to poor hygienic conditions and lack of safe drinking water.

The IGEP Trust along with Merck(Germany) and the Medanta Hospital(Gurgaon) came together to organise two health camps in the districts of Giridih and Koderma in the Federal State of Jharkhand in August 2018. A team of doctors and attendants examined approx 900 people who visited the health camps for check-ups. Many of them work in the mica mining belt in the area.

Due to its popularity and the higher demand, the organisers have agreed to hold the next health camp in early 2019.

## **Export Promotion for Sri Lanka**

IGEP is working together with the Sri Lanka Export Development Board to promote business relations between India and Sri Lanka. An important project to promote Sri Lankan rubber glove exports to India has been undertaken and successfully completed. As first part of the project intensive market research was done in India. Potential exporters in Sri Lanka and their production facilities were visited and interviewed. Additionally, IGEP also organized B2B meetings in October, 2018 for a business delegation from Sri Lankan with importers from India. The meetings took place in the Embassy of Sri Lanka in New Delhi. The embassy gave valuable support for the rubber glove project.

importance of environmental and social compliance in exporting industries. He emphasised the need of concentrating on traditionally good markets and further regional diversification. He underlined the use of "selling" India as an additional market. He said that most countries and companies would not want to reduce employment in their home markets and to export jobs. But they always look for extra markets. This possibility is offered in a unique way by the growing Indian economy and by the chance to sell to the also fast growing neighbouring markets in South and South East Asia. He said he is convinced that India has a bright future as foreign investment location if it follows this concept.
