Optimism after Elections

The India election, the greatest show of democracy, is over. It ended positively. What nearly all Indian citizens wanted came true. The country has now a strong government with the absolute majority of seats for one party. And it seems to have elected the strong man who will be able to implement and fulfil. He is not enforced to always make long negotiations with coalition partners who insist on advantages and compromises. He can do most steps alone!

The first reactions are nearly unanimously optimistic. But the new Prime Minister, Shri Narendra Modi, is facing enormous expectations from all sides. Not a small number of his voters seem to be convinced that he can do miracles. After his first days in office there is broad hope that he makes India an economic super power, at least within this election period.

When the dust of the battle will have settled down, one will realize that some hopes were exaggerated because a huge country like India cannot be totally changed immediately. However, the chances for big progress are good. The now much criticized former government has - especially in the financial and monetary sector - paved the way for improving the economic fundamentals during the last months of its term. In addition, the world economy looks much better than one, two years ago. USA and the European Union (EU) are not yet back to smooth and high growth, but after managing complicated crises they are on a good way. If India is becoming a real partner for them and not just a country in South East Asia, it can gain a lot. This needs a firm position. But the first – nearly genial-stroke of the Prime Minister to emphasize the relations with SAARC, which seemed already to be forgotten, underlined his pragmatism and showed the world his willingness to make use of sleeping potentials for achieving his objectives – against all reservations.

Much will depend on the ability to create confidence and to carry out quick actions. Visible success in fighting inflation, creating new jobs, supervising the bureaucracy and enhancing exports will give much credit from the side of all those who had become disillusionized and tired. In Gujarat the Prime Minister has demonstrated his capabilities. His strict objective orientation is exactly that what his voters and the Indian citizens in general want. They are fed up only to hear why things cannot be done. They want economic progress combined with strict law and order.

With first positive results India may face a "real Modi wave" with even more support. Foreign capital is waiting for this development. It is therefore not unrealistic to expect that India within two or three years becomes a destination as important as China. With growing exports and technology transfer.

Let's not only wait and see, but actively participate in this movement.

GIRT Meeting for True and Positive Image of Carpet Industry

The accusation of using child labour in a big way remains a deadly threat for the Indian carpet industry also today. Twenty five years ago the carpet manufacturers and exporters had started a lot to wipe out the reproach of child labour and workers' exploitation by massive steps. IGEP took the lead together with numerous Indian companies and foreign buyers to introduce voluntary and unannounced controls and a labelling system to show that carpets were made socially correct – totally in

been established with the help of buyers and manufacturers/exporters. Vocational training courses were introduced and health care was improved. Publications in press and media helped to spread this information and so considerably supported the building up of a generally positive image of the carpet sector.

However, recently a study was published in USA which more or less repeated all the old attacks. CNN broadcasted the allegations made there by a young researcher and so brought back the life threatening dangers for the industry, its employees and their families who all are totally depending on foreign orders.









line with the Indian law and internationally binding agreements, e.g. with the International Labour Office (ILO) of the United Nations. Thanks to the Rugmark label introduced in the early nineties and other similar initiatives the possible collapse of the carpet industry and its exports could be avoided. Hundreds of thousands of work places have been safeguarded and companies and workers could continue their activities. In addition, schools for the children of poor families have

Against this background the All India Carpet Manufacturers Association (AlCMA), the Indian Carpet Export Promotion Council (CEPC) and many exporters approached IGEP. It was decided to first have a discussion and brainstorming session for further action within the framework of the German-Indian Round Table (GIRT). This meeting was held on 9 April, 2014 in the AlCMA premises in Bhadohi, Uttar Pradesh, India.

The great interest was underlined by the presence of

about eighty manufacturers and exporters, more or less including all important companies in the carpet sector of the Uttar Pradesh Carpet Belt. Chief Guest, V. Sharma from Obeetee explained the contents of the study, showed some major mistakes and made clear that joint action for correcting the dangerous consequences of false allegations is the need of the hour. He was supported by speakers of the associations and by Dr. Kebschull, who all emphasized that the whole industry has been put on the accusation bench and that fast action is now urgently necessary.

During the discussion it was unanimously stated by industry representatives that the main claims of the American paper are wrong and defamatory. Child labour is not used by exporters. Many of them have built their own strong control systems to avoid any violation of the law. But positive public relations are needed as well as the broad spreading of convincing facts about the industry.

It was decided that for this purpose all participants and organizations will join hands to carry out adequate measures in India and in all important target markets. Next meetings were agreed. IGEP promised to do its best to help accelerate necessary steps and to create and disseminate information for buyers.



BSCI India Office Participates in Roundtable on Sustainable Development in PHD Chamber, New Delhi

The BSCI India office participated in a roundtable which had the theme "Good Global Practices on Sustainable Development, Green Technology and Cleantech" on March 20th in PHD Chamber, New Delhi. BSCI India Office Continues to Assist Indian Exporters to Become BSCI Compliant.

The last six months have seen an upswing in Indian textile and home furnishing exports. Many Indian exporters would like to upgrade their factories to BSCI standards as this is becoming more and more a necessity especially for EU buyers. The BSCI office is therefore giving guidance to all exporters on the steps to be taken to become BSCI compliant exporters.

BSCI's representative in India, Dr. Dietrich Kebschull of IGEP had the opportunity to meet the German President during his visit as well as members from the Indian government. He highlighted the work of the BSCI office in India for the promotion of sustainable growth in the country. In this regard mention was also made how IGEP has for many years helped to introduce many German renewable energy firms to India. In some cases these dialogues have translated to actual cooperation agreements between the companies. Also the general promotional and social work of IGEP was mentioned.

Introduction of Wider Criteria for Factory Based Carpet Manufacturing

The RUGMARK concept was evolved by its founders basically to avoid the use of illegal child labour in carpet weaving. However with the weaving trend and demand for verification for additional social standards RUGMARK Foundation India carried out inspections of carpet manufacturing units, which are in factory set ups using criteria additional to the use of illegal child labour only.

As regards social & safety measures the following observations have been made in most of the cases:

- Fire extinguishers, first aid boxes, doors/gates and exit ways meant for using at the time of accident/emergency where clearly demarcated.
- Drinking water facility/hygienic toilets were found to be of reasonable standard.
- Notice boards placed at different places are highlighting the rights of workers and rates of minimum wages.
- The whole factory premises were found to be neat and clean.
- No hesitation was shown by the management to show their factory.

The IGEP Foundation along with RUGMARK has always taken a leading role in promoting exports from India and taking effective counter measures to prevent damage to manufacturing and exports. Since long, we are already

working with many big German buyer's towards assisting their suppliers in India in implementing the improvement with the "International Social and Environment Standards (ISES)" concept at their work-sites. The ISES standard is in line with SA 8000 and ISO 14000 standards, and is strictly following the laws of India and international orginizations. The idea is not to rank companies as good or bad, but to assist companies to achieve desirable standards.

IGEP Foundation is a certified body. It has received an accreditation for ISES 2020. This has been a big step forward for us as we are offering social and environmental consultancy since the last two decades. IGEP has functioned in a partnership approach and has been carrying out auditing assignments as an integral part of export promotion.

The fields covered under the ISES standard are: health & safety at work place, freedom of association, working hours, compensation, environment protection etc.

The audits are done hand-in-hand with the entrepreneurs. The basic first audit lasts normally only one day. Then according to the situation an adjustment and a "Corrective Action Plan" is developed. IGEP/RUGMARK advises what is to be done and a time plan is agreed. Then follows a re-audit. If things are ok, a certificate is a given. It is thus a process and not an event.

These audits are not aimed to give a company a certificate of "passed" or "not passed". The idea is of a constructive co-operation, where ways are found jointly to make necessary changes for strengthening international competitiveness by improving working conditions.












