#### Safety Officer; "Blurbs Blog":

(The following is an edited article that was previously run but holds great importance this time of year)

Cold Tire Failure: Upon researching this, here is what I found...

The internet has been buzzing recently with the story of a rider (in New Hampshire last winter) who experienced a failure with his Bridgestone BT45 tires. Bridgestone has claimed the failure is the result of cold temperatures in excess of the intended design, below 32F.

The guess is that the tire has a compound which dipped below it's freezing point and the added weight of the bike and rider on that tire, caused spider cracking through the outer layers of rubber. Since Firestone and Bridgestone both have had this issue on passenger car tires in the past it wouldn't shock anyone to know that the problem has now happened on their motorcycle tires..

I am sure we are all interested to see if Bridgestone will help this guy out and replace this tire (have not as yet), or if they are going to continue to claim that a motorcycle that experiences below freezing temperatures (and ridden) is abusive and therefore not a warranty defect for them to fix. Their responses as

he has posted online so far point out that "exposing" a tire to below freezing temperatures and riding during such," is bad".

Check out the picture of said tire, courtesy of the ironbutt.org forum user "nhrider".... he has it posted on about a dozen popular forums and I pictured it here...

\*Facts for the above article taken from an article in "The Rider".

Blurb NOTE: So "Heads-Up"!!! Remember, your tires will not get as "hot" during use during the winter and will not therefore handle the same on the pavement. Very important is to check the tire



pressure when cold. *No exceptions!* It's important to remember that your recommended tire pressure is its 'cold' tire inflation pressure, as in "not yet ridden" or "before you have driven more than a few miles"... otherwise rising temps from use, ambient temperatures or the sun's radiant heat will all affect the tire gauge reading.

Since air is a gas, it expands when heated and contracts when cooled. *This makes winter months the most critical times to check inflation pressures on a more regular basis*. The difference between average summer and winter temperatures is about 50° Fahrenheit, which results in a potential loss of about 5 psi as winter's temperatures set in. A 5 psi loss is enough to *greatly* sacrifice handling, traction, and durability... *and therefore your safety!* 

I have tried to reach Dunlop for their winter "recommendation" as to "winter "pressure but they sent me back a generic statement that is useless and inconclusive. An internet search will yield varied results with some saying to over-inflate cold tires by 5 pounds while others say "never to do this", therefore this article will have "no conclusion" but rather a "cautionary tone"!

Any questions you winter riders may have on this topic, please contact McDermott's HD and get a professional opinion!

Also Note: If your bike is in storage at home, make sure to move it a foot or so every month to insure against getting a flat spot in your tires!

Historian; "Blurbs Blog": I have written about our HOG chapter's history with as much information as can be obtained so now I am going to write a series of articles about our local towns and their history with information obtained from various internet resources and local historical societies....beginning with the town our wonderful Harley Davidson Dealership is in:

#### Ft Ann (Township) History Part 1:

"Colonial Period"

Fort Ann is located on the old historic route linking the French and English colonies of that time period.

The area was the site of several forts built by various nations, from a small French fort called "The Pickets" near the south end of Lake Champlain in 1689, in the northwest area of the town, to a series of forts (including "Fort Schuyler" and "Queen's Fort') closer to where the village of Fort Ann stands today. The first of these was likely the Stone Fort, built by Englishman Fitz John Winthrop in 1692. The English expedition led by Francis Nicholson built Fort Schuyler, about a half-mile south of the present village, in 1709. (The old Champlain Canal passed through a part of the site.) Nicholson burned the fort when he and his army left, but he returned in 1711 and built the Queen's Fort, later renamed Fort Anne, at the same site. It fell into ruins during the English colonial period.

Fort Anne was rebuilt in 1757 by the English, during the French and Indian War. The fort was named Fort Anne (in honor of Princess Anne, eldest daughter of King George II). The July 8<sup>th</sup> 1777 Battle of Fort Anne (NEXT month's article!) occurred here during the Saratoga Campaign. The town was organized as "Westfield" in 1784, but was renamed Fort Ann – without the "e" – in 1808!

The Early Town of Ft Ann

Part of the town was in the "Artillery Patent of 1764", granted to 24 officers of the British army. Settlement of the town did not occur until 1775. The town was established as the "Town of Westfield" in 1786 and was renamed Fort Ann in 1808. Parts of the original town were used to form the later towns of Dresden (1806), Hartford (1793), and Putnam (1806).

In 1820, the village of Fort Ann incorporated as a municipality within the town and in 1823, the Champlain Canal was completed, linking the area to the "outside world". Later the Delaware & Hudson Railroad established a depot at Fort Ann village.

Notable People Orestes Garrison, Wisconsin State Assemblyman Edwin R. Reynolds, former US Congressman

Blurbs:

Hogtown – An early name for western part of the town, it is a hamlet (no pun intended!). The name is derived from farmers having "let hogs forage freely"!

Ft Ann Town: Size: According to the United States Census Bureau, the town has a total area of 110.8 square miles, of which 109.5 square miles is land and 1.3 square miles is water.

The town lies partially within the Adirondack Park and of the county's (Washington County) 17 towns, Fort Ann is the largest by area.

Populations: Based on the latest census info available:


Town of Ft Ann: 6,417 people, 1,386 households, and 1,042 families residing in the town Village of Ft Ann: 471 people, 187 households, and 127 families residing in the village.


