
Historian; August 2016 "Blurbs Blog": Glens Falls, A Brief History Part I

I do think it interesting to explore the history and background of these local villages, cities and towns we ride through and this article will compile some history on Glens Falls! I gather all information from various internet sources, text book material, and also contact historical societies via email. I wish to acknowledge them all but do not want the tedious task of keeping and including a bibliography for each article....so suffice it to say I use a lot of sources and borrow their info with the best of intentions! So let us begin with some facts/stats and see where we go from there!

Glens Falls is a city in Warren County, New York, United States and is the central city of the Glens Falls Metropolitan Statistical Area. The population was 14,700 at the 2010 census. The name was given by Colonel Johannes Glen, the falls referring to a large waterfall in the Hudson River at the southern end of the city.

Glens Falls is a city located in the southeast corner of Warren County (notated in yellow at right), surrounded by the town of Queensbury to the north, east, and west, and by the Hudson River and Saratoga County to the south. Glens Falls is known as "Hometown U.S.A.", a title given to it by Look Magazine in 1944. The city has also referred to itself as the "Empire City.

Located in Warren County and Incorporated 1839 (village), 1908 (city)



A Brief History

As a halfway point between Forts Edward and William Henry, the falls was the site of several battles during the French and Indian War and the Revolutionary War. The then-hamlet was mostly destroyed by fire twice during the latter conflict, forcing the Quakers to abandon the settlement until the war ended in 1783. Fire also ravaged the village in 1864, 1884, and 1902. (We will side-bar and explore more about the




fires next newsletter so be sure to watch for that!)

The area was originally called Chepontuc (Iroquois; "difficult place to get around"), also referred to as the "Great Carrying Place," but was renamed "The Corners" by European-American settlers. In 1766 it was renamed Wing's Falls for Abraham Wing – the leader of the group of Quakers who established the permanent settlement – and for the falls on the Hudson River. Wing's claim to the name of the falls and the hamlet was transferred to Colonel Johannes Glen of Schenectady in 1788, in exchange for hosting a party for mutual friends, depending on which of several local legends is believed. Colonel Glen changed the name to "Glen's Falls," though it was often printed with varying spelling such as "Glenn's," or "Glens". The spelling "Glens Falls" came to be the common usage.

As Abraham Wing was so important to Glens Falls I will add here some more about him!

Abraham Wing was born August 4, 1721, in Dartmouth, Province of Massachusetts. He was the son of Edward and Sarah (Tucker) Wing. He married Anstis Wood in 1740 or 1741. They moved to Oblong, Dutchess Co., N.Y., ca. 1744.



In June of 1762 Mr. Wing purchased several of the Queensbury Patent lots from the patentees for a nominal sum. He was granted as a free gift, a lot of 10 acres containing the valuable water privileges on the left bank of the river, in consideration of his erecting a grist mill and saw mill at that point. (Grist Mill picture at left is of the rebuilt mill which was built in 1853).Mr. Wing, his dependents and laborers built three log houses in the fall of 1765. In the spring of 1766, their families moved into the houses. Mr. Wing's first farm was on the site of the present Glens Falls Home on Warren Street.

In May 1766, their first town meeting was held. Abraham Wing was elected supervisor of the town, a position to which he was reelected every year for many years." He was looked up to as the great man of the place, the merchant, the lawyer, the

minister and the innkeeper." He and other settlers suffered great material losses during the Revolutionary War.

At a very early period, a log dwelling of considerable dimensions was erected on the corner of what is now Ridge and Warren Streets for the purpose of a store and inn. There was a well at this site used for the accommodation of early settlers. It furnished very clear, pure, cold water. Here, according to the Wing papers, hundreds of pounds worth of liquor of various kinds were brought

from Albany, Montreal, and on one occasion from Nova Scotia. Here the Jessups, Hugh Munro, Capt. Bradshaw and the neighbors with but few exceptions, held high revel and ran up bar bills of lusty proportions. From the location of this tavern, the little settlement soon became known, in addition to its proper name of Queensbury patent, and its foster name of Wing's Falls, as Wing's Comers and finally as The Corners. Here too, according to the tradition of the Wing family, was held the entertainment and revel, which resulted in the loss of the children's birthright, the name of the place. The legend of the name change is as follows, Colonel Glen offered to pay the expenses of a wine supper for the entertainment of a party of mutual friends if Mr. Wing would consent to transfer his claim and title to the name of the falls.

Abraham Wing died May 3, 1795. Anstis Wing died May 29,1807. Their remains, with those of many other of the first settlers here, repose in the little burial ground by the Half-way Brook, where the old Quaker church stood. They were buried without tablet or monument, as is the Quaker tradition.

Safety Officer; "August 2016 Blurbs Blog": This month's article is Part IV (of 4) on "Understanding Motorcycle Batteries & Your Charging System" ... next month: Part 2 of "Your Charging System"!

How your charging system works

Without a good working charging system on your bike, you are not likely to go far. But don't confuse your <u>Harley-Davidson charging</u> system with the charging system of an automobile.

Most automobiles use a battery to operate electrical components when the engine is not running and to start the engine. After the engine is started the electrical components and systems operate using

power from the charging system or alternator. Therefore, if you disconnect a battery cable from an automobile while the engine is running, the engine and electrical systems will continue to operate. <u>Harley-Davidson's operate completely off of the battery</u> and the charging system simply replaces the voltage at the battery as it is used. If you disconnect a battery cable while a Harley is running—everything stops!

For a quick check to see if your charging system is working correctly, simply connect a volt meter to the positive and negative posts on the battery. With the engine running at 2000RPM you should read more than 14 VDC and not more than 14.7 VDC.

In General, a Harley-Davidson's charging system is made up of only three components (not counting wires). The Stator, Regulator/Rectifier and the Battery.

Stator

Several windings of copper wire coiled around an iron core mounted under the engine primary case (left side) with a magnetic 'Rotor' splined to the sprocket shaft. The plug exits at the left front of the engine case.

For those of you who are "do it Yourselfers"....Test the stator for continuity, check to be sure it's not grounded, test A/C voltage and amperage output. Inspect the rotor for signs of rubbing on the engine case or stator wiring and for any loose, cracked or broken magnets.



When replacing the stator, the four mounting bolts should always be replaced. If that is not possible be sure to clean and loctite the four bolts holding it to the engine case. For those of us who do not engage in these tasks... take your bike to McDermott's HD and they will check your charging system for you!



Regulator

The regulator is a solid state unit (mid 1970s and later) with cooling fins on the top. It is usually mounted near the front of the frame or engine.

The regulator is grounded to the frame or engine, plugged in to the stator plug_at the left front of the engine case with a long wire to the Main fuse or the battery. Note: Plugging or unplugging the regulator while the motor is running can cause an electrical spike and short out the regulator. By

testing for proper voltage at the battery, and then testing for proper voltage coming from the stator, you can determine the general condition of the regulator by the process of elimination. Regulators are easy to damage. Just a little too much amperage and that's all she wrote.
