Safety Officer; "October 2016 Blurbs Blog": This month's article is on "GPS, Map or Nothing"!

In this month's HOG magazine (volume 37), there is an article on page 17 entitled "Off the Grid or Tech connected". Reading this article prompted me to want to expand on the topic as I will call it "GPS, Map or Nothing".

I notice in the HOG article that people have varied opinions about being "tech-connected" or in this case using a GPS. The opinion seems to be that many believe using a GPS detracts "something" from the ride... and from the whole "it's about the ride not the destination" mentality.

I would thus interject as "bullet/blog points" some of the positive points to having GPS navigation on your bike!

- 1) With a GPS you can actually ride uninhibited with no regard as to where you are, knowing that when it is time to go home you simply click on "home" and off you go! This allows you to actually give full attention to your ride, the scenery etc and you "see more"...and you will take many more back roads you may have passed as you know it really doesn't matter where you end up as getting home is a simple click away!
- 2) You are SAFER with a GPS then without one! I keep my GPS turned on and zoomed out a few clicks. This allows me to "see" ahead and know if there is a hairpin turn for example coming up a short distance ahead giving me plenty of time to slow down and prepare for it. Knowing the road ahead is a tremendous asset especially when riding on new roads. You can also spot water features ahead and plan to look for pull-off areas to take a break and enjoy the scenery!
- 3) With a GPS you have a detailed set of maps right in front of you! No need to pull over and grab for that old paper map. Also, in the event you need fuel, food, medical attention etc the GPS has that information a few clicks away and will take you right to it. This knowledge makes your ride mentally more comfortable! A paper map does not show the nearest fuel stop nor the nearest hospital.
- 4) In the event of a breakdown, and they do happen...you need to call for roadside assistance. With a GPS, you can click on "my location" and give not only the nearest street address but also the longitude and latitude so that help can find you in the exact spot you are sitting in!
- 5) As for pertaining to use in leading chapter rides, it is extremely valuable! I have the ability to make exact routes on the computer incorporating all the back roads I want, the



rest stops, fuel stops etc...and load that route into the GPS. This makes for a wonderful ride experience for those following! I can thus plan distance/time between stops, time to the lunch stop, total miles and total time of ride etc with great accuracy!

It is not a matter of being "ruled by technology" and "losing a sense of the adventure" but quite the opposite! Because I have a GPS on my bike my adventures know no bounds and I can get insanely lost knowing I can get home, get fuel or medical attention, look up points of interest for the area I am in and see many more great places one might otherwise miss...it expands the possibilities and lets you ride "free" of stress!

I actually carry TWO GPS units on my bike with one put away as a back-up! It is such a pleasure to ride with you all! As always, Safety First! Jake Delgaudio Happy fall y'all.

Historian; "Blurbs Blog": Glens Falls, A Brief History Part II, The 3 Great Fires

Here we will continue on and build upon last months "part I" with more regarding Glens Falls History! Let's explore "The Great Fires"!


As you read about the history of some of Glens Falls' most iconic buildings, you may notice a theme: almost all of them were constructed after 1864, with many being erected after 1902. Since the settlement of Glens Falls (originally called "Wing's Falls) dates back to the mid-1700's, it raises the question, "Why aren't there more buildings in Glens Falls that

date back to the late 1700's and early 1800's?" The answer: fires.

Glens Falls went up in significant flames not once, but three times between 1864 and 1902, effectively wiping out most of the city's older buildings. Read on to learn more about each of the fires.

### The First Fire: 1864

The New York Times reported it as "**The Great Fire at Glen's Falls**," while the Glens Falls Messenger proclaimed it was "**one of the most destructive fires that ever happened in any village in the Northern States.**" On May 31, 1864, a fire broke out in the kitchen of the Glen's Falls Hotel, which today would've been located where Hudson Avenue enters Centennial Circle,



according to The Post Star. The fire spread quickly, consuming virtually all of the buildings in the downtown area on Glen, Exchange, Ridge, and Warren streets.

In total, 112 predominately wooden buildings met their demise in the fire, and the full damage was estimated at \$1 million in 1864, or \$14.9 million in today's dollars. Only three downtown buildings withstood the destruction. Some of the most notable buildings to be destroyed included, "the Glen's Falls Hotel, the Mansion House, the Glen's Falls and Commercial Banks, the Presbyterian, Methodist, Baptist, and Universalist Churches, the offices of the Republican and Messenger," and all but two of the "stores and shops in the village," according to an 1864 report from The New York Times.

### The Second Fire: 1884

Although architectural standards were changed after the devastating 1864 blaze, and many buildings were re-built with concrete and bricks instead of wood, another fire broke out on April 28, 1884. The Post Star reported that this second blaze began at "W.H. Guildersleeve's Union

Hall at the top of Glen Street hill," and spread from there. Among the buildings damaged or destroyed in this blaze were the Union Hall and the Cosgrove Opera House, a number of buildings and houses on Maple Street, and the Glens Falls Opera House and



Presbyterian Church on Warren Street. The fire also tore through "a row of saloon buildings known as 'Murderer's Row."" *The 1884 Photo above courtesy of the Chapman Museum* 

### The Third Fire: 1902

By this time, a municipal water system had been established in Glens Falls as a means of efficiently putting out fires. Even so, a third blaze started on April 26, 1902.

This fire began at Webb Brothers Clothing and Furnishing Store, which was then located at 146 Glen Street. When it was finally put out, 16 businesses on the west side of Glen Street had been destroyed, some of the more notable of which included the Glens Falls Daily Times publishers and the Joseph Fowler Shirt & Collar Co.

### Impact Of The Fires

Although the fires were devastating, the resiliance of Glens Falls was proven by its residents' determination to rebuild after each blaze. Some of the most positive outcomes of the fires include the establishment of a municipal water system and the improvement of building standards.
