

**Release & Waiver of Liability,
Assumption of Risk & Indemnity Agreement**

IN CONSIDERATION of being permitted to observe, participate in any way, in any Town of Newell Rodeo/Community Club events or activities, I for myself, my personal representatives, heirs & next of kin:

- (1) Hereby RELEASE, WAIVE, & DISCHARGE, the Newell Community Club, The City of Newell, the promoters, participants, sanctioning organizations or any affiliate, sponsors, advertisers, owners & lessees of premises, offices, agents, members & employees, all for the purposes herein referred to as "RELEASEES" FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, & next of kin FOR ANY & ALL LOSS OR DAMAGE, & ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE ACTIVITIES WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES INCLUDING NEGLIGENT RESCUE OPERATIONS OR OTHERWISE. In addition, I COVENANT NOT TO SUE any of the RELEASEES based upon any claim arising out of any of the RODEO/PLAY DAYS/PRACTISE.
- (2) Hereby, I ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the Rodeo/Rodeo Grounds whether caused by NEGLIGENCE OF RELEASEES or otherwise.
- (3) Hereby, I AGREE TO INDEMNIFY, SAVE, & HOLD HARMLESS THE RELEASEES & each of them from any loss, liability, damage or cost they may incur due to claims brought against the RELEASEES arising out of my injury, or death, or damage to my property while I am in the RESTRICTED AREAS &/or while competing, practicing, observing or working for any purpose participating in the RODEO/ RODEO GROUNDS & whether caused by the negligence of the RELEASEES or otherwise.

I HAVE READ THIS RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK & INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, & HAVE SIGNED IT FREELY & VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME & INTEND MY SIGNATURE TO BE COMPLETE & UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW IN THE STATE OF SOUTH DAKOTA.
