What to Know:



State law, not the Town Council, mandated housing policies that severely limit local control.



Like all Marin jurisdictions, the Fairfax town council followed state laws and updated the Housing Element to avoid crippling state fines and a Sacramento takeover.



Independent audits confirm strong financial management, with one of the highest reserves for a town our size.



The next election is in Nov. 2026. Let's not waste time and an estimated \$60,000 on an unnecessary extra election.

This recall isn't about better governance. It's about eroding community trust with MAGA-style tactics: disinformation, personal attacks, and manufactured outrage. **Fairfax faces tough challenges—now is the time to unite, not divide.**
