Please be advised, beginning on/about Monday, June 22, 2020, the New York City Department of Design and Construction (NYC DDC) on behalf of the New York City Department of Environmental Protection (NYC DEP) will commence infrastructure upgrades at the intersection of State and Nevins Streets, beginning with mobilization of materials. This project entails the installation/ replacement of trunk water mains, valves & appurtenances, weather and field conditions permitting. The permitted work hours will be Monday through Friday from 7:00 AM to 6:00 PM.

What are the Community Impacts?

- The DDC is committed to maintaining a work site that is safe and clean. However, dust, noise and heavy equipment are common elements of construction and we ask for your patience during the project.
- There may be limited street access on certain blocks. However, deliveries to commercial/residential properties and emergency vehicle access will be allowed. In addition, the DDC will be baiting the construction zone on a regular basis to control rodent populations.

Some Things to Remember:

- Please follow all posted DOT rules and regulations during non-construction hours.
 Emergency vehicle and Pedestrian access will be maintained at all times.
- Driveway/Loading dock access
 may be temporarily restricted.
- Vehicular access may be restricted on certain streets in certain locations.

Pedestrian/Traffic

- Pedestrian access to buildings will be maintained at all times.
- Parking will be temporarily restricted so construction may proceed. Signs will be posted where necessary.

Water Service Interruptions

- Temporary water service disruptions may be necessary in order to replace the water mains. If it is necessary for DDC to turn off your water service, you will receive advance written notification 72 hours before the service interruption.
- Water service will be restored everyday by 6:00pm or by the end of work shift. If additional shutdowns are required, you will receive a new notice daily until work is completed.

Special Needs

 Individuals with special needs who may be uniquely impacted by this project should contact the project's field office, as soon as possible, to make them aware of your situation. The DDC will work with you to attempt to minimize the inconvenience as much as possible.
