2020 STRAWBERRY FESTIVAL QUEEN PAGEANT CONTRACT

I. Eligibility of contestant to participate in the Strawberry Festival Queen Pageant

1.1 *Age.* I am or will be on Strawberry Festival Day, May 9, 2020 no younger than 16 and no older than 21 years of age.

1.2 *Residence.* I am claiming eligibility to compete in the Stilwell Strawberry Festival Queen Pageant based upon my residence in Adair County. I must have been a resident of Adair County for at least six (6) months prior to the competition.

1.3 *Personal Characteristics.* I understand that in order to be eligible to compete in the Stilwell Strawberry Festival Pageant, I hereby certify to the Personal Characteristics set forth in this section:

- 1.3.1 *I am not now married and I have never been married, nor have I had a marriage annulled.*
- 1.3.2 *I am not now pregnant, and I have never been pregnant. I am not an adoptive parent of any child.*
- 1.3.3 *I am of good moral character and I have not been involved at any time in any act of moral turpitude.*
- 1.3.4 *I have never performed any act or engaged in any activity or employment that is or could reasonably be characterized as dishonest, immoral or indecent.*
- 1.3.5 *I do not use or consume any illegal controlled dangerous substances or abuse the use of alcohol or other dangerous substances. (I understand that I must complete any and all urine drug test screenings that are requested of me. I further understand that should I decline or not pass the drug test, I will not be eligible to compete in the pageant).*

1.4 *Attendance.* I understand that I need to attend as many rehearsals as possible in order to be prepared to perform successfully in the event. I agree to be present at all rehearsals as well as the pageant dress rehearsal unless my absence is absolutely necessary and is approved in advance by the pageant director. I understand that if my absence(s) affect the progression of the group's overall preparation, the pageant director/ committee will notify the Stilwell Kiwanis Board, and the board will have the sole discretion of allowing me to continue in the pageant process or not at any point.

1.5 *Attitude and Behavior.* I agree to be respectful and have a positive and receptive attitude to the pageant director and committee, as well as to other contestants. Should I not be able to do this, I understand that the pageant director/committee will notify the Stilwell Kiwanis Board, and the board will have the sole discretion of allowing me to continue in the pageant process or not at any point.

II. Use of Strawberry Festival Queen Title

If selected as 2020 Stilwell Strawberry Festival Queen, I shall not use, or allow another party to use my status while appearing in an official capacity as 2020 Stilwell Strawberry Festival Queen or Queen-elect for public announcement or for advertising and promotional purposes without prior written approval of the Stilwell Kiwanis Club.

III. Availability for Appearances and Events

I agree to make myself available for such personal appearances, interviews, testimonials, endorsements, filming, tapings, photographic and recording sessions and other various commitments and events related to my Year of Service that the Stilwell Kiwanis Club has made and will make for me in its sole discretion. I agree to be on time, if not early, to all appearances.

Therefore, by signing this Application and Contract and submitting it to the Stilwell Kiwanis Club for approval, the contestant represents and agrees that (1) all facts and representations contained on this Application and Contract and its attachments are true and accurate; (2) the Contestant agrees to abide by all the rules and regulations of the Kiwanis Club and the Strawberry Festival Queen Pageant described in this Application and Contract and its attachments, in the period before and during the Year of Service; and (3) the Stilwell Kiwanis Club shall have the sole discretion to determine whether, in its judgment, the Contestant may continue to participate in the Strawberry Festival Queen Pageant in the event that the Kiwanis Club determines that any statement or representation by the Contestant is not true and accurate or that any action by the contestant is inconsistent with the rules and regulations of the Pageant.
