## **Entertainment And Legal Representation Agreement**

This Entertainment and Legal Representation Agreement ("Agreement") is made and entered into as of this [03/17/2025] by and between:

Southside Recordz ~ (Conglomerate), a [Nevada]; [Sole Proprietorship Company], with its principal place of business at: [9620 Las Vegas Blvd S, Ste E4 516, Las Vegas, NV 89123] {"Southside Recordz ~ (THE CONGLOMERATE)"},

and

Edward Rawlinson, professionally known as AKA DJ Killa Karolina, residing at [20820 Torrence Chapel Rd, Cornelius, NC 28031] ("Artist").

WHEREAS, **Southside Recordz** ~ **(THE CONGLOMERATE)** is engaged in the business of providing entertainment, legal representation, and related services to artists; and

WHEREAS, Artist desires to engage **Southside Recordz** ~ **(THE CONGLOMERATE)** to provide such services;

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

- 1. Representation and Services:
- 1.1 Entertainment Services: **Southside Recordz** ~ **(THE CONGLOMERATE)** shall act as Artist's exclusive representative for all entertainment-related matters, including, but not limited to:
- \* Recording contracts and negotiations.
- \* Performance bookings and negotiations.

- \* Merchandising and endorsement agreements.
- \* Public relations and media management.
- \* Career development and strategic planning.
- \* Copyright and trademark management relating to entertainment.
- 1.2 Legal Representation: **Southside Recordz** ~ **(THE CONGLOMERATE)** shall provide or arrange for legal representation for Artist in all matters relating to Artist's entertainment career and all personal dealings outside of the entertainment industry, including, but not limited to:
- \* Contract negotiation and drafting.
- \* Litigation and dispute resolution.
- \* Intellectual property protection.
- \* Business transactions.
- \* Personal legal matters as agreed upon.
- 1.3 Scope of Personal Dealings: The "personal dealings" covered by this agreement, are not limited to legal matters that are directly affected by the artist's professional career. Any personal legal matters outside of that scope, do not require a seperate written agreement.
- 2. Term and Termination:
- 2.1 Term: This Agreement shall commence on the Effective Date and shall continue for a period of [3] years, unless earlier terminated as provided herein.
- 2.2 Termination:
- \* Either party may terminate this Agreement upon [30] days' written notice in the event of a material breach by the other party.
- \* Mutual agreement in writing.
- 3. Compensation:
- 3.1 Entertainment Services: Southside Recordz ~ (THE CONGLOMERATE) shall receive [25]% of Artist's gross income derived from entertainment-related activities.
- 3.2 Legal Representation: Legal fees will be billed at standard rates, or at a flat fee negotiated by both parties, and will be deducted from Artists income, or paid directly by artist. A schedule of these rates will be provided as an addendum to this document.

- 3.3 Expenses: Artist shall reimburse **Southside Recordz** ~ **(THE CONGLOMERATE)** for all reasonable out-of-pocket expenses incurred in connection with the performance of its services.
- 4. Artist's Obligations:
- 4.1 Cooperation: Artist shall cooperate fully with **Southside Recordz** ~ **(THE CONGLOMERATE)** and provide all necessary information and materials.
- 4.2 Exclusivity: Artist shall not engage any other person or entity to provide the services covered by this Agreement.
- 4.3 Notification: Artist will notify **Southside Recordz ~ (THE CONGLOMERATE)** of all offers, and proposed deals, related to the artists career.
- 5. Southside Recordz ~ (THE CONGLOMERATE) Obligations:
- 5.1 Best Efforts: **Southside Recordz ~ (THE CONGLOMERATE)** shall use its best efforts to promote Artist's career and protect Artist's interests.
- 5.2 Accountability: **Southside Recordz ~ (THE CONGLOMERATE)** shall provide Artist with regular accountings of all income and expenses.
- 5.3 Confidentiality: **Southside Recordz** ~ **(THE CONGLOMERATE)** shall maintain the confidentiality of all information provided by Artist.
- 6. Governing Law and Dispute Resolution:
- 6.1 Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of [NEVADA].
- 6.2 Dispute Resolution: Any dispute arising out of or relating to this Agreement shall be resolved through [MEDIATION/ARBITRATION/LITIGATION].
- 7. Entire Agreement:

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings.

8. Amendment:

This Agreement may be amended only by a written instrument signed by both parties.
