To All:

In the past two years and especially in the last four months, my mother has experienced malnutrition, hunger, dehydration, assault, and sanitary issues. Further Mom's life was placed in danger on February 3, 2011, when Bart had Mom taken out in twenty degrees below freezing weather wearing house slippers, light weight pants and a sweater. My mother, 89 year old Emma Parr, has been subjected to Elder Abuse under the supervision of her legal guardian, Barton Cox, license #991048.

I was never notified by Bart that Mom had been admitted to the Emergency Room on January 8, 2011 (for severe stomach bleeding because of her poor diet) until two days later. Also, if Bart had not been stopped, he would have forced Mom to unnecessarily have four major teeth extracted, when all that was needed was to have her front tooth rebuilt. On the night of April 5, 2011, Mom was assaulted at The Court at Denver with a blunt object while asleep in bed leaving both eyes blackened. Mom was found the following morning in bed and was sent to the Emergency Room for seven hours.

Bart falsified his Annual Report to Arapahoe County Court On April 7, 2011. This leads me to believe that Bart has falsified other documents as well. Until a through investigation is completed other legal documents could be in question.

Bart also had Mom admitted to a Hospice; which one I still do not know. On April 16, 2011, I called the conservator, Patty, to ask if she had any information regarding which Hospice. Patty did not know. In my conversation with Patty she said Bart had called her and asked what funeral home Emma has arrangements with. He thought it was the one in Englewood but when he called them, they did not have Emma in their records. Apparently, Bart is already preparing Mom's funeral arrangements. Isn't this a personal issue that is left to family members? Where does Bart's guardianship stop?

As I stated in my April 4, 2011 letter my next check will be written to a funeral home. Now that possibility is here and is greater then ever. The only inhuman and destructive thing Bart has yet to do to Mom is spit on her and then kick dirt in her grave.

Bart had Mom admitted to Hospice because Mom apparently has "cognitive decline". If this is the case, according to Bart, all people experiencing Dementia or Alzheimer's should be in Hospice and there would not be any need for Alzheimer's facilities.

I Googled the traits of Bart Cox's personality and all the behaviors I have documented for the past four months. They are perfectly summed up by Dr. Tom O'Connor in the paragraph below found on http://www.drtomoconnor.com/1060/1060lect04b.htm :

"AGGRESSIVE SOCIOPATHS derive strong, yet nonperverse gratification from harming others. They like to hurt, frighten, tyrannize, bully, and manipulate. They do it for a sense of power and control, and will often only drop subtle hints about what they are up to. They polish their aggressive, domineering manner in such a way to disguise any intimidation others might feel. They seek out positions of power, such as parent, teacher, bureaucrat, supervisor, or police officer. Their style is one of passive aggression as they systematically go about sabotaging the ideas of others to get their ideas in place. In their spare time, they like to hunt or occasionally do sadistic things like find stray dogs and cut them up. They are usually effective at getting their way, and are especially vindictive if resisted or crossed. They don't follow the social norm of reciprocity like others do."

Bart's behavior has been nothing but vindictive. I question his mental stability. Instead of addressing me directly; he is sadistically taking it out on Mom. I believe Bart, owner of Care Management Advocates LLC, is unfit as a guardian. A thorough investigation by the proper authorities will be conducted regarding Bart's qualifications as guardian, a position of trust. I have documented all these issues and events. Once the investigation is conducted the authorities may uncover many more abuses to other families under Bart's supervision.

Bart said to me February 14, 2011, "Your mother doesn't need a Power of Attorney, she has a Guardian." Mom is a defenseless Elder and Bart is diminishing her life through his abuse. I am Power of Attorney for Emma Parr, and I advocate for her rights as a human being.
