To date, no money had been spent on a new speed sign. Larry asked about if an audit had been completed. Henry indicated that this still had not been done. OLD BUSINESS

- Larry indicated that there has been no update on finalizing the WGPOA By-Laws. Larry to follow-up with the lawyer on getting the By-Laws finalized.
- There has been no progress on getting an additional speed sign. Larry is going to order the same speed sign that we currently have and will work with the township to get it put up.
- Larry discussed the insurance claim relating to the accident that caused damage to the fence.
 Larry does have a copy of the accident report. Larry needs to get pictures so he can send a claim to the insurance company for \$800 damage to the fence.
- Larry talked to the Pingree Grove Fire Department about getting older fire signs replaced per a homeowner's request. Larry said that the Pingree Grove Fire Department is already working on this.
- The Board talked about the cart paths. The lights on the cart paths are old and need to be replaced. Henry volunteered to get new solar lights and replace the current lights. We

also talked about getting golf cart only signs. Jason went on line and found reflective golf cart only signs made of aluminum. We agreed that we would need 6 signs and the board gave Jason the approval to purchase the signs.

- The Board talked about putting bushes on the outside of the fence (Weld Road side) but were
 concerned about the spacing with a total cost being between \$5K-\$6K. It was decided to table
 this until the next Board meeting. We also talked about getting some of the landscaping
 cleaned-up in the entryway.
- Larry started a discussion about when we should have the next annual meeting. The group discussed the issues of having low numbers at the WGPOA Annual Meeting. We decided that having the meeting on Sunday at 10AM was too early for Sunday. If we were to have the next annual meeting on Sunday, the meeting should start at noon. We finally decide to look at having the WGPOA Annual Meeting at the Elgin Country Club on either Saturday January 10th or 17th. Jill is to see if either of those dates are available.
- The Board decided to have the third quarter meeting on Wednesday August 6th at the Elgin Country Club. Jill is to see if that date is available. We also talked about having the fourth quarter Board meeting on November 12th at the Elgin Country Club. Jill is to see if that date is available.

• NEW BUSINESS

Henry would like to have something done to the center of the cul-de-sac island because it is all
dirt. The Board discussed either having mulch put down or using some sort of shady ground
cover. The Board agreed to allow Henry to contact our landscaper about addressing this
area with a \$1K limit before having to get quotes and presenting to the Board.

The next Board meeting will be on August 6th.
