



FNQG General Meeting Minutes 12/9/21

Pam Cortner called the meeting to order at 9:59AM and asked everyone to silence their phones. The prayer and pledge were led by **Linda Weiss**. Linda then asked the members to join her in singing God Bless America

Membership- Penny Maus: A total of 57 members were present, including 2 new members. Our new members are Paula Jurgonski and Lynda Richardson. Penny reminded members that if your dues have not been paid by the December general meeting, December 9, that you will not be included in the 2022 Flying Needles Directory.

Newsletter and Minutes: Everyone received the December Needle Notes. Sharon Jacobs moved to amend the November Board and General Meeting Minutes to include the discussions that took place regarding the proposed SOPP changes. Deborah Moen seconded this amendment; it passed with a guild majority. Inputs for the January Needle Notes are due December 14 to Jayne Pendergast.

Treasurer's Report- Anne Johnson: The financial report was published in the newsletter. The current bank balance is close to \$27,000. Flying Needles Quilt Guild has been selected by 22 members as their charity of choice on Amazon Smiles.

UFO: Margaret Jacobs had a finished project to share. Margaret Jacobs and Ruth Johnson completed the most number of projects, so they are splitting up the prize of fat quarters. UFO #11 is due in January. The UFO Program is designed to help you finish 12 something's in your studio. They can be anything: blocks, bags, quilts, you name it! A number will be given at the General Meeting, and you will have until the next General Meeting to finish that project. If you are unable to finish in time, you deposit a fat quarter to the UFO Coordinator. At the end of the year, whomever has finished the most number of projects receives the stash of fat quarters. If you have your list for 2022, project #11 is due at the January general meeting.

Show & Tell: Please see our Facebook page and website for pictures from Show & Tell.

December Blocks: All December blocks have been returned, and we would like to see the finished quilts in January.

Sonja: Sonja is planning the 2022 December Block quilt blocks. They are adapted from the Freestyle Churn Dash pattern, using a white background with floral prints. The first 10 blocks are due at the June General Meeting. Sonja will be at the Sit 'N Sew in January and February if anyone has any questions. Sonja's instructions are also on our website under Quilt Guild Activites under December Block.

Changes to the By-Laws

Article III MEETINGS

Section !: The corporation shall hold an Annual Meeting in September of each year.

Section2: General Meetings will be held monthly.

Section 3: The Board, if necessary, may call special meetings.

Section 4: Any time a vote of the members is taken, the members present shall constitute a quorum, except for an election of Officers, when a quorum will consist of members present plus the absentee ballots received.

Section 5: Except as otherwise provided in these By-Laws, meetings of the Board shall be held in person.

Section 6: Some particular meeting or meetings of the Board shall be conducted through use of Internet meeting services designated by the President that support anonymous voting, support visible displays identifying those participating, identifying those seeking recognition to speak, and showing the results of votes.

- a. These electronic meetings of the Board shall be subject to all rules adopted by the Board, which may include any reasonable limitations on, and requirements for Board members' participation.
- b. Meetings of the Board shall be held electronically through Internet meeting services when the President or First Vice President has obtained consent for this from every Board member. A minimum of a 2-day notice shall be given for such a meeting to occur.
- c. The Secretary shall send by e-mail to every member of the Board, at least 24 hours before each meeting, the time of the meeting, the URL and codes necessary to connect to the Internet meeting service, and as an alternative and backup to the audio connection included within the Internet meeting service, the phone number and access code(s) the member needs to participate aurally by telephone. The Secretary shall also include a copy of, or a link to, these rules.
- d. The Secretary shall schedule Internet meeting service availability to begin at least 15 minutes before the start of each meeting.
- e. Members shall identify themselves as required to sign in to the Internet meeting service, and shall maintain Internet audio access throughout the meeting whenever present, but shall sign out upon any departure before adjournment.
- f. The presence of a quorum shall be established by audible roll call at the beginning of the meeting. Thereafter, the continued presence of a quorum shall be determined by the online list of participating members, unless any member demands a quorum count

- by audible roll cal. Such a demand may be made following any vote for which the announced totals add to less than a quorum.
- g. Each member is responsible for his or her audio and Internet connections; no action shall be invalidated on the grounds that the loss of, or poor quality of, a member's individual connection prevented participation in the meeting.
- h. The chair may cause or direct the disconnection or muting of a member's connection if it is causing undue interference with the meeting. The chair's decision to do so shall be announced during the meeting and recorded in the minutes.
- i. To seek recognition by the chair, a member shall raise their hand.
- j. Votes shall be taken by audible roll call. The chair's announcement of the voting result shall include the number of members voting on each side of the question and the number, if any, who explicitly respond to acknowledge their presence without casting a vote. Business may also be conducted by unanimous consent.

Changes to the SOPP

Officers: The Guild has a Board of Directors (herein refereed to as the Board), which is also referred to as the Officers. These positions are elected for one year at the September Annual Meeting. Officers serve from January 1st through December 31st. The previous President serves as a non-voting advisor to the Board.

See BY-LAWS (Article V) for information about officers, terms, and job descriptions.

- 1st Vice President
- 2nd Vice President
- Secretary
 - Records the minutes of the Board Meetings, the General Meetings, and the Annual Meetings.
 - o Presents the minutes to the membership in the monthly newsletter.
 - Schedules Internet meeting service, as needed.
 - Notifies membership of Internet meeting login information.
 - o Performs the duties incidental to that office and as properly required.
 - Authorized to sign checks.
 - Oversees any member service group that deals with writing.
 - Historian
 - Newsletter
 - Sunshine & Shadow
 - Website
- Treasurer

Committees:

- Committees are formed by the Board.
- Guild members may serve on more than one committee, but the Chairman may head only one committee.
- Committee Chairman and members are recruited by the President.
 - o Committee Chairman can also recruit additional members, if needed.
 - Committee Chairman positions are voluntary and do not require a vote by the general membership.
 - Committee Chairman will administer their respective activities and be responsible to the Board.
- Any expenditure over \$150.00, (or over the Committee's budget), must be approved by the Board, and is put before the membership for a vote upon Board approval.
- New committees may also be formed at any time if the need or desire warrants.

• Committees may meet in person or electronically through an Internet meeting service. Committee Chairman will serve in the capacity of Secretary if a meeting is held electronically.

** See BY-LAWS (Article III) for guidelines regarding electronic meetings. **




