Last month, I was privileged to be on a telecom for a "wait time in line failure." The requirement of this telecom was to call in on your postal cell phone, and when it was your time to share what happened, you also had to share your office on video. So, starting in the parking lot, we had to show what the office looked like. Everything from landscaping, flagpole, signage, and box section, to the retail lobby. What does the customer really see? I passed that with flying colors. Then I walked back to my office to sit down, and one of the Managers online loudly said, "Look at that messy desk!" I was mortified, and yes, it was messy with stacks of edit books, c360 cases, and everything else except the kitchen sink. It had become my dumping ground for everything. Do you find yourself in a shambles throughout the workday? We work for the Postal Service; this is our daily routine! Are deadlines impossible to meet? Is rummaging through your computer a task best left for a treasure hunter? If so, you need some serious organization to get your office life on track. Some of you may think this an impossible task, but it is not because I was able to do it. All you need is a little time and effort, and you can be as organized as you want. Of course, organization does not just mean you have to be neat and tidy, thank goodness!! Our time is extremely limited during the day. Here are a few ways to help you accomplish clearing the mess and getting organized. Just keep in mind, it is a process and cannot be accomplished in one day, but little by little, you can clear the clutter.

Everything has a home, and there's a place for everything. Cleaning up around the office is usually the last thing you want or have time to do, but your state of mind will be so much calmer and clearer when your surroundings are clean and uncluttered. So, I have worked hard to cultivate the habit of creating a home for EVERYTHING! ### **Encouraging Legislative News**

One week ago today, I was headed home from a wonderful, fun weekend in Hood River, Oregon, for the Tri-State Convention. It was so nice to meet in person again and to see old friends and faces and make new friends. It was nice to have National President Dan Heins and his wife there and also to have Edmund Carley there, who is running for national president, this year.

Ed shared with us the encouraging news that there are two legislative bills. The first bill is H.R. 3076. House Oversight and Reform Committee Chair Carolyn Maloney (D-NY) and ranking member James Comer (R-KY) have reached an agreement on postal reform. This bill would eliminate the current pre-funding of USPS healthcare costs. It would also require new postal retirees to enroll in Medicare (but optional for current retirees). It would preserve the 6-day delivery and provide flexibility to the PMG to utilize ground transportation for cost efficiency and flexibility. It would require key progress reports to Congress on the PMG's implementation of his reform plan. UPMA continues to express the need for bipartisan legislative reform.

The other bill is H.R. 3077. Some of the provisions for this bill are a ballot tracking method for votes cast by mail, paid parental leave for postal employees, a Merit System Protection Board for all EAS, and an \$8 billion appropriation for the Postal Service to electrify 75% of its vehicle fleet and to build charging stations at postal facilities. This bill would also require January 2021 service standards on First Class Mail and a pilot program to study using postal employees to conduct the census. It would also allow Congress to inspect postal facilities at their discretion. This bill does not have bipartisan support.

UPMA is encouraged by this movement, and we will be keeping a close eye on these bills. This year, the Legislative Summit is September 26-29. We are hopeful for in-person meetings. We are really hoping that this year we will get the much-needed legislative reform the Post Service needs to continue to serve and deliver to the great people of this United States of America.

### Successes Need to be Recognized

Mr. Ruiz fielded questions after he was done speaking. Many members are very concerned about the Fast Track Hiring, which is a disaster, in my opinion. One member attending his first-ever convention brought up the current caustic environment and asked if there could be some more positive emails sent out instead of all of the "you are failing" emails that have become the trend over the last few years. He also mentioned that we need leaders and not just managers. Mr. Ruiz called these types of emails not failures but opportunities that we can all learn from, but we all know that this is the engaging way of pointing out failures. This person also asked what it actually looks like to be successful in our jobs because that never, ever seems to be information that is sent out to the field. The room applauded someone being willing to point out the current unpleasant environment that we are experiencing daily in our jobs. Hopefully, Mr. Ruiz has some ideas on how to fix this.

I've heard it said that perhaps some of our higher-level Managers have misunderstood the word engaging and thought they were supposed to be enraging.

As your Chapter Member Representative Chairperson, I have stayed fairly busy representing Managers going through investigative interviews. This reminds me of our Western Area Adverse Action Rep Shari Hetzler sharing information with us at the convention. Besides saying that Managers should be concise and truthful in interviews, she gave us an example of how to answer a question. If you're asked, do you know what time it is, how should you answer that question? Many people in the room knew how to respond, but some didn't. Your answer to that question should be yes if you know what time it is or no if you don't. I probably don't need to explain why being truthful is so important, but I will. If you're not truthful, you lose all credibility, and that is not where you want to be when your job may be on the line, and it seems that lately many people's jobs are on the line.






