2020-21 GOALS/OBJECTIVES

YOURpath for Adult Learners' 2020-21 objectives focus on its instructional, attainment, and program goals as outlined below:

Instructional:

- Objective 1: To ensure that every student enrolled in the program has the instructional support needed to advance in their online coursework, moving to the next level of advancement within a three-month span.
- Objective 2: To ensure that every student enrolled in the program has the instructional support needed to demonstrate test-readiness gains (at a minimum of 3 points) on their HiSET practice test and (at a minimum of 5 points) on their GED practice test, every three months.

Attainment:

- Objective 1: To ensure that every student who demonstrates test-readiness is scheduled for his/her official exam within 1 month of testing.
- Objective 2: To ensure that 100% of our students who demonstrates test-readiness on their practice test pass their official GED or HiSET exam.

Program:

- ♦ Objective 1: To increase our student enrollment by 10-15% by the end of 2020.
- \bullet Objective 2: To improve our student retention by 10-15% by the end of 2020.



STUDENTS ENROLLED PER STATE

Among our 27 student enrollees:

- 25% (7) reside in the state of PA.
- 32% (9) reside in the states of Fl, LA, and MD, representing 10.7% (3) in each state.
- 14.2% (4) reside in the states of GA and IL, representing 7% (2) in each state.
- 28.8% (8) reside in the states of CA, CO, MA, MO, NV, OK, SC and TN, representing 4% (1) in each state.






ACTIVE/INACTIVE STUDENTS

Active Inactive Inactive due to Covid 19 Completers






GENDER DEMOGRAPHIC

- 15% (4) consists of males.






STUDENT RACIAL/ETHNICITY

- 11% of the students are Asian American, totaling 3.






STUDENT AGE

- 4% (1) are between the ages of 60 and up.






STUDENT EMPLOYMENT STATUS

- 4% (1) of our students are retired.







ENROLLMENT RATE


• YOURpath's enrollment rate increased to 74% from 2018/2019 to 2020.





QUARTERLY ENROLLMENT RATE


• YOURpath's quarterly enrollment rate increased by 21% (4).

• YOURpath's student retention rate for 2020 is 93%. Only two students officially termed from the program.




The Retention rate was calculated by dividing the number of students on the last day of the given period by the number of students on the first day. Then, multiply that number by 100 to convert it to a percentage



STUDENT ACADEMIC TRACK


Our students are on the following academic tracks:

- 48% (13) of our students are on the GED track.

Recently, YOURpath has had an increase in student enrolment of students with English as a Second Other Language (ESOL). Our ESOL student population consists of 33% (9).






ACTIVE STUDENTS' TESTING STATUSES

Among our actively enrolled students:


- 16% have completed the program.

STUDENT HIGH SCHOOL ATTAINMENT RATE


YOURpath's student high school attainment rate doubled in 2020, increasing to 67%.

2021-22 GOALS/OBJECTIVES

YOURpath for Adult Learners' 2020-21 objectives focus on its instructional, attainment, and program goals as outlined below:

- Instructional:
 - Objective 1: To <u>continue</u> ensuring that every student enrolled in the program has the instructional support needed to advance in their online coursework, moving to the next level of advancement within a threemonth span. (*This objective is supported by the projected test date tracking log*).
 - Objective 2: Implement a tracking system to effectively monitor students' test-readiness gains (at a minimum of 3 points) on their HiSET practice test and (at a minimum of 5 points) GED practice test and ensure that students are making monthly gains to test within 3-4 months of enrollment (excluding TABE courses).
- Attainment:
 - Objective 1: To <u>continue</u> ensuring that every student who demonstrates test-readiness is scheduled for his/her official exam within 1 month of testing.
 - Objective 2: To increase our student high school attainment rate by 15%, to reflect an 80% or above outcome.
- Program:
 - Objective 1: To increase our student enrollment by 15-20% by the end of 2021, with a focus to increase enrollment among our male gender population.
 - ♦ Objective 2: To improve our student retention by 15-20% by the end of 2021.
