As such, this report does not include any students who enrolled in the program after the cut off period, which constitutes a total of 2 additional students for the quarter.

## 2020-21 GOALS/OBJECTIVES

YOURpath for Adult Learners' 2020-21 objectives focus on its instructional, attainment, and program goals as outlined below:

- Instructional:
> Objective 1:To ensure that every student enrolled in the program has the instructional support needed to advance in their online coursework, moving to the next level of advancement within a three month span.
$>$ Objective 2: To ensure that every student enrolled in the program has the instructional support needed to demonstrate test-readiness gains (at a minimum of 3 points) on their HiSET practice test and (at minimum of 5 points) on their GED practice test, every three months.
- Attainment:
> Objective 1:To ensure that every student who demonstrates test-readiness is scheduled for his/her official exam within 1 month of testing.
$>$ Objective 2: To ensure that $100 \%$ of our students who demonstrate test-readiness on their practice test, pass their official GED or HiSET exam.
- Program:

> Objective 2: To improve our student retention by $10-15 \%$ by the end of 2020.


## STUDENT ENROLLMENT PER STATE

- Among our 25 student enrollees:
- $29 \%$ (7) reside in the state of PA.
- $39 \%$ reside in the states of MD, FL and LA, representing $13 \%$ (3) in each state.
- $8 \%(2)$ reside in the state of GA.
- $24 \%$ reside in the states of CA, CO, IL, OK, SC and TN, representing $4 \%$ in each state.
- $4 \%$ (1) reside in the state of NC, recently enrolled (last added, not included on graph).

## ACTIVE/INACTIVE STUDENTS

- Based on our current enrollment, consisting of 25 students:
- 2 student completer, totaling $8 \%$.
- 15 actively enrolled, totaling $62 \%$
- 5 inactive due to Covid 19, totaling $19 \%$
- 3 inactive, totaling $11 \%$

## GENDER DEMOGRAPHIC

- There is total of 25 students in enrolled in the program as of July, 2020.
- $84 \%(21)$ of them are females.
- $16 \%(5)$ of the them are males.



## RACIAL/ETHNICITY DEMOGRAPHICS

Among our 25 student enrollees:

- 16 of them are African Americans (black), constituting 64\%.
- 4of them are European Americans (White), constituting 16\%.
- 4 of them are Hispanic Americans, constituting 16\%; and
- 1 is Asian American, constituting 4\%.


## STUDENT AGE DEMOGRAPHICS

- Among our 25 student enrollees:
- $21 \%$ are between the ages of $18-29$;
- $33 \%$ are between the ages of $30-39$;
- $25 \%$ are between the ages of $40-49$;
- $17 \%$ are between the ages of $50-59$; and
- $4 \%$ are between the ages 60 and up.



## STUDENT ANNUAL ENROLLMENT

- Effective this Quarter (MayAugust), YOURpath's student enrollment has increased by 18\% from 2019.



## STUDENT ANNUAL RETENTION RATE FOR THE QUARTER

- As of this quarter, YOURpath's annual student retention rate is at 68\%.
- The student retention rate is based on the number of students who are in a terminated or inactive status in the program divided by the total number of enrollees in 2020.



## STUDENT QUARTERLY ENROLLMENT

- This quarter student enrollment increased by $34 \%$ from last quarter.
- This constitutes a total of 10 students enrolled during the quarter.

## STUDENT GRADE LEVEL UPON ENROLLMENT

Our currently enrolled students were on the following grade levels upon enrollment:

- $17 \%$ of students were in $12^{\text {th }}$ grade.
- $29 \%$ of students were in the $11^{\text {th }}$ grade.
- $29 \%$ of students were in the $10^{\text {th }}$ grade.
- $13 \%$ of students were in the $9^{\text {th }}$ grade.
- $8 \%$ of students were in the $8^{\text {th }}$ grade.
- $4 \%$ of students were in grammar school.

## STUDENT ACADEMIC TRACK

- Our students' academic tracks are as follows:
- $46 \%$ (12) of them are on the HiSET track.
- $4 \%$ (1) has graduated via the HiSET track.
- $46 \%$ (12) of them are on the GED track.
- $4 \%$ ( 1 ) has graduated via the GED track.

## TESTING STATUS SINCE 2019

- Today, 54\% of our students have tested in at least l or more subject areas. This reflects an $8 \%$ increase since 2019.

## TESTING STATUS SINCE 2019

- Out of all the students enrolled in YOURpath since $2019,8 \%$ has earned a diploma, constituting 2 completers;
- $46 \%$ (constituting 12 students) are active (i.e. completing their coursework) and have tested in 1 or more subject areas;
- $31 \%$ (constituting 8 students) are currently active (i.e. completing their coursework), but have not yet tested. This is due to students having recently enrolled in the program and demonstrating a "not ready to test" status as indicated by their initial practice test results; and
- $15 \%$ (constituting 4 students) have not yet tested. This is due to students being in an inactive status,

## TESTING STATUS THIS QUARTER (MAY-AUG)

- During this quarter, $25 \%$ of our students have tested this quarter (consisting of 4 students out of the total 12 students who have tested in 2020).
- Collectively, these students passed a total of 6 subject areas, consisting of: Reading (1), LA/Writing (2), Social Studies (2), Science (1).
