**Agenda Item #1:** Report out on prior meeting minutes. Update on the 1023 Application Submission for YOURpath's 501c3 status. Update on consolidation outreach and funding lists and contacts. **Presenters:** Ms. Cook and Dr. Artis

## **Discussion:**

- Mrs. Best, Chairman in Training, called the meeting to order.
- Ms. Cook reported out on prior meeting minutes.
- Dr. Artis provided an update on the organization's 1023 application status. She
  informed the board that she contacted the IRS on 1/22/2020 and was informed that the
  application has not yet been assigned to a determination specialist. IRS has 180 days to
  process the application.
- Dr. Artis provided an update on the consolidation of the outreach and funding lists/contacts. Dr. Artis mentioned that she plans to follow up with the nominees for the advisory committee following the approval of the 501c3 status. The Board of Directors agreed with this decision.
- Dr. Artis and Mrs. Best are still working on their individual grant/sponsorship lists and will be collaborating on the consolidation of the lists.
- Dr. Artis also informed the board that she is making steady progress with the business advertisement. The Philadelphia Public Library has given approval to distribute YOURpath's flyers to its various branches.

## Action:

• Dr. Artis will continue to follow up with the IRS on the status of the 1023 application.



- Dr. Artis and Mrs. Best will continue working on their outreach efforts/research and schedule time to consolidate the information in preparation for fundraising efforts/activities.
- Dr. Artis will continue with her outreach efforts to spread the word about YOURpath for Adult Learners.

**Agenda Item #2:** Update on action plan regarding tasks to be completed (high, medium and low priorities), including trademark. Discuss Fundraising Drive. **Presenter:** Dr. Audrey Artis **Discussion:** 

- Dr. Artis provided an updated status re. the Plan of Action for 2020 activities. The following status were reported:
  - The fiscal Budget is completed; however, Dr.Artis has to include the new curriculum and new high school online expenses.
  - The Student and employee handbooks are completed
  - The Student and employee forms have been uploaded, but will remaining an ongoing process.
  - Business cards are completed and all members have received their cards as of January 2020.
  - The Bank Account has been established and Vice Chairman, Mrs.Dora has been added as of February 3, 2020.
  - Student enrollment is increasing, but at a slow rate.
  - Dr. Artis added insurance for the Board of Directors onto the 2020 Plan of Action and will be taken actions as a high priority.
- Vice Chairman, Mrs. Best has volunteered to take on the responsibility of preparing the documentations for trademarking YOURpath for Adult Learners logo, which is owned by Dr. Artis.

## Action:

- Dr. Artis will commence researching insurance for the Board of Directors.
- All Board members will continue activities (i.e. outreach efforts) as assigned on the 2020 Plan of Action.
- Mrs. Best will commence the process for trademarking the logo.

**Next Actionable Steps for All Members:** The above mentioned actions will be taken in addition to other activities that were discussed as outlined below:

- 1. Dr. Artis will be integrating resources (i.e. videos) to support fundraising efforts. These resources will be provided at the next meeting.
- 2. All board members will continue with the outreach efforts to help increase student enrollment. Mrs. Best will be sending Dr. Artis (via email) the name of a potential student who will be contacting the office.
- 3. Mrs. Best will be reaching out to the First Baptist Church of Glenarden, where she has contacts in support of outreaching efforts.
