**Commented [1]:** You need to clearly state your position. Follow the sample below.

For example, you can say: ...because they argue that marijuana is ...; has...; and generates tax revenues that fund public programs. Note: If the mental health centers are public centers, then they are included in the public programs. If they are not, then you can say: ...public and private programs.

**Commented [2]:** Position sample: In this ongoing debate, it is apparent that the proponents' argument is much stronger than

the opponents' argument because they prove that marijuana is less harmful than alcohol or tobacco; it promotes state funding and reduces the concerns centered on public health safety and risks

Commented [3]: Let's say: Firstly. It's more formal.

**Commented [5]:** Good job on transitioning. Here you can say: Secondly, the proponents argue that marijuana has economical benefits for major industries. (This should be directly taken from your position statement).

Commented [4]: You need to present your argument from the proponents' viewpoint. You can say: Firstly, the proponents argue that marijuana is less harmful than alcohol. Apply this comment and example to revise main idea #2 as well.

Commented [6]: Your supportive sentences for main idea 1 and 2 are closely related to another students' work. Keep in mind that the teacher and students' samples are only to be used as guides. You ideas should be original (i.e. your own).

**Commented [7]:** Good Job on transitioning. However, you need to include some evidence that show the economic benefits to these industries. Some statistical evidence would be very strong and useful.

**Commented [8]:** Change to proves. You are speaking in the present tense.

**Commented [9]:** You do not need to keep referring to marijuana as an herb. It is already understood.

**Commented [10]:** You need to do a better job connecting your evidence to your main idea once you have provided stronger evidence.
