



The Tragedy of Black Wall Street: A Historical Reflection and Modern Lessons

The Rise of Black Wall Street

At the turn of the 20th century, African Americans founded and developed the Greenwood district in Tulsa, Oklahoma. This area, known as "Black Wall Street," became a beacon of Black economic prosperity and cultural richness. The community thrived with a variety of businesses, including barber shops, clothing stores, restaurants, and even a hospital. Greenwood was a self-sustaining community where money circulated within the neighborhood, fostering economic growth and stability.

The Tulsa Race Massacre

On May 31, 1921, a white mob began a violent rampage through Greenwood, decimating the community. Over the course of two days, the mob looted and burned down businesses, homes, schools, and churches. The massacre left as many as 300 people dead and 10,000 homeless. This horrific event stands as one of the

most devastating acts of racial violence in American history.

The Aftermath and Resilience

Despite the destruction, the residents of Greenwood showed remarkable resilience. By the end of 1922, 80 businesses had reopened, and the community began to rebuild without significant help from the greater Tulsa community. However, the long-term impact of the massacre was profound, and the area never fully recovered to its former glory.

Modern Lessons: Disparity in Funding for Black Nonprofit Businesses

The tragedy of Black Wall Street highlights the systemic challenges that Black communities have faced and continue to face. One such challenge is the disparity in funding for Black-led nonprofit organizations. Research shows that Black-led nonprofits receive significantly less funding than their white-led counterparts. For example, as of 2023, Black-led nonprofits receive 24% less revenue and 76% less access to unrestricted net assets.

This disparity in funding means that Black-led organizations often lack the resources needed to serve their communities effectively. The systemic nature of this problem is rooted in racial bias, both personal and institutional, which affects the philanthropic and grantmaking processes.

The story of Black Wall Street serves as a powerful reminder of the resilience and strength of Black communities. It also underscores the importance of addressing systemic inequities in funding. Philanthropic organizations and grantmakers must recognize and actively work to overcome these disparities. By doing so, they can help ensure that Black-led nonprofits, like YOURpath for Adult Learners, have the resources they need to thrive and continue their vital work in their communities.
