Lily Grace Catering & Event Services Get Away Car Terms and Conditions

The renter of any vehicle must adhere and agree to all terms and conditions:

PAYMENT TERMS: A non-refundable deposit of 50% of rental amount will be due and payable upon signing of contract. The remaining balance will be due fifteen (15) days prior to day of rental. Payments are accepted via cash, check, or credit card. Deposit must be received with signed contract to confirm the date of rental. We do request a gratuity of at least 10% for your driver. This can be paid to the driver on the date of event or can be added to your final payment. Rentals are for a set amount of time and/or mileage. If more time/distance is requested, additional charges may apply and are dependent on the vehicle chosen, location and/or weather.

CANCELLATION: Cancellations will only be accepted in writing, either by mail or email more than thirty (30) days prior to the event date to cancel final balance and reservation.

CLIENT RESPONSIBILITIES: Client and renter are responsible for his or her guests and for any damage to exterior or interior of vehicles being used during their event. Any damages will be estimated, and client will be notified by mail and/or email of the repair/replacement estimate within fifteen (15) days. All damage cost must be paid within 30 days of receiving estimate of damages.

PERFORMANCE: Lily Grace Catering & Event services will not be held accountable for delays caused by (but not limited to) breakdown of vehicle in route or during event, traffic issues, stormy weather, or wrong addresses. If your preferred car is not available to attend your event due to breakdown or stormy weather, we will give you the choice of using one of the other vehicles or a refund. If refund is chosen, it will be sent by check within 30 days. The 1921 Dodge Brothers Touring (*Darby*) and the 1941 Oldsmobile Custom Cruiser (*Ophelia*) will NOT be taken out in the event of rain. The 1971 Roll-Royce (*Roland*) may or may not be taken out in the event of rain.

We ask that you and your guests please be respectful of the vehicles – they are old and classic. Be aware of all jewelry and/or metal objects, that they do not damage the upholstery or

damage the exterior. Under no circumstances will food and/or beverage be allowed in any of the vehicles – Champagne Toast is allowed outside the car, but bottle may NOT be opened inside the car. Sparklers will not be allowed near any of the vehicles. We do not allow any guest to drive the vehicles or rent vehicles without our driver. Decorations and adornments are allowed so long as they do not damage the finish of the exterior or interior of the car. Ask about our “Just Married” signs or magnets or working with your florist or planner to get the exact look you want for your special get away.

Lily Grace Catering & Event Services has the right to terminate service at anytime if client, guest, or passengers do not adhere to all terms and conditions stated above. If early termination is necessary due to violation of these terms during a scheduled event, then client and renter will NOT receive any portion of deposit or balance refunded.
