CALL MEETING TO ORDER: Meeting was called to order at 17:30

APPROVE MINUTES: Minutes for the meeting of October 10th, 2023, were approved as presented.

TREASURER REPORT: The treasurer's report was presented. See attached report. The month's bills were reviewed. This month's bills include fuels mitigation project expenses, an increase in payroll expenses due to fire assignments, and higher than normal balances on the WEX fuel bill and credit card bills due to fire assignments, but these costs are reimbursable. **There was a motion made by Chuck to pay bills in the amount of \$182,403.96. Brent seconded the motion. Motion was approved.**

AFG/SAFER/DOT/CIH Grants update: The CIH Grant process has been challenging, but we have our program started now. The grant runs through May of next year, CDC is not renewing the grant after that time.

NEW BUSINESS:

Mobile sign purchase/grant repayment: **Chuck moved to approve the purchase of a new (to us) truck mounted sign for our sign truck from LiteSys Inc. for \$6194. Brent seconded the motion, motion approved.** We have applied for a grant the county has that we may be able to use to help pay for the sign costs.

Employee benefit renewal update: Employee benefits have been renewed. Chief brought up some ideas to consider: Looking 'big picture' at staffing topics and having paid providers not living in the local community for various reasons, one being housing availability, would we want to consider buying a house for employees to use living in town?

Joint Ambulance/Fire District Meeting: Chief and Nick brought up the idea of a joint meeting with the fire district and ambulance district boards. It was suggested to invite the Ambulance District board to the January or February Fire board meeting.
