Windmill Is Odd Site On Wappoo

Boatmen passing through Elliott's Cut on the Intracoastal Waterway may think they're on the Zuider Zee as they pass the property of Mr. and Mrs. John Roessler.

The Roessler's live on Wappoo Hall Road in Riverland Terrace on a lot overlooking the waterway.

Looking as if it were part of an illustration for "Hans Brinker," an old-fashioned Dutch windmill with its long blades overlooks the water on a point near the Wappoo Cut Bridge.

Roessler built the mill in 1931 to pump water. He conceived the idea for his windmill from those he had seen while traveling in

Europe.

The general type of windmill found in the Charleston area is a steel frame windmill resembling an oil-drilling tower. However, with the availability and cheapness of electricity the windmills have lost their usefulness and a windmill is hard to find in the Lowcountry. But they are still prevalent in the Southwestern and Midwestern

part of the United States.

The Dutch windmill with its long arms carrying cloth sails is seldom seen on American farms, and is gradually disappearing from the countryside of the Neth-

Roessler wrote to an acquaintance in Holland for plans to build the mill and was told that the cost to construct an authentic Dutch windmill would be considerably high. He then decided to draw plans of his own and rely on his memory of the Dutch windmills he had seen.

The machinery of a windmill consists of intricate from wheels and gears. That part of the mill presented no problem to Roessler since he is a locksmith and mechanically inclined.

The wheels and gears come mostly from discarded junk. However, one iron wheel had

to be specially made by a forge in Philadelphia.

The top part of the windmill, as well as the Dutch windmills, can be turned in any direction so that the blades can face the wind.

Roessler said his windmill was not exactly an authentic Dutch mill, but resembled a Dutch mill more than any other kind. Dutch windmills are much larger and usually drive a pair of stones for grinding grain.

Dutch mills, such as the Roesslers', usually follow a form known as a "post mill." A "roundhouse," which is simply a storeroom, is built around a "substructure" containing the gearing and machinery and carrying the sails.

But the availability of electricity has made the windmill more of an ornament than a useful structure. Roessler uses the roundhouse for a workshop and storage.


The elements have also played havor with the 30-year-old structure. Storms have ripped off two of the sails. Roessler has chained the other two sails to revent them from ripping off.

Roessler's interest does not stop with windmills. He is an amateur artist and painted several scenes of the Morris island Lighthouse before erosion swept away much of the soil around the lighthouse. He also raises his own tobacco for his cigarettes and cigars.

Although he is 80 years old, Roessler still, avidly reads mechanical magazines describing modern machinery.


But his main interest is "tinkering." As an example, he displayed a small cannon about three inches long which he had made and which fires from "firecracker" powder.

His windmill is now known as a landmark on some maps. Several maps of the intracoastal waterway list the point as "windmill" and boats plying the waterway use it as a guiding mark.


The Garden Club has accepted the challenge of the moving and established a diverse committee of community participants to serve as the Windmill Preservation Committee.



The Riverland Terrace Windmill Preservation Project Committee met April 26, 2000 with Sandra Taylor presiding.

The minutes were read and approved as corrected.

The treasurer reported a balance on hand of \$5,071.14. A complete report is attached.

Mrs. Taylor had insurance information from Bob Lane and the Taylor Insurance Agency. \$50,000.00 coverage on the windmill with a \$1,000.00 deductible and \$1,000,000.00 liability coverage will cost \$848.00. This will cover the Riverland Terrace Garden Club and the City of Charleston.

Mr. Meffert said we need to know if the liability coverage is a maximum of \$1,000,000.00 or \$1,000,000.00 per incident.

Mr. Bob Donegan and Mr. Bob Riser worked on boarding the windmill windows. After the first floor was finished, Mr. Donegan put his ladder up toward the second floor window. It was about four feet short. While he was studying the situation, Mr. Nelson came over and offered to finish the job. Mr. Donegan said he could repair the windmill blades.

Mr. Neal Chavis has given a bid of \$1,000.00 to build the footing. We will also receive a bid from Mr. Tommy Strock. Mr. Jerry Smeltzer may be able to reduce the cost of the concrete.

Mr. Meffert moved that the committee authorize up to \$1,000 for the construction, labor and material for the footing as per bid. Betty Riggs seconded the motion and it was carried.

Mr. Compton was unable to find information on the soil sample tests from the fire station. Mr. Barton said SME will do a soil sample for no charge. A letter will be sent to SME.

Mrs. Taylor said Mr. Barton was informed that Limehouse Trucking will charge \$75.00 per hour per crane. Two cranes will be needed for 2 - 3 hours. Mrs. Taylor asked Mr. Barton to get all moving costs in writing.

We hope to have extensive newspaper and television coverage of the move.

Janice Shumake has written an article on the Riverland Terrace neighborhood for the Post and Courier. Andrea Fisher has called for a follow up article for The Journal.

A letter will be sent to Mr. Schryver and Mr. Furtwangler thanking them for their interest in the project.

Mrs. Taylor has called the Dept of Archives to inquire about grants. It was felt that this is not appropriate at this time. We may want to apply for listing in the National Historic Register.

Mrs. Riggs asked about the tax deductible status for the Garden Club. No action has been taken as yet.

There being no further business, the meeting was adjourned.

The Riverland Terrace Windmill Preservation Committee met May 10, 2001 with Sandra Taylor presiding.

The minutes were read and approved.

The treasurer reported a balance of \$2787.72. There has been no activity since February 8th.

Sandra gave Bob Lane the IRS forms to give to Mr. Jackson. Mr. Jackson did not want them until after the tax season. He also requested a 3-year financial report. The financial report and the IRS forms are now in Mr. Jackson's hands.

Sandra was disappointed that the windmill dedication has been so long.

It was noted that the Mt. Pleasant Garden Club has received a historic post office building that was in great disrepair. This was acquired after we received the windmill. However, the post office has already been restored and the dedication is scheduled for July.

Matt scheduled the cherry-picker to come trim the pine tree and several limbs.

However, not enough was cut since the windmill blades rotate. They will need to return to complete the trimming.

We will need to have someone repair the rotating device. It will turn; however, you have to physically make it turn at this point.

We can raise the windmill but the price would be too costly. We would have to redesign the foundation. Sandra suggested that we move on at this point. A motion was made to leave the windmill as is and the motion was seconded and approved.

Mr. Simmons needs to return to check on the blade that has become dislodged.

The pine tree around the windmill needs to come down so that we can complete the work around the windmill. We need to work on getting the fence around the windmill.

We have plans for four steps and a handrail. We will get prices from Mr. Simmons to do this work. (Remind him that we are a non-profit organization.) Mr. Simmons will give us a quote for the following work to be completed:

- · Fix Hole (where squirrels cannot get in)
- Replace Shingles (we have replacement shingles)
- Hang door (Bob has the door.)
- Spray wash and paint the exterior

Body to be white

Roof to be red

Door to be red

Window trim red to match the door

Bob Lane will get in touch with Mr. Simmons and get the estimates. When we received the price, we will check with Paul to see if he approves.

Regarding fundraising, Betty Riggs stated that Easterby's and the Methodist Church are willing to assist in this area. Betty will get the necessary information needed. Sandra asked Betty to check on having the fundraiser during the middle to the end of June.

We discussed having the dedication around September. However, this date depends on the completion date of all necessary repairs. It was suggested that a sandwich sign be put in the median at the entrance to notify residents about the fundraiser. The Riverland Terrace Neighborhood Association used this same sign to distribute their newsletters.

BEST CLUB PROJECT

The Riverland Terrace Garden Club's best project during 2001 was the completion and dedication of our windmill. This has been an endeavor of love and endurance over a period of two years, beginning with the first moving of the windmill in December, 1999.

The windmill was built in the early forties by neighborhood resident John Roessler and was operational for years. Mr. Roessler was stationed in Holland during World War II and was fascinated with windmills. It was donated to the garden club in December of 1999 when the current owners decided to build a house on the lot where the windmill had stood for decades. In July, 2001 it was moved to its permanent home near the Plymouth Avenue Fire Station facing the Intracoastal Waterway.

Renovations began in August 2001. We had wonderful cooperation from gentlemen in the neighborhood who volunteered their time for this effort. Some interior damage from leaks had to be repaired. However, a family of squirrels had made their home in the windmill, so renovations had to wait until the squirrels were carefully removed. Atlantic Pest Management on James Island donated their services to remove the little creatures. They also provided us with materials and education that will help keep the squirrels out.

The neighborhood men gave the little windmill a bright coat of fresh white paint with a pretty red trim. The blades were repaired so they will now turn with the breeze. On the inside, the polished wood floors were swept, mopped and dusted, ready to be opened to the public.

The dedication date was set for Nov. 17. Invitations were sent out to various dignitaries as well as to many former residents of the Terrace who remembered the windmill during their childhood when it was operational. Garden Club members began decorating windmill cookies and sharing recipes for spiced apple cider.

On a perfectly lovely fall afternoon, 110 neighborhood residents and friends gathered around the little windmill. Our President, Mary Connor, welcomed everyone with warm remarks. Our representative on City Council was on hand in the Mayor's

absence and gave a brief talk about the windmill and the historic significance of the structure. The granddaughter of one of our members provided music. Our President did the ribbon cutting followed by the applause of the crowd. Then everyone was given the opportunity to go inside the windmill, even getting a chance to climb up the stairs to the second level.

Garden Club members had tables set up where they served the windmill cookies, which they had so carefully decorated, along with hot spiced apple cider. People enjoyed visiting with one another and reminiscing about past days in the Terrace. In fact, it seemed that people did not want to leave, but as the sun began to set over the Stono River, everyone headed for home.

We feel that this windmill project is one of the best things the club has done in recent years. It has helped bring the neighborhood together, with so many people being involved, and it has put the Garden Club "on display", so to speak. Everyone knew that this was our project and the entire neighborhood is grateful that we have saved this little piece of the history of Riverland Terrace. We realize that calling this structure ours is a big responsibility, both financially and otherwise. It means that we will have to work harder and plan more successful fundraisers. But we are all happy to have had a part in saving this historic little windmill.

The costs involved were its two moves, \$4705.50 and the renovation \$4,880.78

City Agrees To Permanent Location For Windmill

After months of delay, one of Riverland Terrace's most endearing landmarks is getting a facelift and a new location to boot.

The Riverland Terrace Windmill, built in the late thirties by the late John Roessler, has served as a cherished part of the Riverland Terrace landscape for over 60 years. Construction on its Wappoo Hall Road lot led to the relocation of the structure to the front of the property late last year. Now, after months of work, members of the neighborhood's Windmill Preservation Committee have secured a new home for the landmark, adjacent to the Plymouth Avenue Fire Station.

"We had to go before Mayor Riley, City Council, and the real estate board, and they all overwhelmingly approved its location," said Sandra Taylor, chairman of the Windmill Preservation Committee.

The windmill will be located adjacent to the fire station and near the parking area for the Riverland Terrace Boat Landing. "It will be seen from the waterway as well as the land," Taylor said.

The committee is currently in the process of compiling cost estimates for the construction of a foundation for the structure. "It was never on a foundation before, and it was getting kind of unstable," Taylor said. The committee is also trying to nail down costs for moving the landmark. "It's been boarded up, so it's ready to move, and all we have to do is get that foundation," she said.

While the group has raised some money to fund the project, more donations will be needed, especially as the group begins the restoration of the windmill. According to Taylor, the windmill was restored about 10 years ago by a former property owner. However, the door was blown off during Hurricane Floyd, (see Windmill, page two)

and the windmill blades are in disrepair. In addition, minor external and internal repairs are needed, and the windmill needs to be stained, Taylor said. "I don't know whether we can get it working again or not," she added. "I believe (the former owner) got it working again, but it will require more money."

Once restoration is complete, Taylor hopes the windmill will be used as a hands-on setting for school children. It will also con-

tinue to be featured on the neighborhood's holiday tour of homes. "We would also like to open it from time to time to the public and have gift items available," Taylor said. "We're really excited, and we can't wait to get it into place so we can share it with the public."

HISTORIC PRESERVATION

For 60 years a Holland style windmill has been overlooking the Intercoastal Waterway in Riverland Terrace.

Built by John Roessler around 1936, it has persisted as a fascinating landmark for local residents, many of whom remember swimming and crabing from the nearby dock and picking flowers which grew in the shadow of the windmill.

As of December 1999, it became necessary that this local treasure 10 find a new home. The present owners, the Woodrow Nelsons, were building a house on the lot and have donated the windmill to the Riverland Terrace Garden Club for preservation at another site.

The garden club, comprised of forty-seven members, accepted the challenge and has established a diverse committee of community participants to serve as the Windmill Preservation Committee.

Since the ideal site was on city property, permission needed ${f t}o$ be obtained from the Mayor, City Council and the Real Estate Board.

A new home has now been established, and that is on a lot adjacent to the Plymouth Avenue firehouse. A site plan was done, and a foundation poured.

The date for moving the windmill to its permanent location was Wednesday, July 26, 2000. A group to secure the windmill before its actual move was obtained. They worked feverishly in the AM with the truck and crane arriving at 2PM. The process was slow with the top coming off first to be followed by the body. The route taken for its journey was chosen because of its few live oaks. The truck arrived with its treasure in about forty minutes, and the task of restructuring began. By 4:30 PM the windmill had found its resting place. The following day the blades were attached (having been rebuilt by one of the committee members).

The refurbishing of the exterior and the interior have been completed and a dedication is planned for November.

It is thrilling to know that one year later such a piece of history now can stand proudly and playfully give wink of the blades to passerbys.

THE WINDMILL PROJECT

The culmination of the Riverland Terrace Garden Club's windmill project was its dedication which was held November 17, 2001. Approximately 110 people attended. This has been an endeavor of love and endurance over a period of two years, commencing with the first move of the structure on the property owner's parcel in December of 1999.

It was inevitable that the windmill be moved to a permanent location. That was accomplished in July 2001. It is now located near the Plymouth Avenue fire station on the Inter-coastal waterway in Riverland Terrace where it stands proud and strong.

The costs involved were its two moves (\$1,705.50) and the renovation (\$4,880.78).

HISTORIC WINDMILL PRESERVATION PROJECT

Since 1929, a Holland style windmill has been sitting in Riverland Terrace on the banks of the Intracoastal Waterway. The windmill was built around 1936 by Mr. John Roessler who had spent time in Holland during the war and who had become fascinated by windmills.

For many years it was a working windmill. But in more recent years it has persisted as a fascinating landmark for local residents, many of whom remember swimming and crabbing from the nearby dock and picking flowers which grew in the shadow of the windmill. It has also served as a landmark for boaters traveling the Waterway.

In December, 1999, it became necessary that this local treasure find a new home. The owners of the property were planning to build a new home and the windmill would have to be moved. Knowing that the Riverland Terrace Garden Club was always interested in preserving and protecting our neighborhood, the owners donated the windmill to the club. We accepted the challenge and established a committee of members and community residents to serve as the Windmill Preservation Committee.

The Garden Club paid to have a crane lift the little windmill off of its foundation and moved to a temporary spot so the property owners could begin the construction of their house. Then the committee set to work finding a permanent home. The City of Charleston gave permission for us to put it on a lot adjacent to the Plymouth Avenue Firehouse. A site plan was done, and the foundation was poured.

On a hot day in July of 2000, the moving began. Workers came in the early morning to remove the blades and to secure the structure for moving. By 2:00 p.m., the truck and crane arrived. The process was slow, with the top coming off first, followed by the body. A route for the move had to be chosen carefully so as not to damage live oak limbs hanging over the street. Many neighbors gathered along the street to watch the little windmill being moved to its new resting place. The truck

arrived with its treasure in about 40 minutes. By 4:30 p.m. it was in place. Then the task of restructuring began. On the following day the blades were attached (having been rebuilt by one of the committee members).

Needless to say, we were relieved. We had found a home for the windmill just a few hundred feet down the waterway from its original location, and we were able to pay for its move. For many reasons, this is an even better location in that it is now on public property rather that private and will be easily accessible to people in the neighborhood. Refurbishing plans have been done and await only the approval of the Board of Architectural Review.

A dedication is planned for late spring or summer. There will be fundraisers and much hard work ahead. We realize that calling this structure ours is a big responsibility, both financially and otherwise. However, it is thrilling to know that we had a part in saving this little piece of history which now stands proudly at her new home and playfully gives a wink of the blades to passersby.

Portrait of the Riverland Terrace Windmill

M JAMES ISLAND, RIVERLAND TERRACE WINDMILL

Between the arms of the Ashley and Stono Rivers, a partially man-made passage embraces the northern coast of James Island. Boaters familiar with this stretch of water will warn of swift tidal currents and narrow channels in the Wappoo Creek and especially Elliott's Cut. And for more than 80 years, mariners traveling this route have noted an odd but charming site on the bank of the creek, near Statute Mile Mark 470 of the Atlantic Intracoastal Waterway.

The landmark is a two-story Dutch-style windmill, designed and built in the 1930s by John Roessler. Bequeathed to the Riverland Terrace Garden Club in 1999, the iconic structure was moved about 1000 feet West to a plot near the Plymouth Avenue boat landing. The Garden Club has been caring for it there since July 15, 2000.

Who was John Roessler?

John Roessler was a locksmith by trade and the son of German immigrants Adam and Helena Roessler. His grandfather, Charles Fredrick Roessler was blacksmith.

In 1850, then six-year-old Adam Roessler immigrated to the US with his parents and brother Charles Carl. Eventually Carl opened a hardware store at 485 King Street and Adam opened a locksmith shop on Market at Meeting Streets in Charleston. His wife Helena was born in Bavaria and they were wed in Charleston in 1880. Helena died at the age of 41, leaving behind

seven children ranging from 4-year-old Catherine to 21-year-old Alma. It was 1901 and youngest son, John, was 12.

Adam continued to run the locksmith shop, which also sharpened tools. John was his apprentice. Over time, his siblings grew up and moved out of their Meeting Street home, but John stayed with his father. Also in the home were his sister Alma, her husband, stonecutter Michael Mahony, and their five children.

In 1917 John registered for the draft. A year later he was aboard the SS Maunganui, headed for France -arriving just days before the armistice was signed. A Quartermaster Private assigned to Service of Supply, he worked at one of the many refrigeration plants built by the American Army. Eight months later he returned to the US.

During the time he was in Europe, John had the opportunity to see a number of working windmills, the brick Moulin Tour (tower mills) that dotted the landscape of France and the iconic "smock-style" windmills of Germany and the Netherlands.

Soon after the war, in 1924, John married Friedricka "Frieda" Jantzen. They built a home on James Island along the waterfront of Wappoo Creek in 1929, at a time when, John said, "there wasn't anything here but cows." John was an amateur painter, tobacco farmer and according to a story that appeared in the Charleston News and Courier, a self-described "tinkerer".

Not long after, his brother-in-law Bernhard K. "BK" Jantzen, wife May and their children moved in next-door. Later Frieda's sister Annie came to live with the Roessler's and another Jantzen

Construction and use of the windmill

Roessler started construction on his windmill in 1933. He used the mill to pump water from a well to the house and garden. His idea was based on the windmills he had seen in Europe.

One reason there are so many windmills in Holland is because onethird of the land is below sea level. The mills pump water out of the lowlands and back into the rivers beyond the dikes so the land can be farmed.

According to published reports (Charleston News & Courier, July 8, 1969), Roessler wrote to an acquaintance in Holland asking for plans to build the mill but was told it would be cost prohibitive to construct an authentic Dutch windmill. He then decided to draw plans of his own. Another account says he found the plans in a Popular Mechanics magazine. It's likely he "tinkered" with ideas from several sources.

The machinery of Roessler's windmill was constructed with iron gears and wheels, mostly from discarded junk, except for one iron wheel that was forged in Philadelphia. The hexagonal shape of the mill and the sloping horizontally thatched tower topped with a cap

resembles the Dutch "Smock-style" mill, so named because the shape resembles the smock worn by farmers long ago.

The "cap" or the top part of the mill turns on a curb. It can be set in any of six directions so that the "sails" can face the prevailing wind squarely. Roessler's configuration is called a "binnenkruiers," (literally inner winder), the winch for winding the cap operates from inside the mill. The sails, which are mounted at a slight angle, turn counter-clockwise. Traditionally, the position of the sails at rest intends to communicate emotions or news to anyone who can read the code. (see side bar). The sails of the Roessler windmill at Riverland Terrace telegraph "celebration." They have been locked in place to avoid damage to nearby trees.

Around 1940 John sold the Roessler's Locksmith Shop to his brother-in-law, "BK" Jantzen, and retired to the homestead on James Island. For decades after it's construction, the windmill was Roessler's workshop, where he installed a grinding machine with a whetstone to sharpen knives and lawn-mower blades. The windmill has been featured in a number of newspaper accounts and served as an aid to navigation for mariners.

The windmill was a welcome gathering place for family and friends. Lorraine Houghtaling of Goose Creek recalls that her grandparents were good friends of "Uncle Johnny and Aunt Frieda." She lived at her grandparent's home on Welch Ave. near Riverland Terrace Elementary School. As a child she visited the Roessler's frequently. She vividly recalls how kind and resourceful the Roesslers were.

space below his house, sort of an above ground cellar, there was everything you could ever need. One time we got a puppy and needed a dog house. Uncle Johnny had one with clapboard sides, a red roof and even a window! I will never forget it."

Inside the windmill was mysterious and intimidating to young Lorraine. "There were more tools and metal shavings than you could ever imagine," she said. "And it smelled like oil or some lubricant, for a prissy little girl, it was nasty and scary. Probably the only time in my life I obeyed 'don't touch anything."

Other regular visitors included the kindergarten class of Betty Riggs Playhouse, a private nursery school in Riverland Terrace. Edith McLemore, a life-long resident of the Terrace and an active member of the Riverland Terrace Garden Club (RTGC) was one of Betty Rigg's teachers. She recalls taking her classes to visit the windmill. "Betty Riggs was a friend of John Roessler's, and that's why we were able to bring the children there," Mrs. McLemore said.

She recalled the property as magical. Behind the house on the left, there was a huge fig tree, another large shade tree and an old tractor. Grownups saw it as a rusted relic, but for the many children who kept the seat shining, it plowed through acres and acres of imaginary farms. On the right, stood the windmill and in an adjacent field, the 'truck farm.' The Roesslers grew watermelon, sugar cane and corn.

"Aunt Frieda," Lorraine recalls, had a thick accent and was one of the sweetest, most unassuming people you could meet. Frieda would can some of the proceeds from the garden, but Lorraine recalls how "Uncle Johnny" would break off a piece of the sugar cane stalk for the children. "We would peel it back and chew the sweet bite. It tasted just like a lolly pop. Then you'd spit out the fiber. On holidays we'd have upwards of 40 friends and family at picnics under the shade tree, everyone bringing food. The men would sit around, listening to car races or baseball games on their transistor radios," she said. There was even a rickety dock where some folks fished in the Wappoo Creek.

She also recalls "Uncle Johnny" as kind a man who was always ready to help anyone. "He was quite a DIY guy. And in the

The children were thrilled to watch the sails move, but were not permitted to go "upstairs" to see gears turning. In 1964, one of Mrs. McLemore's students was Linda Iler. John Roessler's windmill holds special childhood memories for her. "My mother used to bring him our scissors and such to sharpen; I loved visiting it," Iler said. Now a member of the Riverland Terrace Garden Club (RTGC), Linda and her husband Rhett are active in the windmill preservation efforts.

By the time John Roessler was 90, the windmill endured its share of damage from high winds and decay from old age. No less than 13 hurricanes and severe storms had scraped the coast of Charleston in the time Roessler lived on the property.

Even though two of the sails were removed, the treasured landmark continued to draw attention from the local media and the boating public, including a photo that appeared in the local newspaper in 1979.

Pre-deceased by all of his siblings, John Roessler died September 6, 1982. His wife Frieda died 7 months later. They had no children. The property on Wappoo Hall Road, which was home to the windmill, was passed on to Freida's nephew, Carsten lantzen.

Carsten Jantzen was a gifted artist, musician and music teacher and a son of BK Jantzen. A charter member of the Charleston Artist Guild, Carsten exhibited locally and nationally, including a major exhibit at the Columbia (SC) Museum of Art. Among his paintings are numerous scenes of the South Carolina Lowcountry. Largely self-taught, critics noted his adept handling of beach and marsh scenes. He held two degrees from Juliard School of Music was also a performer with the Charleston Symphony.

After Carsten Jantzen's death in 1994, the property changed hands again. The windmill remained on the bank of Elliot's Cut, battered by winds, its broken sails stilled by chains to prevent further damage.

A New Home for the Windmill

In 1996, Woodrow Nelson purchased the former Roessler property. He elected to build a home on the lot and offered the windmill to the Riverland Terrace Garden Club (RTGC). All they needed to do was find a suitable location, secure all the necessary permits and permissions and find a way to safely move it. The 47-member club agreed to accept the challenge. A preservation committee chaired by Sandra Taylor and comprised of RTGC members Edith McLemore, Linda lier, Barbara Knight and John Meffert went to work.

An ideal site, part of Plymouth Park, is owned by the City of Charleston. It is adjacent to the Plymouth Avenue JIPSD Fire

Station and Riverland Terrace Boat Landing. Working with City of Charleston mayor, city council and others, the group put together a site plan and obtained permission to pour a foundation. At a time when the City of Charleston and the Town of James Island were at odds over annexation and incorporation, the RTGC windmill preservation committee found a way to bring a diverse group together.

The new site was only two-tenths of a mile from the original location—a short walk around the block. However, the windmill weighs about 11,000 pounds and is two stories tall. A team was assembled to prepare the structure for the move.

The committee designated July 15, 2000 "M" day, moving day. Early in the morning the work began. The broken sails were removed. Members of the committee built a new set.

The cap was separated from the two-story base. A Limehouse & Sons Company crane lift the windmill's cap and base, then carefully place them on a flatbed truck. Hundreds of people came out to watch. It took 40 nail-biting minutes to transport the gift to it's new home at the base of Plymouth Avenue. Electric wires along the tree-lined route had to be moved aside due to the height of the load. Once on site, the structure was rebuilt, and by 4:30 that day, John Roessler's creation had a new home and

proud new owner.

To help with the renovation, the RTGC engaged Gerald Simmons and the crew of Belezza Construction Company. Together with RTGC volunteers, they went to work refurbishing the windmill right away and had it spiffed up in time for the dedication on November 17, 2001. Since then, the club has established an account dedicated to the maintenance of the windmill. In 2010 the subcommittee raised money to repair windows, replace rotted wood and paint the exterior of the historic landmark.

On April 3, 2016, celebrating its 80th year, the windmill was open for a public viewing in conjunction with a tour of neighborhood gardens organized by the RTGC.

What's next?

It's been a charming backdrop for wedding photos, a welcomed site for boaters and a unique link to one of the earliest homeowners in the oldest neighborhood on James Island. Edith McLemore would like to see more public access to the windmill and possibly capitalize on the weekend boating traffic by selling refreshments from the windmill. In the meantime, the group continues to look for creative ideas to establish a long-term strategy for preservation expenses. Immediate plans include the installation of a plaque identifying the windmill history.

The Riverland Terrace Garden Club meets on the 1st Tuesday of every month, September through May at the Bethany United Methodist Church on James Island. The meetings are educational, with guest speakers, club business and light refreshments. New gardeners are welcome. Send them a message through the Facebook group page.



This Dutch-style windmill was designed and built by John Roessler in the 1930s for his wife Frieda at their home in Riverland Terrace.



- Designed and built in the 1930's by Terrace resident John Roessler
- Originally used to pump water for his garden, then later he used it as a workshop to sharpen all types of blades for neighbors and friends
- Sits on Elliotts Cut near Statute Mile Marker 470 of the Atlantic Intercostal Waterway
- Bequeathed to the Riverland Terrace Garden Club in 1999. Moved to the Plymouth Avenue site on July 15, 2000, and the Garden club has cared for it since then.
- In 2022-2023, the windmill underwent major repairs and restoration that included: repairing and the stabilizing of its blades, wood repairs inside and to the exterior, as well as, repainting.
