Tanker Tales: Baffling

(Larry Watson relates more tanker stories to Liz Pszczolko)

Liz: You said there was another tanker someone made.

Larry: I was chief at the time, and I can't remember his name, he was a welder. Very good. So we requisitioned him to outfit the tanker. And it was an old...I don't know...maybe a milk truck, but we had to put baffles in it. Baffles keep the water from going (Larry makes loud whooshing noise) and flipping the truck over. And so he was doing that and went right inside the tanker and did the welding.

He was a neat guy. Lived up North Side Road.

I also remember going to fires and we had a pumper that was the first one that was given to us by the OFM. Brand, spankin' new pumper. The tank itself was small, like 300 gallons, which is not much bigger than a furnace oil tank, just enough water to get going or do an inside thing. And so someone would take off with the rapid attack, that's what it was called. And it had some spunk to it. So someone would take that with someone else with them to help to set it up, because that was for fast set up. You can pull in there and boom, boom, you pull all the gauges and rip out an inch-and-a-half hose and swoosh, you're going.

Liz: For like five minutes? With that water?

Larry: Oh, yeah. And the tanker was to follow. The other thing with the rapid attack was the setup of the port-a-tank, and that was like a portable swimming pool, maybe eight by ten. Then the tanker would pull up to this and dump its load and take off for more. The pumper then sucked the water out of the port-a-tank and pumped onto the fire.

Liz: So you need both for any sustained fire-fighting?

Larry: Yes, the tanker and the pumper work as a team.

Communities served by volunteer firefighters depend on them to be their first line of defense for many types of emergencies. Volunteer firefighters are summoned to a wide array of emergencies across the country every day including fires, emergency medical incidents, vehicle accidents, natural disasters, hazardous materials incidents, water rescue emergencies, high-angle and confined space emergencies, and other general public service calls. The public relies on the volunteer emergency services to be their first line of defense in these emergencies. Volunteers spend an enormous amount of time training to prepare for these emergencies.



A great big thank you to all the volunteers at the Ice Cream Social and Market. Once again we could not have fun events like this without you. From serving ice cream and toppings, selling the yard sale items to help afford the fire departments new tanker, donating items, to a great job with clean up, we all appreciate your efforts.

We always need more volunteers.




