5.1 NCC

The seed swap was busy and \$340 was raised for the rural food bank. Movie night was a success raising approximately \$75. A suggestion was made for game night, this may be a possibility in June. Volunteer appreciation will be held June 14, to thank everyone who pitches in. Jam night in the past has been well attended, suggestion was made to purchase/update equipment. Ongoing events including book club (31 online members), yoga and exercise group are very popular. It was voted on and approved to purchase and train on AED for the building. Washroom doors were repaired, railings will be installed on ramp, chairs will be repaired, and curtains/blinds will be installed on the windows.

5.2 NEST

March was busy, reporting 3 medical calls, 1 motor vehicle accident and 4 fire calls, including mutual aid. It has been asked of OFM to address mutual aid calls. Wild land training is taking place with O'Connor Township personnel. A raffle will be held to raise funds, the prize consisting of 5 cords of wood and a wood stove, donated by Blaze. 2023 had a total of 67 calls.
