## MEMORIAL WEEK OF ACTION – DAY 4 SCRIPTS/TEMPLATES Secretary of the Commonwealth Al Schmidt

## FOR CALLING FROM OUT OF STATE:

Hello Secretary Schmidt,

My name is **[FIRST AND LAST NAME]** and I'm calling from **[YOUR STATE]**. I am contacting you to urge you to please order hand count audits of the paper voting records in Philadelphia, Allegheny, and Erie counties.

A non-partisan, nonprofit organization called the Election Truth Alliance has conducted analysis in these counties, as well as in multiple states across the country, and has identified patterns consistent with vote manipulation in the 2024 U.S. general election. Their findings have also been substantiated by Dr. Walter R. Mebane Jr., a leading election forensics expert. I respectfully urge you to please meet with the Election Truth Alliance to allow them to explain their analysis and answer any questions.

Pennsylvania is a critical swing state, and what happens in Philadelphia's elections has a significant impact on the rest of the country. I have valid concerns that votes in Pennsylvania may not have been counted accurately and hope that you will work to reaffirm my confidence in our elections. I am aware that auditing 2% of statewide votes and the State Treasurer's race is not sufficient to detect the potential vote manipulation that the data indicates may have taken place. Please act on this today.

## FOR CALLING FROM PENNSYLVANIA:
