Linco Enterprises, Inc. offers a lifetime limited residential wear warranty, lifetime limited structural warranty and 10 year limited medium commercial wear warranty on both The Lands, The Cosmos and The Masterpiece Collections (5 year limited light commercial wear warranty − Lands Collection | pre-May 2020.) Warranties are non-transferable and apply to customers who originally purchased and installed NexxaCore™ Rigid Engineered Vinyl Flooring. The original, paid-in-full invoice is required. Claims must be filed by the original purchaser. In the unlikely event that any portion of your floor should fail, with respect to any provisions of this warranty, Linco Enterprises, Inc. at its sole option to the original purchaser will arrange a prorated credit based on the terms outlined below.

Prior to installation, the installer/owner is responsible for inspecting and verifying materials and factory finish of the pre-finished hardwood flooring. The installer/owner is the final inspector and assumes the responsibility to determine if the product is correct and acceptable before installation begins. **Installation is Acceptance**

Lifetime Limited Residential Wear Warranty

NexxaCore™ Rigid Engineered Vinyl Flooring is protected with a proprietary Guardia 12™ (Lands | pre-May 2020) or Guardia™ 20 (Cosmos / Lands / Masterpiece) wear layer. This layer is warranted not to wear through under normal use for the life of the product. Wear-through is defined as 100% wear-through that exposes the core material over a minimum of 3% of the total installation. (Gloss reduction or surface scratches are not considered surface wear.) If 100% wear-through is determined to have occurred, Linco Enterprises, Inc. will arrange a pro-rated credit based on the terms outlined below in the section headed "Terms of Lifetime Limited Warranties".

This lifetime limited residential wear warranty is made subject to the following conditions:

- 1. The floor must be installed properly and according to either NexxaCore™ Rigid Flooring installation instructions for Lands/Cosmos or Masterpiece Collection.
- 2. The flooring must be used only indoors in a climate-controlled area. See Installation Instructions for details
- 3. The flooring must be maintained in accordance with NexxaCore™ Rigid Flooring Maintenance Instructions.
- 4. This limited warranty does not apply to moldings and trims.
- 5. Installation of flooring that contains any manufacturing defect is not covered by this limited wear warranty.

Lifetime Limited Structure Warranty

NexxaCore™ Rigid Engineered Vinyl Flooring is warranted to be free from manufacturing or structural defects for the life of the product. Manufacturing defects developing after flooring is installed, will be covered by this warranty. This warranty is not transferable by the purchaser of the floor. It is the responsibility of the installer/consumer to determine suitability of material prior to installation. Installing a defective product will void this warranty.

Lifetime Limited Waterproof Warranty

The NexxaCore Rigid Engineered Vinyl Flooring is warranted to be 100% waterproof and the structural integrity of the flooring will not be significantly diminished by exposure to water for the life of the product. While moisture will not affect the floor's integrity, it is probable that, when excessive moisture accumulates in buildings or on building materials, mold (and/or) mildew growth can occur (particularly if the moisture problem remains undiscovered or unaddressed). Linco Enterprises Inc's moisture warranty excludes damage resulting from mold and/or mildew growth due to prolonged exposure to moisture. This warranty is not transferable by the purchaser of the floor.

Terms of Lifetime Limited Wear, Structure, Waterproof Warranties

Within One Year: Claims on defects of this product as covered by this warranty that are reported in writing within one year of purchase, Linco Enterprises Inc. will arrange a credit based on the original purchase of the product or replace the product. Reasonable labor costs are included.

Year One thru Five: Claims on defects of this product, as covered by this warranty, that are reported in writing after one year but within five years of purchase, Linco Enterprises Inc. will arrange a credit based on the original purchase of the product or replace the product. Linco Enterprises Inc will pay 50% of reasonable labor costs.

Year Five thru Ten: Claims on defects of this product, as covered by this warranty, that are reported in writing after five years but within ten years of purchase, Linco Enterprises Inc. will arrange a credit based on the original purchase of the product or replace the product. Labor costs are not included.

After Ten years: Claims on defects of this product, as covered by this warranty, that are reported in writing after ten years of purchase, Linco Enterprises Inc will provide the sufficient replacement amount of the product to repair the defective area of floor. Labor costs are not included.

5 Year Light Commercial Limited Wear Warranty (Land Collection | pre-May 2020)

NexxaCore™ Rigid Engineered Vinyl Flooring is protected with a proprietary Guardia 12™ wear layer. This layer is warranted not to wear through under normal light commercial use for a period of 5 years from date of purchase. Wear-through is defined as 100% wear-through that exposes the core material over a minimum of 3% of the total installation. (Gloss reduction or surface scratches are not considered surface wear.) If 100% wear-through is determined to have occurred, Linco Enterprises, Inc. will arrange a pro-rated credit based on the terms outlined below in the section headed "Terms of 5 Year Limited Light Commercial Warranty."

This warranty is non-transferable and applies only to the original purchaser and only if used in the following commercial areas:

- Retail: Novelty Shops/Boutiques, Product Display Areas, Sales Floors, Showrooms, Hair Salons, Hallways, Entryways (walk-off mats required)

10 Year Medium Commercial Limited Wear Warranty (The Cosmos, The Lands, The Masterpiece Collections)

NexxaCore[™] Engineered Vinyl Flooring is protected with a proprietary Guardia 20[™] on the surface of the vinyl layer. The vinyl layer of the floor plank is warranted not to wear through under normal medium commercial use for a period of ten years from date of purchase. Vinyl layer wear-through is defined as 100% vinyl layer wear-through that exposes the core material over a minimum of 3% of the total installation. (Gloss reduction or surface scratches are not considered surface wear.) If 100% vinyl layer wear-through is determined to have occurred, Linco Enterprises, Inc. will arrange a pro-rated credit based on the terms outlined below in the section headed "Terms of 10 Year Limited Medium Commercial Warranty."

This warranty is non-transferable and applies only to the original purchaser and only if used in the following commercial areas:

- Retail: Novelty Shops/Boutiques, Product Display Areas, Sales Floors, Showrooms, Hair Salons, Hallways, Entryways (walk-off mats required)

Labor costs are not included.

How to Make a Claim

If you need to file a claim under this warranty, first contact your NexxaCore™ Engineered Vinyl Flooring retailer. Proof of purchase including date of purchase must be presented. Claims must be filed within the coverage period. Linco Enterprises, Inc. reserves the right to have a designated Linco representative and/or independent inspectors to inspect the floors and remove samples for technical analysis.

Any or all disputes arising out of Linco Enterprises, Inc., products, or this warranty shall be subject to mandatory and binding arbitration, pursuant to the rules of American Arbitration Association. Any trials by jury are expressly waived.
