The regular meeting of the Sundowners Snowmobile Club was called to order August 6, 2015 at 7:35 pm by the president at Lakeview. The president, vice president, secretary, two board members, and trail chairman were present, with a total of 20 members attending.

SECRETARY'S REPORT:

- On file and distributed to all members.

TREASURER'S REPORT:

- Read by Tammy Bolden and accepted as read.

PRESIDENT'S REPORT:

- The September meeting will be at the Pit Stop and the October meeting will be at Oberg's.

ALLIANCE REPORT:

- No report, since the Alliance does not meet in the summer. The next meeting will be September 2.

TRAIL REPORT:

- The wood has been delivered for the bridge at Ron Lund's.
- Discussed some landowner changes and possible alternate routes.

OLD BUSINESS:

- The president led a snowmobile raffle status discussion:
 - A review of ticket sales last month showed that the sled was about half paid off.
 - If the sled is paid off by September 1 a big ticket sales blitz would result in good profit for the club.
 - Tim Kuschel has generated over \$1200 by taking the sled to various events.
 - Tim Weber and Casey Lund also were at Tobacco Days with the sled.
 - Planning to participate in Chilimania on September 12 with the sled in the booth and ticket sales. Approximately **10 volunteers** are **needed**. Contact one of the club officers to volunteer.
 - Discussed possibly taking the sled to the Utica Festival and/or Jefferson County Snowmobile Alliance Vintage & Antique Snowmobile Show, Vintage Grass Drags & Swap Meet.
 - Casey Burns of Burns Full Service offered to store and display the sled in between events, both to make it easier and to provide visibility in another location. This is actually a second identical sled on loan from Rock River Marina and Motorsports, with the original remaining on top of the wall at Lakeview. This will have to be discussed with Rock River Marina and Motorsports.
- Map ad sales were discussed and are normally needed in March – April time frame. However, since last year's map was prepared for a two-year period, they weren't required this year.
- The online membership process has been completed at sundownerssnowmobilers.com, with PayPal collecting dues. The first new member to join electronically is Carl "Walt" Kindstrom.

NEW BUSINESS:

- Tammy Bolden moved the Sundowners provide a \$400 memorial for the passing of Eileen Hutchinson, wife of Treasurer Tom Hutchinson and long-time Sundowners' secretary. Motion adopted.
