ALLIANCE REPORT:

- Rod Burzinski gave a director's report, which included information on the Recreation
 Opportunities Analysis Open House Meeting the DNR is hosting in Fitchburg Dec 13, 4:00 –
 7:00 pm. Rod is unable to attend, so Levi Olson will try to make it.
- Levi Olson talked about trail issues:
 - Surveyed the clubs represented at the meeting for trail status. Milton, Orfordville, and Janesville are complete. The remaining clubs are close and should be finished within a week.
 - Some bridges need planking. Specifically south of Clinton to the state line, which was damaged by a fallen tree.
 - Starting the process for a new bridge between Evansville and Janesville.
 - Talked about the SNARS program and the new alliance/association level between club-level and county-level.
- Youth report explained the article the Rock County youth representatives wrote for the WSN magazine.
- Old business:
 - The Alliance and clubs are both covered for crop damage in their respective insurance policies, with each having a \$250 deductible per occurrence. Photos, landowner name, and address of the damage would be required for claims, which would be followed up by an adjuster's visit.
- Rock County Sheriff's Deputy Chris Krahn:
 - Spoke about snowmobile safety classes. He and Casey Lund discussed clubs teaming with

the Sheriff's Department on future safety classes, so anyone wanting to do that should contact him no later than September before the schedule is finalized.
