SUPPORT APPROPRIATE ADVERTISING RESTRICTIONS FOR HEALTH INSURANCE PLANS RC 18

RESOLVED that NYSUT shall support any effort at making all insurance plans conform to appropriate advertising restrictions that are accurate and complete.

RESPECT-DIGNITY-UNITY FOR LIFE RC 18

Resolved that we will respect our in-service and retiree members by striving to resolve our differences, or where that is not possible, to develop processes that allow us to understand, appreciate, and accommodate each other's needs in such a way that all constituent groups feel fully respected and valued as members; and be it further

Resolved that we commit to continue this effort until all NYSUT members can proudly and truly say WE ARE ONE, WE ARE UNION FOR LIFE

RESOLUTION IN SUPPORT OF REAL HEALTHCARE REFORM RC 21

RESOLVED that NYSUT join with our national unions, the American Federation of Teachers, the National Education Association, and the entire American labor movement in supporting real health care reform with a full and robust public health insurance component in order to bring quality health care to all American citizens.

Resolution against massive Federal Budget Cuts to established Social Justice Programs RC 21

RESOLVED that we strongly oppose such budget proposals that might adversely affect current, established social justice programs; and be it further

RESOLVED that we inform our representatives in Congress to fight and to vote against budget cuts that adversely affect working people.

CONSIDER MEDICARE ADVANTAGE PLANS PRIVATIZING OF PUBLIC PROGRAM RC 17

RESOLVED that NYSUT point out, whenever dealing with Medicare Advantage plans, that such plans are, by their very nature, an example of privatizing what is now a public service and that a Medicare Advantage Plan is a private insurance plan not connected to the United States Government.

CONSIDER A RESEARCH BASED EXPERT STUDY OF A NATIONAL SINGLE PAYER HEALTH PLAN RC 17

RESOLVED that NYSUT urge its national affiliates to consider committing resources and expertise to examine a national single payer health plan, and that such professional examination include both positives and negatives of such a plan; and be it further

RESOLVED that the result of such examination be presented, if at all possible, in sufficient time prior to the 2025 NYSUT Representative Assembly so that a resolution either in favor or against it can be presented and voted on by the delegates.

RESOLVED, that we ask the NYSUT Board of Directors to recognize November as "Alzheimer's Awareness Month" and be it further
