How did we get here?

By the fall of 2019, **hundreds of thousands of people around the globe were protesting against** the single most powerful industrial complex in the world, the pharmaceutical industry and their forced implementation of mandated medicines, and government overreach in relation to it. Many Americans were blissfully unaware of the censorship that had been slowly happening during the previous year, across all our major social media platforms: Google, Youtube, Facebook, etc.(2) Many Americans assume that we will continue to live in a state of freedom forever – without ever actually having to fight for it – since our forefathers already did that.

Many Americans were not aware that a great deal of deception has been handed out by many of our major institutions, especially the pharmaceutical and chemical industries. (3)

A small number of citizens have been fighting for a few years to bring awareness that our legislators are being paid handsomely to implement laws that violate our civil rights, our Christian rights, our Constitutional rights (4), and our bodily autonomy rights.

SARS2/COVID19 IS UNLEASHED

- Jan 24th, the US Congress begins working on the CARES ACT, a bill that will bring relief to US citizens while the
 economy is shut down during the lockdown. Wait a minute. How did they know this far in advance that there
 would need to be a shutdown? After all, at this point there were less than 50 people in the US who were proven
 to have COVID.
- Jan 30th, US borders are closed to travelers from China
- Mar 13 US begins implementing lock-down strategies: schools close, businesses are forced to close, fear overtakes the country – and the rest of the world
- Early March genomics researchers in the US are able to determine that this new virus strain is created in a lab by splicing several strains into one. We may never know if it was released by accident or on purpose
- Mid-April We realize that the original models of 2 million Americans dead from this virus, is a serious overestimate, by about 95%. The new argument is that we must remain on lockdown to 'flatten the curve'. A month later the curve had been flattened, but the new argument was that we need to avoid letting the virus reach any more people. Scientists around the globe (at least the ones who aren't tied to the industry funding of pharma): virologists, epidemiologists, and doctors are stating publicly that a lockdown can not stop a virus only perhaps delay it a bit. They state that once a virus begins it's trek around the world, it will find all humans. Our best defense against any virus is a strong immune system and metabolism. Then we will develop antibodies against the virus when we experience it we may or may not feel symptoms.

It's hard to accept that a virus will lead to death for some people. However, 35-50,000 people die from the flu viruses each year in the US.(5) We know that viruses kill. It's sad for sure. But we expect it. It seems this Covid virus is stronger, and will end more lives than the typical flu – but not the originally projected 2 million, and not even 10% of that. Perhaps 5% of that estimate. So are all the actions we took originally still warranted? (6)

Ultimately what happened to those hundreds of thousands of demonstrators who were rallying around the world to bring awareness to the plight of freedom-loss? What happened to all of us who were previously out in the public domain attempting to 'wake up' the average citizen to government overreach, and the slow, creeping loss of our Constitutionally guaranteed rights? **We were suddenly, and very effectively, silenced. Around the globe.** In the time it took to write a newspaper article containing gigantic doses of fear. Coincidence or plan?

BUT WHO WOULD WANT TO SILENCE PROTESTORS AND LOCK DOWN COUNTRIES?

In each country that went into lock down, the edict would've come through that country's Ministry of Health or Health Department or Center for Disease Control. But, who is advising those entities?

Make no mistake... it is the single most powerful conglomerate on Earth, the pharmaceutical industry (7). This is also who is paying off our legislators, medical professionals and gov't officials to promote only the industry narrative – that only meds/vaccines will save the world (8). And so there is this massive search to find the next big medicine or vaccine. To the exclusion of all natural, God-given means of saving humanity from disease and illness. And, it seems... to the exclusion of Jesus Christ, as true Savior.

WHY WOULD THE PHARMACEUTICAL INDUSTRY WANT TO IMPLEMENT CONTROLS LIKE THIS?

Think about it this way, if pharma can convince our legislators to mandate specific meds (which they do through lobbying payments) by the creation of laws, that means that roughly 350,000,000 doses of that medicine will be purchased in the US alone. There would be a captive market. This is a windfall for any business. How much money would an industry be willing to shell out, in order to guarantee this huge sale? And if it can be done, then why stop at one drug? Why not pay out more money to guarantee more monster sales?

In science, it is well known that every human body is different. A medicine that helps one body, may cause an allergic reaction in another, or some other life-threatening effect. There is no 'medicine' on the face of the Earth that is 100% safe for all humans. If we know that all medicines will injure or kill a certain percent of the population that consumes it – why would we ever want to force someone to take it? Wouldn't that be akin to Russian Roulette? Should people have a choice in the matter, or should other humans have the options of controlling them by forcing meds?

This process has already begun in the vaccine world. In 2019, 38 states fought against mandating vaccines for all school children. These mandates came with zero exceptions – even if the child has a known risk for death. Previously there were exemptions that allowed parents to not get their child vaccinated: if they thought the child might be injured or if they stood against vaccines due to religious beliefs, because most vaccines have aborted fetal cells in them.(10) The law to mandate vaccines passed in NYS. Parents have pulled children out of school rather than chance killing them. What would you do as a parent if you knew the vaccine might kill your precious baby? Or if you believed your Bible when it said, "Do not partake in another man's sin," and you truly believe that injecting your baby with a medicine that contains aborted fetal cells would be just that.

Other concerns around this issue:

H.R. 6666 is a bill currently before the US congress.(11) It's title is: COVID-19 Testing, Reaching, And Contacting Everyone (TRACE) Act. This is an unconstitutional bill that opens the door to human tracking & medical mandates. Covid is a lab created virus, released upon society – for what? Accident or Plan?

Patent # 060606 was awarded to Microsoft earlier this year.(12) This gives Microsoft the ability to trace human beings through the cloud, and award cryptocurrency based on the human's actions. It lays the foundation for a medical police state that gives unlimited power to gov't agencies and the industries with which they partner. There are no mechanisms for individuals to opt out or that protect their privacy rights.

In early 2020, 2 unconstitutional projects are assigned random contract #s, both inflict a severe monitoring of humans and they both just happen to have the #666 assigned. Coincidence?

Revelation 22: ¹⁴ Blessed are they that do his commandments, that they may have right to the tree of life, and may enter in through the gates into the city. ¹⁵ For without are dogs, <u>and sorcerers</u>, and whoremongers, and murderers, and idolaters, and whosoever loveth and maketh a lie.

It seems the King James translators may have done us a disservice. The original Greek word, instead of 'sorcerers' was pharmakoi (or pharmakon). Pharmakoi translates directly into our modern-day 'pharmacy'. (23) Our current paradigm of believing that pharmacy is for the good of humankind, biases us to thinking that Jesus could not possibly have been speaking about our much needed 'medicines'. In fact, I've had a few pastors say that perhaps one could not make an exact, direct translation, because perhaps 2,000 years ago when this was written there was a different understanding of what 'phamakoi' meant. As in, perhaps it only applied to the opiates that they were using as their choice of medicines of the day. Since these are the words of Jesus, I had to ask myself, "Would our all-knowing, all-seeing, omni-present Lord – when He was speaking about the end of days – and having already seen the end of days – possibly have spoken a word that didn't quite fit into our modern-day knowledge base? Could he have made a mistake? Was 2000 years too far in advance for Him to have imagined what would be happening in our day?" For those who believe in a literal Bible, it seems obvious that Jesus could see exactly who he was addressing – perhaps it's us. And appears that Jesus could see one of the biggest evils of our day – pharmaceutical takeover of our gov't. This is both a spiritual problem as well as a physical problem. If Satan can get us weak enough through drug use, he can bring our thoughts under submission. This issue is literally a fight for the bodies and the souls of men, women and children.
