

## Three Barnstaple 'Bills'

The town of Barnstaple is a seaport on the River Taw which flows into the Bristol Channel. This channel provides a maritime border between the English North Devon coast and the South Coast of Wales.

My x3 great grandfather was born in Barnstaple and lived his formative years there before a second criminal offence resulted in Transportation to Australia. However, the following does not address my personal ancestry, instead it derives from a recent request I received from a fellow researcher seeking advice on tracing her great grandmother-in-law.

In looking into this challenge I chanced upon three different William Laramys, contemporaries of my x3GGF all born in the 1820s in or around Barnstaple and for which there seems to be some confusion amongst researchers on the Ancestry platform as to which one was which. The following is my attempt to provide some clarity on this point. Of course, I too may have got this wrong so I would be grateful to be put straight where I am in error. Thanks.

In case you are wondering if my findings are of any interest to you, I'll just say up front that the respective spouses to these 3 Barnstaple 'Bills' were Mary Atkins, Mary Morgan and Mary Heal(e). Places include Nth Devon hamlets and villages surrounding Barnstaple such as Marwood, Pilton, Shirwell, Fremington and Braunton while this paper also touches on the counties of Monmouthshire and Glamorgan in Sth Wales. Several Laramy children end up in Michigan, USA via Canada while the siblings of one of our Bills migrated to the State of Ohio before settling in Colorado via Kansas. If that has piqued your interest, then read on.

I have also annexed to this paper family pedigrees for each of the 3 William Laramys detailed below.

### Gone Missing

The first Bill that I came across was a William Laramy living in South Wales in the late 19th century. He had three children between 1885 and 1891 with his domestic servant, a widow named Mrs Jane Rees. I had been looking into the GRO Indexes for children of unmarried mother's surnamed Rees in this period which led me to this man, alas these people are unrelated to the GGM-in-law I was trying to trace.

Tracking back from this William Laramy proved a challenge and there is a degree of speculation in what follows, but I will outline my reasoning. What I did know was that in the 1891 Welsh census William Laramy is described as a widowed farm labourer born in Barnstaple, Devon, England.

In the 1901 census William's place of birth is given as Marwood (a hamlet on the outskirts of Barnstaple). The respective census ages of 67 in 1891 and 75 in 1901 give William a year of birth circa 1825. Despite Laramy being an atypical name there were several William Laramys born in North Devon around this time.

However, I was stuck by one and that was William Laramy aged 15 years in the 1841 census living on Blakewell Lane in the Parish of Marwood and who had a younger brother named Philip. The boy William had with Mrs Rees in 1885 was named Philip. In the 1851 census the then 25yo William was no longer with his family but the family had since grown and now there was a sister aged 7 named Matilda, the same name as William's second child with Mrs Rees.

The coincidence that this William Laramy in Marwood had two younger siblings named Philip and Matilda, the same names given to my 'Welsh' William's own children was way too much to ignore.

I believe this William Laramy of Marwood is the same man who married Mary Atkins in 1845 with whom he had seven children between 1846 and 1861. This William was a farmer and innkeeper, then labourer, and can be found in the 1851 and 1861 censuses living with his wife and children in Pilton, North Devon. In the 1871 census his wife Mary is recorded alone with the children. She is described as married and working as a French polisher. 10 years later in 1881 the census recorded these same details, again married but no husband present.

Two consecutive censuses where Mary's husband was not with her needs some explanation. Her Bill did not have the sort of occupation that would keep him away from home on census night and I've not been able to find a census record for this William in 1871 or 1881. It is also worth noting that Mary had an occupation in her own right and was not described as, for example, 'farmer's wife'. This suggests to me that William and Mary were no longer living together but we're still married, and William was still alive somewhere else. As mentioned above in the 1891 census William was described as a widower and indeed, the french polisher Mary Laramy née Atkins had died in 1887.

I think the most plausible explanation for this is that sometime in the 1860s William Laramy deserted his wife and may or may not have relocated to Wales at that time. For whatever reason he felt the need to avoid being recorded in the censuses but by 1891 he was in a new family making it slightly more difficult to avoid the census of that year.

I wonder if William called himself a widower not actually knowing whether that was the case. I suggest this because it's curious that William and Jane never married. It's clear that Jane was free to do so, her husband had died in 1883, but I wonder if William was unaware that he was also free to marry again and wasn't prepared to take the risk of committing bigamy. In any event he had an extensive relationship with Jane over a minimum of six years during which time they had three children.

It is not simply that Mary Atkins' partner went missing from the census records that I think her husband was the father of Mrs Rees' 3 children registered at Gower, Glamorganshire. There may be an explanation for why he deserted his Devon family.

I cannot say for sure which Barnstaple man this relates to but there appeared in a Court report in the North Devon Journal in 1864 the following -

Assaulting a Wife. William Laramy defendant in a former case, was charged with cruelly ill-treating his wife, on Saturday night last. - The case was proved by the evidence of Ann Trump, who witnessed the assault ; but, as the wife declined to prosecute, Laramy was discharged on paying the expenses and promising to treat his wife well.

William, the father of three children with Mrs Rees died on 24 May 1908 at Cheriton Sth Wales. His son with Mrs Rees registered the death. William died of senile decay and, coincidentally just 4 months before he passed two of Mary Atkins' sons John and James Laramy travelled from North America where they had been living for over 35 years and arrived at Liverpool on 17 January 1908.

The brothers spent 5 weeks in the UK before returning to the US. What was the purpose of the visit? Their mother had been dead 20 years and only one brother remained in England. Did they make a mercy dash to bid farewell to their estranged father in Wales? It seems the most plausible explanation to me.

In summary my reasoning for the father of Mary Atkins' children and the father of Mrs Jane Rees' 3 Laramy children being one in the same William is –

- Both born Barnstaple/Marwood according to census records.
- Both involved in farming.
- No alternate records for Mrs Rees' William prior to birth of Philip in 1885.
- No alternate records for what became of Mary Atkins' William post 1860's.
- Mary Atkins described as 'Mar[ried]' in 1871 and 1881 census indicating her husband was still alive.
- Mary Atkins recorded with own occupation in 1871 and 1881 census indicating she was not supported by her husband.
- Mary Atkins' husband had siblings named Philip, Matilda and Sarah which were the names given to Mrs Rees' 3 Laramy children. None of these names were given to any of Mary Atkins' children.
- Circumstantial evidence for Mary Atkins having a troubled relationship with her husband.
- Potential explanation that Mrs Atkins' sons' trip back to UK in 1908 was to visit their ailing father.

## Shirwell

In a few Ancestry.com trees a second William Laramy is sometimes confused with the William Laramy above. Not without reason as they both hailed from the environs of Barnstaple, married women named Mary and lived in South Wales.

Bill number 2 was born William Laramy around 1829 and whilst the census records from 1851 to 1901 consistently record his place of birth as Barnstaple or Shirwell, the 1841 census records the family living at Nailsea in Somerset and, confusingly, all the children, including the 12-year-old William are recorded as having been born in that county.

I've not been able to find a birth or baptism record for William however there is a baptism record for his younger brother James which took place in Barnstaple in 1835. Another younger brother, Henry born circa 1831, is recorded in the 1861 census as having been born in Shirwell, Devon. I can only conclude William, and these siblings, were in fact born in or around Barnstaple in the county of Devon, not Somerset, and that the 1841 census is in error.

William's sister Ann however was born in Nailsea in 1838, and it is from her birth record that we learn that Ann's, and presumably William's, mother's maiden name was Cornish. William named his youngest daughter Amy Cornish Laramy, presumably after his own mother.

By the late 1840's William's family were living in Upper Llanfrechfa, Monmouthshire, Wales. William's father was a miner. William Laramy married Mary Morgan at Llanfihangel Llantarnam on 5 August 1850 in the county of Monmouthshire, Wales. They had 3 girls and 3 boys. William died 10 December 1901. His wife Mary died the following year.

## Bill number 3

Our third William Laramy was, like our second Bill likely born in the hamlet of Shirwell however unlike the other two he remained in the county of Devon throughout his life. This William married Mary Heal of Fremington in 1850. The village of Fremington is 3 miles west of Barnstaple on the southern banks of the Taw.

In the 1851 census William and Mary were living in Shirwell Town with William's parents, William and Hannah Laramy. I've not been able to identify any earlier records for William, and it is not clear whether he had any siblings. His parents are recorded in the 1841 census. Both William and his father were agricultural labourers.



William and Mary had at least 5 children, all girls. William died in 1909 and is buried at Saint Peters Church yard, Shirwell. He was predeceased by his wife Mary by two years, and they are buried together in the same church yard.

### **North American connections.**

Whilst William Laramy and Mary Heal's five daughters all lived out their days in the county of Devon, and William Laramy and Mary Morgan's six children remained in South Wales, four children of William Laramy and Mary Atkins made their way to the USA via Canada. And these were not the only Laramys to emigrate to the new world as two of Mary Morgan's brothers-in-law, having been born in Devon and living in Wales, made their way directly to the USA as adults.

It can be quite a pleasure working with American records given their availability online and the level of detail they can sometimes provide. This of course is offset by the completely missing 1890 Federal census records which were lost in a fire in the 1930's.

### **From South Wales to the Mid-West**

I'll start with the two Devon/Welsh brothers Henry Laramy and James Laramy referred to earlier. Whilst James was the youngest of the three Laramy boys, sons of Thomas Catter Laramy & Emma/Amy Cornish, he was the first to sail to the US after marrying Caroline Berge in 1856. The couple arrived at Turnbull, Ohio around 1857 with their newborn Welsh daughter named Elizabeth in tow. They had a further 7 American children moving to Kansa in the 1870's. By the 1890s James and Caroline were in Colorado where they lived out their days. James died in 1905, and Caroline followed him three years later.

James' brother Henry married Maria Joshua at Llanfihangel Llantarnam, Monmouthshire in 1849 and they had a son named William born 1850 and another boy in 1851 that they named James. This appears to be the only children they had. Sadly, James died at the age of four in 1855 and his mother Maria followed him in 1861 aged just 38 years leaving Henry a widower in sole care of their 10-year-old son William. It's very likely that this event was the trigger for Henry to emigrate and join his brother in the USA. I have not identified a shipping record, but Henry was in Wales for the 1861 census while on 11 June 1864 he was in Mahoning county, Ohio where he married Christina Emma Campbell.

Christina and Henry had at least five children before Henry filed for divorce in 1878. I don't know the details of why he filed for divorce but it's worth noting that around this time Christina had a child she named Viola and it appears that Henry was not father. Christina married again to an Edward Cross in 1883 in Allegheny County Pennsylvania and they had a daughter and a son. Christina died in Hudson County, New Jersey in 1919.

Henry had filed his divorce papers in the state of Kansas which was where his brother James had relocated to in the mid 1870's. Henry married for the third time at Coffey County, Kansas in 1884 to Mrs Nancy Knowlton née DeSpain. Nancy was the widow of Atwood Knowlton with whom she had two children and adopted a third. In 1891 Nancy's daughter Henrietta Knowlton married Charles Laramy, Henry's son with Christina born 1865 in Ohio.

Henry and Nancy did not have any children, and their marriage did not last. Whilst I cannot find a divorce record Nancy remarried to a William Farmer at Missouri in 1894. Curiously, Nancy used the surname Knowlton rather than Laramy and the

question arises as to why the couple, both residents of Coffey, Kansas travelled 400 miles across state lines to marry.

After the break-up of his marriage to Nancy Henry made his way to Colorado where his brother and sister-in-law were. Henry Laramy died in 1897.

### **Just do it**

I mentioned above that several children from the first Bill detailed in this paper also made their way to North America. William Laramy and Mary Atkins had at least 7 children before William escaped to Wales. The oldest, Mary Ann born 1846, sadly died just 11 years of age in 1857 and the next two children, William b.1847 and Eliza A. b.1849 both married in, and remained in, England.

In what I find to be an incredibly brave act their fourth child Maria, born 1851, at just 20 years of age along with two younger brothers in her care boarded the ship *Nestorian* at Liverpool bound for Canada arriving at Québec, 13 August 1871. The shipping records do not reveal much, and I don't know whether anyone was waiting for them on the other side. All the same I'm mightily impressed by her.

Maria Laramy married Christopher James Emery in 1873 at Oxford, Ontario. James was also a native of Devon but had been in Canada most of his life having arrived with his parents and siblings in 1854. Around 1882 Maria and Christopher travelled 250 miles west from London, Ontario leaving Canada for Grand Rapids, Michigan, USA. They had at least 9 children. Christopher died in 1895.

At 46 years of age Maria married again to the 60-year-old widower Silas J Powell at Grand Rapids in 1897. They divorced in 1911. Maria died at Los Angeles, California in 1927.

Maria's brothers John born 1853 and James born 1858 are both recorded in the 1881 Canadian census at Westminster, London, Ontario about 25 miles away from their sister Mrs Maria Ellery. John married Elizabeth McConville sometime in the mid 1870s. They had a son, John Edward Laramy born in 1876. Elizabeth already had a son named Thomas born circa 1869. I've not found a marriage record for John and Elizabeth. I suspect Elizabeth had not been married previously. But that's just a guess.

John and Elizabeth had a further three children in Canada before also relocating to Grand Rapids, Michigan in the early 1880s. John Laramy died in 1910 aged 56. His wife Elizabeth died in 1924.

John and Elizabeth's fifth and last child, named Frederick George Laramy, was born in 1887 at Grand Rapids. At least that is according to the birth registration that took place in Michigan 8 months after his birth. However, 55 years later in 1942 Frederick's uncle James Laramy attested to Canadian authorities that he was present and recalled that the birth occurred at London, Ontario. Frederick was obviously keen to be a Canadian.

It seems all 3 siblings chose the US over Canada at the same time. Around 1883 the youngest of these three, James, married the widow Katherine (Katie) Wadsworth

née Roundy. I've not yet found a marriage record however the 1900 US census records James as having been in the US 18 years and married for 17. James and Katie did not have children although Katie had a daughter from her first marriage. Lottie Wadsworth was born in 1879 and took her stepfather's surname of Laramy.

Katie died at Grand Rapids in 1907, after which James married the widow Mrs Malisa Kyes née Howe in 1909. James and Malisa had a daughter in 1910 they named Mary Madeline Laramy. James died in 1947 at the ripe old age of 89. His second wife Malisa had died just over 2 years earlier in November 1944.

## **A Fourth Musketeer**

Sometime in the early 1880s Maria, John and James were joined in Michigan by their youngest brother George Laramy. George was just 10 years of age when his sister Maria and brothers John and James made their way to Canada in 1871. A decade later aged around 20 years of age the youngest of Mary Atkins children, George, made his own way across the Atlantic to Michigan and in 1884 he married Ida Elizabeth Chapell. They had at least five children. Ida died in 1938 after which George married again to the widow Mrs Lillie Boyer née Gray. Lillie died in 1950, and George went the following year.

Mary Laramy née Atkins 1824-1887 the wife of our first Bill had 20 American grandchildren that she never got to meet. In England only her daughter Eliza Atkins Hall née Laramy had one son named Reginald William Hall and he had no children leaving all of Mary's descendants in Nth America.

## **And Finally**

## Annex A – Paternal Grandparents of Bill no.1

The grave of Philip and Sarah Laramy and their son John is in the Church yard of St Peter's, Shirwell. I outline below 4 other children of this couple.

### Three Barnstaple 'Bills'

John Laramy died in 1843. His father Philip died 1835 aged 65 and his mother Sarah died 1838 aged 62. The gravestone records John's death as 1 April 1843 aged 42 years. His death was registered at Barnstaple in the second quarter of 1943, volume 10, page 27. John was married to Elizabeth Carder and they had at least five children.

John's wife had died in 1840 and is buried at Marwood which is where the Carders were from. In the 1841 census John was a farmer living at Marwood. With him were Betsey aged 9, Mary 7, Sally 5, John 4 and William 2.

In the 1851 census these children can be found as follows.

- **Betsey** b.1832 was at her maternal aunt's in Marwood. Elizabeth's sister Mary Carder married William Gould in 1835. William died in 1845. Mary appears in the 1851 census as the wife of Joseph Irwin. Her two surviving children from her marriage to William Gould are with her as is the daughter she had with Joseph in 1850.
- **Mary Ann** b.1834 and **Sally/Sarah** b.1836 were in the house of George & Elizabeth Basldon described as nieces. George Balsdon married Elizabeth Laramy in 1823.
- **Philip** b.1837 was with his maternal grandmother and uncle, Mrs Mary Carder and her son Thomas. Philip is designated the nephew of Thomas.
- **William** b.1839 was with his uncle James Laramy in Westleigh, Devon. He is recorded in the census as James' nephew.

The above I believe confirms that John's wife was Elizabeth Carder from Marwood. It is also evidence that Philip and Sarah Laramy had a son named James born circa 1794 and a daughter named Elizabeth born circa 1797.

Elizabeth Basldon née Laramy died in 1875, and her executors included nieces Maria Bird and Sally Elizabeth Rude. Maria Bird née Laramy, born 1828 in Marwood was the daughter of William Laramy & Maria Marshall who had nine children including Bill no.1, the husband of Mary Atkins. Miss S E Rude born 1838 in Barnstaple was the daughter of John Rude & Sally Laramy.

Given that Elizabeth born circa 1797 was the aunt of Maria Bird and Sally Rude it follows that their respective parents, William born circa 1791 and Sally born circa 1810 were Elizabeth's siblings and children of the above Philip and Sarah Laramy.

Thus, Phillip and Sarah had at least the following five children

- William 1791-1873 m. Maria Marshall
- James 1794-1882 m. Susanna Basildon
- Elizabeth 1797-1875 m. George Basildon
- John 1801-1843 m. Elizabeth Carder
- Sally 1810-1904 m. John Rude
