Target Audience

This activity is designed to meet the educational requirements of Interventional and General Cardiologists, Internists, Cardiothoracic Surgeons, Primary Care Physicians, and Nurses, Nurse Practitioners, Residents, Fellows, and ancillary staff.

Overview

ARCH Hawaii 2026 will be held at the Sheraton Waikiki, January 15–17, 2026, bringing together leaders in interventional and structural cardiology, imaging, peripheral interventions, and general cardiovascular care. The program integrates live global case transmissions, cutting-edge technologies, disruptive innovations, and expanded content for general cardiology practitioners.

The meeting emphasizes real-world, evidence-based strategies with sessions covering complex PCI, lifetime structural heart management, imaging integration, pulmonary embolism and DVT care, and state-of-the-art pharmacologic updates. This year introduces dedicated sessions on general cardiology topics—hypertension, heart failure, atrial fibrillation, GLP-1/SGLT2 therapies, and dyslipidemia management—broadening the scope for a wider audience.

Learning Objectives

- Integrate emerging disruptive technologies into interventional practice.
- Apply advanced strategies for complex PCI including calcium modification, bifurcation lesions, and left main optimization.
- Incorporate imaging and physiology to enhance decision-making in PCI.
- Evaluate the latest clinical evidence from landmark trials of 2024–2025.
- Manage heart failure, atrial fibrillation, dyslipidemia, and metabolic therapies using new guideline-based updates.
- Describe multidisciplinary approaches for PE, DVT, and venous interventions.
