Attention Exhibitors

CRATING in designated areas only. CRATE SPACE IS LIMITED. X-pens will not be allowed in the building. Dogs must be removed from the Trial site immediately following the conclusion of the judging every night. No dogs may be left in building overnight. There will be no space for un-entered dogs

PLEASE CLEAN UP AFTER YOUR DOGS

ALL DOGS PRESENT MUST BE HELD ON LEASH BY THE HANDLER OR CONFINED TO THEIR CRATES except when being judged.

Dogs may not be on Flexi-Leads or long leads while in the building. No prong collars.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIAN'S recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

No RV or Overnight parking available at the Trial Site. See list of accommodations for details on RV parking

THE TRIAL SITE will be available at 7:45 am.

ENTRY FORMS MUST BE SIGNED at the bottom by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted.

CHANGES, ADDITIONS OR CORRECTIONS to entry forms must be received in writing or by e-mail prior to the close of entries. Those received by telephone are not acceptable.

ERRORS ON ENTRY BLANKS. Owners and handlers are responsible for errors in making out entry forms and no entry fee will be refunded in event of such error or cancellation of entries after the published closing date. Please print plainly or type all information on your entry to help avoid errors.

A RECORDING FEE of 50 cents and \$3.00 AKC Event Service Fee are required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test.

This Recording Fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (AKC Dog Show Rules, Chapter 11, Section 2).

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by the action of the Event Committee.

If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies and the dictates of law enforcement or the owners of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not

limited to snowstorms, hurricanes, lightning, extreme heat, heavy rains or other circumstances including, but not limited to, the condition of the facility or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund will be made. POST DATED CHECKS AND RETURNED CHECKS do not constitute a valid entry fee. The Secretary will add a \$15 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as practicable after entries close with confirmation and judging programs. Should such acknowledgement not be received by exhibitor within a reasonable amount of time, please notify Trial Secretary.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. Owners or agents alone are responsible for the presence of their dogs in the ring at their scheduled time. Judges will adhere as closely as possible to the judging schedule.

Every effort will be made to accommodate handlers with multiple dogs in the same class.

Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal & external parasites, communicable diseases and have appropriate vaccinations

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs.
