Dogs must be removed from the Trial site immediately following the conclusion of the judging every night. No dogs may be left in building overnight. There will be no space for un-entered dogs **PLEASE CLEAN UP AFTER YOUR DOGS**

ALL DOGS PRESENT MUST BE HELD ON LEASH BY THE HANDLER OR CONFINED TO THEIR CRATES except when being judged.

Dogs may not be on Flexi-Leads or long leads while in the building. No prong collars.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIAN'S recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

ENTRY FORMS MUST BE SIGNED at the bottom by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted. **CHANGES, ADDITIONS OR CORRECTIONS** to entry forms must be received in writing or by e-mail prior to the close of entries. Those received by telephone are not acceptable.

This Recording Fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (AKC Dog Show Rules, Chapter 11, Section 2).

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by the action of the Event Committee.

If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies and the dictates of law enforcement or the owners of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the event, no refund of entry fee will

be made.
