



#### THE NCPACA LIFETIME ACHIEVEMENT AWARD


The Lifetime Achievement Award is presented to outstanding members who have contributed to the advancement of the accounting profession, have served and who continue to assist the National Council, their chapters and their community, and who uphold professional and personal integrity, The recipient of the award is given the title of "Councilor".

Each year, the Selection Committee receives nomination from officers and members of the NCPACA and member chapters. The committee members review these nominations using strict guidelines that were instituted and approved by the members of the Board of Councilors. The members of the Selection Committee are elected by the Councilors from among its members, For the years 2020-2021 there are eleven members of the Selection Committee including the Governor of the Board of Councilors and the NCPACA President.

The Board of Councilors consists of all the awardees. Through 2021, there are now a total of one hundred (100) Councilors who have been conferred this honor including this year's new councilors.

The Councilor award was established by the NCPACA in 2002, The founders were Bobby dela Cruz of Toronto, Al Maglan of San Francisco and Rick Sesbino of Dallas (deceased).

While it serves as recommendatory body in terms of the NCPACA policy issues, the Councilors may also embark on projects separate from the NCPACA, The Councilors do not supplant the existing Council but contribute to make it grow better and stronger, The Councilors elect their officers every two years, a Governor and Secretary General. Their terms coincide with the elected NCPACA officers. The current Governor is Ms. Vivian Roz from AFAA-New Jersey and the Secretary General is Ms. Stella Marie Santos from PCPAs of Greater Chicago.





### BOARD OF COUNCILORS OBJECTIVES


1. To recognize those members who made significant contributions to the well-being of the NCPACA and the chapters;

5. To foster and enhance the spirit of camaraderie and brotherhood within the chapters and the National Council.








## **Message from our Governor**




## **Message from our Secretary General**

Ramon Guanzon, CPA, CA




Ramon has made significant contributions to the Accounting Profession especially among the Filipino immigrant community.


Ramon is a passionate practitioner who always give back to the community through his volunteer efforts since coming to Canada in 2004.


#### **Councilor No. 99**




## **Councilor No. 100** Czarmel Lopez, CPA
