- \* To include all the Past NCPACA Presidents in the monthly NCPACA teleconference meetings as they are the foundation of the NCPACA.
- \* To release all approved monthly meetings within a week or two.
- \* To have the Treasurer's Report during the monthly NCPACA teleconference meeting.
- \* To release all approved minutes of the NCPACA Past Presidents' meetings, NCPACA Executive Board Meetings, and Annual General & Business Meetings be completed within a month or two after the said meetings.
- \* God has given each one of us the POWER. All we need to do is to use that POWER. P = stands for Plan; O = stands for Organized; W = stands for Work; E = stands for Enthusiasm; R = stands for Results.
- \* To increase the NCPACA membership; to create new chapters; to increase the attendance of the annual convention; and to encourage the active participation of the councilors who represent the majority of the expected attendees of the annual convention.




universities in the area to promote AFAA-NJ and the Scholarship grants of NCPACA.

As Councilors, we strive to fulfill our mission and goals to be in service to our fellow Councilors and NCPACAn, this includes:

- Updating the Board of Councilors directory
- In December 2020 raised funds (for NCPACA) totaling \$2,425 for the typhoon/earthquake victims in the Philippines. The donation was sent to PICPA (through the courtesy of Evely Chun Peng) and in coordination with PICPA President Jun Bato and Ms. Lita Aguirre, funds were awarded to the earthquake victims in Mindoro. An official receipt amounting to Ph 116,739.50 was received and acknowledged by PICPA.
- We also started Quarterly Meetings for the Board of Councilors (instead of annual / convention meeting). Meetings were held on Jan 7, 2021, April 19, 2021 (Selection Committee only), May 19, 2021, and July 26, 2021.
- Finalized proposal to provide financial aid to Councilors 75 years old and over to give 50% discount in the delegate fee. Such discount shall be shown in the Delegate Registration Form.
- Improved and revised the Councilor Nomination package and Councilor Selection to show/include in the Nomination Package and Evaluation Forms: 1) The rating (%) for each criterion and the passing %. 2) Enumerate/show by box/checklist form (for check off) the location and year of the last 10 NCPACA conventions. 3) Enumerate year and position (outline form). 4) Give specific descriptions on professional accomplishments and community involvements. 5) Match/reconcile nomination criteria guidelines against the evaluation sheets and include breakdown of rates to be assigned to criteria
- Agreed to 'decentralize' responsibilities by naming a 'Councilor-in-Charge' from each Chapter, who shall be responsible in coordinating future Councilor's events/activities per Chapter, follow-up attendance and meeting participation.
- At the councilors meeting, our Secretary General Stella Santos donated \$2,000, Marlo Mallari and Abraham Villanueva pledges to donate \$100 each to fund Councilors Bank Account to drop the deficit balance and for the incoming officer to start anew.
