- 3. A nominee must have held an elected position at NCPACA or must have successfully chaired a major committee of the National Council or helped create a Chapter 25 points
- 4. A nominee must have done significant contributions and services to NCPACA or Chapter to uplift the accounting profession -10 points
- 5. A nominee must have made some important contributions to his/her community as well -10 points
- 6. A nominee must have outstanding reputation in his personal and in his professional career 35 points
