## **Topics Discussed**

**Adding Matthew Frazier:** Richard moved to add Matthew as our 7<sup>th</sup> and final board member. Morris 2<sup>nd</sup> this motion. All approved.

**Web Page:** Morris will continue to work on the webpage. We discussed giving everyone their own login, and reaching out to those that we do not have an email on file for yet.

**Lights at front entrance:** Richard motioned to set a budget of \$500 to add wired electric lights around the front entrance. Morris 2<sup>nd</sup> this motion. All approved.

**Non Payers:** Richard will have an attorney mail letters to those that have not paid by August 21, letters will be sent certified.

**Mowing:** Richard motioned to pay the current land scaping the additional \$15 per cut that they quoted to mow the small ditch area to the left as your enter the neighborhood.

**Clearing the lot:** The vacant lot has become over grown and an eyesore. The current landscaping company quoted around \$2,400 to clear it. We decided to get another quote from Butcher's Skid Steer Services.

**Street Signs:** Still working with the city. They are going to review the original plans and install them where they're missing.

Richard motioned that we mail everyone a copy of the application to everyone. Jason 2<sup>nd</sup> this motion, all approved. Richard motioned that we mail everyone a letter that is out of compliance with sheds/fences explaining

that they will need to be brought into compliance if they ever need replaced/major repairs/ or before selling the property. Jason 2<sup>nd</sup> this motion, all approved.

**Adjusting Bylaws:** We agreed that some of the DOR's and some of the bylaws contradict each other and need to be adjusted to be more realistic. All board members agreed to read through them so that this can be discussed in further detail at a future meeting.

**Lawyer:** We discussed trying to find a local attorney to aid in adjusting the DOR and bylaws, and someone that was can use to mail legal letters when necessary.

**Plat:** Richard is going to work on obtaining a large copy of our plat. This will aid in approving futures applications for fences, storage sheds, swimming pools, etc..

**Planning Annual Meeting:** Its time to start thinking about planning our annual meeting. We set a date of August 21<sup>st</sup> to meet and plan this event.
