## 2. SELLER WARRANTS

If for any reason a buyer who is first on the waitlist does not want any of the puppies of a certain litter and wants to move to the next litter that buyer will still be first on the next litter because they have been waiting for their desired puppy for the longest amount of time.
- 2.2 That the date shown on <a href="https://desertdawndoodles.com/waitlist">https://desertdawndoodles.com/waitlist</a> next to the BUYER name is the date the deposit was received by SELLER.

## 3. BUYER WARRANTS

3.1 That he/she in good faith believes that he/she is capable of and plans to meet the puppy's future health and welfare needs.

- 3.2 That he/she plans to purchase the puppy for himself/herself and not as agent for a third party.
- 3.3 That he/she, nor any member of his/her household, has not been convicted of any breach of animal welfare laws.
- 3.4 That the puppy will primarily reside inside the Buyer's home, that dogs are allowed in this home and the dog will be properly exercised.
- 3.5 That Seller is not responsible for any transportation costs incurred by acquiring, returning or replacing a puppy.
- 3.6 That the puppy will not be used for breeding purposes and that the puppy will be spayed or neutered before the puppy reaches one year of age.

## 4. BOTH BUYER AND SELLER AGREE AND UNDERSTAND

- 4.1 That order of priority placement (Puppy Pick Order) for each litter is based on the order the BUYER'S deposit is received and breeder picks (if any).
- 4.2 That the BUYER cannot guarantee the breeding attempts during our DAM's next heat cycle will produce a puppy or that puppies whelped will have the gender, size or coat preferences identified in section 1.
- 4.3 That the BUYER must make a purchase decision within 6 weeks of the DAM'S whelping date.
- 4.4 That if the BUYER makes a purchase decision a separate contract for the sale and purchase of a puppy must be signed by both the BUYER and SELLER within 45 days of the DAM's whelping date.
- 4.5 That the PUPPY RESERVATION DEPOSIT amount listed in SECTION 1 is non-refundable and carries over to subsequent litters until the BUYER has found a puppy they are satisfied with.
- 4.6 That SELLER is entitled to the first pick of any litter advertised on desertdawndoodles.com, regardless of BUYER deposit date.
- 4.7 That the average range of our adult-size Micro-Mini Goldendoodle puppies has been 10-20 pounds but we have seen some very rare outliers, with 7 pounds being the smallest and 28 pounds being the largest. Our adult-size Mini Goldendoodle puppies have ranged from 18 pounds to 33 pounds.
