- 4.5 That the puppy will primarily reside inside the Buyer's home, that dogs are allowed in this home and the dog will be properly exercised.
- 4.6 That Seller is not responsible for any transportation costs incurred by acquiring, returning or replacing a puppy.

4.7 That BUYER will spay/neuter the puppy before one year (12 months) of age and provide BREEDER with written confirmation from a veterinarian that the puppy has been spayed or neutered

**4. BOTH BUYER AND SELLER AGREE AND UNDERSTAND**

4.1 That order of priority placement (Puppy Pick Order) for each litter is based on the order the BUYER'S deposit is received and breeder picks (if any).

4.2 That the SELLER cannot guarantee the breeding attempts during our DAM'S next heat cycle will produce a puppy or that puppies whelped will have the gender, size or coat preferences identified in section 1.

4.3 That the BUYER must make a purchase decision within 6 weeks of the DAM'S whelping date.

4.4 That if the BUYER makes a purchase decision a separate contract for the sale and purchase of a puppy must be signed by both the BUYER and SELLER within 45 days of the DAM'S whelping date.

4.5 That the PUPPY RESERVATION DEPOSIT amount listed in SECTION 1 is non-refundable.
