ACCEPTANCE OF CASES: Ally Denture Lab reserves the right to accept or refuse cases by any Dentist at its sole discretion based on factors such as condition of impression and other quality of incoming work. Ally Denture Lab is not liable to complete any case it does not accept.

WARRANTY: Ally Denture Lab provides limited warranty for defects in workmanship and materials for varying time periods depending on the type of product.

- NO Warranty for flippers, immediate dentures and partials, denture and partial repairs and addition of teeth or clasps.
- 30 DAY WARRANTY for Pro-Form Sport Guards, Hard and Soft night guards
- 60 DAY WARRANTY for gaskets and Its-so-clear clasps.
- 1 YEAR WARRANTY for economy denture based on documented maintenance
- 3 YEAR WARRANTY for standard dentures based on documented maintenance.
- 5 YEAR WARRANTY for deluxe dentures based on documented maintenance.
- LIFE-TIME WARRANTY for flexible products only against breakage; NOT wear and tear, teeth or discoloration.

The cost of fabricating custom made dental appliances cannot be refunded. A credit may be issued to the doctor's account when cases do not meet industry standard for quality, function and aesthetics. Each appliance must be inserted by a licensed practicing dentist. The client/dentist are responsible for the fitness and use of all appliances. Ally Denture Lab makes no warranty of merchandise or fitness for a particular purpose.

REMAKES: During the guarantee period we will take the following steps:

- Remake or repair the original product at no cost to the customer.
- Replace the defective product with a different product of equal value. If the replacement
 product is of greater value, the customer will be charged for the difference.
- If credit is requested: NO CASH REFUNDS WILL BE ISSUED. In-house credit may be
 given but it must be used within 60 days. Credits are only available up to 30 days from the
 day the product leaves the laboratory and appliance must be returned with the unaltered
 original models.
