Inside the Institute: A Year in Review

In September 2009, following a six-month long, comprehensive, community and service agency-engaged research process, the Public Policy Institute of Marion County, Inc. (PPI) released the 2009 Kinship Care Study in conjunction with the 3rd Annual Kids Central, Inc. Kinship Care Seminar held at the Klein Conference Center at the College of Central Florida. The release of this study represented the collaborative dedication and leadership of agency and organization representatives that provide kinship-related services in our community. Projects such as this, facilitated through the Institute on an annual basis, offer the citizenry of Marion County an opportunity to participate in improving the quality of life in our community, and in this case, focus their efforts on our most vulnerable populations.

Shortly after the release of the kinship care study, the PPI Board elected to focus the 2010 research project on revisiting a past endeavor in hopes of creating an up-to-date research tool that could further benefit a broad-base of agencies and organizations serving the citizens of Ocala/Marion County. The past endeavor, the 2005 Quality of Life Progress Report (QOL), was a comprehensive indicator project that included statistical data on ten critical categories including health, education, and economy. The 85-page report was offered to the community as a resource in supporting project development for community groups, service-providers, and non-profit organizations. The PPI Board also determined the update of the QOL project would be a subscriber accessible electronic database, providing current and timely information on critical indicator areas and would be maintained as an on-going resource by the Institute.

These studies have provided valued information to the community and in many cases resulted in the establishment of citizen-powered organizations that have continued the community conversation far beyond the pages of the published study.

To ensure continued citizen-engagement and long-term sustainability of the organization, the Public Policy Institute, Inc. initiated a funding campaign in fall, 2007. The ongoing campaign is focused on acquiring long-term financial support through public, private and corporate sponsorship. Though membership revenue reflects continued community support of the Institute, additional funding is needed to ensure future sustainability. In an effort to meet funding needs, strengthen community partnerships and encourage citizen involvement in the vision and mission of the organization, the campaign will continue for the next five fiscal years. 
Membership Revenue: \$4,050
