Stage One: Initial Audit

Description	An independent audit against the Cosmetic Practice Standards Authority (CPSA) overarching and skin rejuvenation standards, alongside key elements of ISO: 9001.
Format	Delivered by a trained IQ Verify auditor on site/ off site (as required).
Duration	3.5 Days
Price	£3,125 £2,500 (+VAT) (incl. 20% discount) <i>In the case of there being significant issues identified within the audit, additional time required to review and clear findings charged at daily rate (where required).</i>
Outcome	Formal certification as an IQ Verify approved Learning Provider, valid for 3 years . Unlocks delivery of IQ Verify Level 4-7 in Skin Rejuvenation.
Maintenance	£1,200 (+VAT) per annum, requires annual 1.5 day reaudit of ongoing compliance.

Stage Two: Software Set-Up

Description	IQ Verify Learning Management System (LMS) set-up for delivery of the IQ Verify Skin Rejuvenation programme. Includes: comprehensive eLearning, guideline compliant clinical logbook generator, RPL logbook generator, student/ assessor portal, faculty chat functionality and staff registration and training on the system.
Price	£3,000 (+VAT)
Outcome	Access to stage three below.
Maintenance	£2,000 (+VAT) per annum, only applicable if less than 30 registrations per year.

Stage Three: Student Registration

Description	Student pre-registration and registration with IQ Verify: <ul style="list-style-type: none"> Pre-registration enables candidate LMS licence allocation to access eLearning and RPL logbook functionality. Payment is taken at this stage. Formal registration is required to access the subsequent IQ Verify examinations and relies upon the completion and sign off of the IQ Verify learner application. All students must begin at Level 4 whether via RPL or the full certification pathway.
Price	<ul style="list-style-type: none"> Level 4: £500 (+VAT) (UKAS accredited, allows entry to Part B of JCCP register). Level 5: £500 (+VAT) (in pilot prior to submission for UKAS accreditation) Level 6: £500 (+VAT) (in pilot prior to submission for UKAS accreditation) Level 7: £500 (+VAT) (in pilot prior to submission for UKAS accreditation) <i>Re-submission / resit fees for candidates who fail one or more of the assessments are charged at £150 (+VAT).</i>
Outcome	Formal skin rejuvenation certification at the relevant level, valid for 3 years . Unlocks access to the next level in the progressive Level 4-7 framework.
Maintenance	£300 (+VAT) every three years from the date of the highest level achieved within the framework. Candidates are re-examined at this level to ensure the maintenance of certificated competency over time, as per the requirements of the ISO.
