VETERANS' FISHING TRIP:

Thank you all who have paid past dues and future dues and donated to our charities. It gave us some financial breathing room. We started August with \$4,445.12 in our account. We took in \$4,060.00 and had expenses of \$581.83, resulting in a balance of \$7,923.29, of which \$3,476.11 is in savings. Of the \$4,447.18 in the checking account, \$5,595.81 are designated for the Youth Scholarship Fund, \$75.00 for the Barstow Veterans Home, \$75.00 for the Apple Valley Legacy Museum, \$100.00 for the Parade of Pianos, and \$75.00 for the Flight Museum. Also, \$400.00 are prepaid dues for 2026 and 2027.

After writing the checks to the youth scholarship recipients on 1 May, we had to move \$600.00 from savings to the checking account to cover our expenses. While our expenses increased over the years, our dues remained \$25.00 for over 25 years. To stop the bleeding, our Board of Directors voted to increase our dues to \$35.00, starting with the year 2026. For those who had prepaid their dues for 2026 (and 2027), you do not have to pay the increased amount until after the end of your prepaid years.

ARE WE RETIREES HEADED FOR TROUBLE WITH TRICARE?

Tricare's current unpaid claims and coverage gaps are creating turbulence for many military members whose doctors are dropping Tricare coverage. Indeed, changes to the military's health care program are causing disruptions which are quickly transforming into tsunami type devastations for many military families. Several thousand Tricare providers haven't been paid for months, forcing many to drop patients, reduce hours or consider closing their clinics.

However, even more unsettling issues are looming. As of Aug. 31, 2025, the TRICARE pharmacy benefit does not cover weight loss drugs for TRICARE For Life beneficiaries, individuals with direct care coverage, and certain other groups when treatment of obesity is the primary diagnosis. Those retirees who are not obese, may still need to worry! TRICARE's efforts, seemingly in violation of existing law, to end coverage of GLP-1 medications (like Wegovy and Zepbound) for TRICARE For Life (mostly Medicare-eligible) beneficiaries may well be a harbinger of things to come:

Military retirees who reach age 65 and become eligible for Medicare Part A and B are automatically enrolled in TRICARE for Life (TFL), a statutorily created DoD health benefit that functions as secondary coverage to Medicare. Congress passed TFL through the FY2001 National Defense Authorization Act (P.L. 106-398) to ensure lifetime health coverage, including access to TRICARE pharmacy benefits.

Unfortunately, the Defense Health Agency (DHA) has adopted policies that deny TFL beneficiaries coverage for certain drugs solely because Medicare does not cover them. This denial directly violates 10 U.S.C. §1074g and Congress's stated intent to guarantee full and equal pharmacy benefits to all TRICARE beneficiaries, regardless of Medicare eligibility. See 10 U.S.C. § 1074g(a)(2), (a)(4); 32 C.F.R. § 199.21(h)(2)(ii), (k)(1).

It also rests on a misreading of 32 C.F.R. § 199.17(f)(3) and its reference to 10 U.S.C. § 1079(a)(10) and NDAA 2017 § 729, neither of which authorizes a plan or age-based split in the pharmacy benefit.

This plan definitely looks like a first step towards taking away more of the health care we were promised when we signed up and served. As "they" set up a two-tiered system - keeping the coverage for younger retirees and service members and their families - this seismically shifts the cost of effective medications onto 65+ retirees and violates laws passed in the National Defense Authorization Act of 2001. Twenty-five years ago, Congress and DOD integrated the Medicare eligible cohort into a single TRICARE pharmacy program - the TRICARE Senior Pharmacy Program ("TSPP) and created Tricare for Life and the Tricare Senior Pharmacy Program for Medicare eligible retirees. Congress thus fixed a problem and ensured Medicare eligible retirees would regain the same pharmacy access as all other Tricare enrollees. (10 U.S.C. § 1086(d)(2), § 1074g); However, we are now moving backwards to a less equitable period.

Those of us who plan to live past 65 - who are and surely will be impacted by this - should immediately contact their elected representatives and help reverse this disturbing step back to a darker time.

Many of us appreciate having the ability to access information that will provide us with accurate and safe references for the problems and advice we need for our everyday lives. In the July 2023 issue of *Military Officers*, there is an outstanding article by Captain Paul J. Frost, who is MOAA's program director for Finance and Benefits.

There are many important apps that can be accessed through the Defense Health Agency (DHA) and TRICARE. We are able to acquire them on several devices such as a tablet, a watch, a desktop, or even our cell phone. For the initial inquiry, go to the following webpage www.tricare.mil/resources/gopaperless/mobileapps. Here is a partial list of several suggestions by Captain Frost that might be of particular importance to your specific lifestyle needs:

- ➤ Humana Military (TRICARE East): beneficiaries and eligibility
- > Express Scripts: pharmacy info
- > MyCare Overseas (international SOS): medical services overseas
- QuickSTART: program to quit smoking
- Breathe2Relax: manage stress
- Tactical Breather: stress relief through exercises
- > PTSD Coach: deals with symptoms of PTSD
- Pain and Opioid Safety: provides guidelines
- ➤ BIOZEN: monitors biosensor devices
- ➤ Provider Resilience: ways to prevent "burnout and compassion fatigue"
- MissionFit: fitness program for the Air Force
- > DHA Medication Adherence: assists with the understanding of prescribed medications

Always remember that MOAA is here to help with any issue that you might have. Never think you're alone, or that your problem isn't relevant. The resources are available for you. 



CHAPLAIN'S REPORT A SPECIAL TRIBUTE TO A WAR HERO

Ensign Donald M. McPherson



Ensign Donald McPherson earned the Congressional Gold Medal and three Distinguished Flying Crosses during his service as a US Navy Pilot aboard the aircraft carrier USS Essex in the final battles of World War II.

Donald McPherson, believed to be America's last surviving "ace" from World War II, passed away on 14 August 14 2025. He was 103 years old.

McPherson enlisted on 5 January 1943, after the Navy waived a two-year college requirement for its aviation cadet training program. He earned his commission and wings at Corpus Christi, Texas, on 12 August 1944. He was assigned to fly a Grumman F6F Hellcat fighter and was a part of Fighter Squadron 83 when it was transferred to the USS Essex in March 1945, during the battle for Okinawa.

On his second evening aboard the Essex, McPherson recalled watching Japanese kamikaze bombers based on Kyushu in southern Japan attack the fleet. One bomber clipped the Essex's radar tower before crashing into a nearby island. Another bomber seriously damaged the USS Hancock.

"This sure made us wonder what we had gotten ourselves in for," McPherson recalled.

McPherson completed his first combat mission—a 300-mile flight to strike on an airfield at Nittigahara—on 19 March 1945. During the raid, his division, known as "Wonder-5" destroyed Mitsubishi G4M 'Betty' bombers on the ground. As he was pulling out from the attack, his plane's engine stalled, and it was struck by anti-aircraft fire. McPherson was able to fly the plane back and successfully land on the USS Essex.

"Upon inspection of the damage to the airplane, we found that a 20mm cannon shell had penetrated the fuselage about a foot behind my back and severed one of the cables that controlled the tail surface," he recalled.

Between March and June 1945, VF-83 flew 6,560 sorties from the Essex. McPherson's group was credited with destroying 220 Japanese planes in the air and 72 on the ground. McPherson would become an ace after shooting

down two Aichi D3A Val dive bombers near Kikai Shima off Okinawa on 6 April 6 1945. He would go on to destroy three Kawanishi E7k float biplanes, which were flying as kamikazes, on 5 May 1945.

McPherson was able to marry the "love of his life" Thelma Johnston, on 17 August 1944 after completing his training. After the war, he returned home to Adams, Nebraska, to work as a letter carrier. He is survived by his two daughters, a son, along with many grandchildren and great-grandchildren.

McPherson was an active member of the Adams United Methodist Church, as well as the local American Legion and Veterans of Foreign Wars. He also served as organizer, promoter, and coach for the Adams Summer Baseball and Softball leagues.

The Associated Press reports that the community later named the ballfield McPherson Field in honor of him and his wife.

Last month there was an aerial photo of George Air Force Base near its beginning in 1943 as Victorville Army Air Field. Below is a photo of George AFB near its end. This picture was taken in the mid-1980s and shows part of George AFB below the aircraft and parts of Victorville and Apple Valley in the background. George AFB closed in December of 1992 due to a decision by the 1988 Base Realignment and Closure (BRAC) Commission after the end of the Cold War.



Shown are three USAF F-4Es from the 35th Tactical Fighter Wing stationed at George Air Force Base. The lead aircraft is from the 21st Tactical Fighter Squadron. On the left wing is a 20th Tactical Fighter Squadron bird and on the right wing is the Wing Commander's aircraft. Ron Matsuda and I were Instructor Pilots in the 21st.

The 20th Tactical Fighter Squadron trained aircrews for the German Air Force.

SEVEN ACTIONS THAT WILL CHANGE YOUR LIFE

- 1. Men (especially), out of courtesy to the fairer sex, always put the toilet seat back down when through.
- 2. When you decide to make coffee, add a pinch of salt to the grounds. Why? Adding salt to coffee activates our sensory receptors. Sodium ions found in salt prevent the taste buds from sending signals to the brain for the bitter flavor. At the same time, this mechanism enhances the sweetness of the coffee.
- 3. When you go the gas station to fill your gas tank, it is advisable to keep your gas tank at least half full to ensure the safety and longevity of your vehicle's fuel systems. Why? For several reasons:

Prevents sediment buildup: Keeping the tank full helps prevent sediment from clogging the fuel pump and filter, which can lead to engine damage.

Avoids condensation issues: An empty tank can lead to condensation, which can freeze and cause fuel lines to freeze, preventing the engine from starting.

Maintains fuel pump efficiency: A full tank allows the fuel pump to operate more efficiently, reducing wear and potential failure.

Reduces the risk of air intake: Keeping the tank full prevents air from being sucked into the fuel system, which can cause overheating and other mechanical issues.

- 4. When it's meal time and you are preparing to offer rice, take a glass and fill it with as much rice as you think you might need. Next, pour cold water into your cooking bowl with twice as much water as the measured rice. Place the bowl with water and rice in the microwave and cook for 20 minutes. You will have perfect rice every time.
- 5. When you decide to paint your walls—especially if it has been a while—purchase a box of TSP (Trisodium Phosphate) and mix with warm water. Wearing sturdy rubber gloves, wipe down the walls/area. Why? Using TSP on walls before painting is important because it effectively removes dirt, grease, and mildew, providing a clean surface that ensures better paint adhesion. It is an essential step in paint preparation, resulting in longer-lasting and more professional-looking results.
- 6. When you get your coffee and it has a "seam" on the top of the cup, always line up the spout hole with that seam. Why? To avoid spilling coffee on yourself. That bit of wisdom is especially valuable during night driving.
- 7. When you complete your "business" in the bathroom and use the last tissue, always replace the empty roll with a new one. Why? That is known as common courtesy in respecting the next person.

These are seven actions of many I have learned in my 75-plus years. I hope you find them likewise beneficial.


United States Air National Guard Birthday

That outfit, known today as the 102d Rescue Squadron, New York Air National Guard (ANG), is recognized as the ANG's oldest unit. The National Security Act established the ANG as a separate reserve component on 18 September 1947, concurrent with the creation of the U.S. Air Force.

Pow/MIA Recognition Day



POW/MIA RECOGNITION DAY remembers and honors those Americans who were prisoners of war and those who served and never returned home. It is commemorated on the third Friday of every September, a date that's not associated with any particular war. In 1979, Congress and the president passed resolutions making it official after the families of the more than 2,500 Vietnam War POW/MI. As pushed for full accountability. DOD's POW/MIA Accounting Agency continues the search for the missing, fulfilling the nation's promise to leave no service member behind.

GOLD STAR MOTHERS AND FAMILY DAY, originally Gold Star Mother's Day, specifically honors mothers who lost a son while serving in the United States Armed Forces. Observed on the last Sunday in September, this day recognizes the special sacrifice these mothers have made and the ongoing grief they carry. The day provides an opportunity for Gold Star mothers to connect with others who understand their unique experience. Many communities organize special events, memorial services, and support gatherings where these mothers can share their stories and find comfort in shared understanding. Gold Star Mothers and Family Day also educates the public about the ongoing impact of military service on families. While we often focus on veterans and active service members, this observance reminds us that military sacrifice extends beyond the individual to encompass entire families.

MOAA LUNCHEON PRESENTATION

"America's Mighty Military" Jack Barry, 1st Lt. USAF

Ladies and Gentlemen, this presentation is of a different nature and caliber of what we all may be used to or expecting. It is inspired by the most significant Arms Race experienced by the Cold War Arms Race sparked on September 15, 1969 when we successfully landed on the moon. Space became the new battlefield.

By definition, an arms race occurs when two or more countries increase the size and quality of military resources to gain military and political superiority over one another. The Cold War between the United States and the Soviet Union is perhaps the largest and most expensive arms race in history; however, others have occurred, often with dire consequences. Whether an arms race increases or decreases the risk of war remains debatable: some analysts agree with Sir Edward Grey, Britain's foreign secretary at the start of World War I, who stated "The moral is obvious; it is that great armaments lead inevitably to war."

Nuclear Arms Race

The United States' decision to use the atomic bomb was made after great debate, but still led to a massive loss of human life.



Though the United States and the Soviet Union were tentative allies during World War II, their alliance soured after Nazi Germany surrendered in May 1945.

The United States cast a wary eye over the Soviet Union's quest for world dominance as they expanded their power and influence over Eastern Europe, and the Soviet Union resented the United States' geopolitical interference and America's own arms buildup.

Cold War Arms Race Heads to the Space Race

The U.S. competition with the U.S.S.R. for technological dominance spurred the U.S. on to the first-ever landing on the moon. The Soviet's launch of the first Sputnik satellite on October 4, 1957, stunned and concerned the United States and the rest of the Cold War arms race soon became the Space Race.

You may have seen the documentary by world renowned documentary filmmaker
David L. Wolper titled "The Race for Space" released in 1959. I had the good fortune
working with David 1966-1968 as a trouble shooter for his National Geographic and Jacques
Cousteau TV series and two feature films: "The Bridge at Remagen" and "If It's Tuesday,
This Must Be Belgium" both released in 1969.

Missile Gap of the 1950s and the Cuban Missile Crisis in 1962 further fueled the Race.

Defending a country is serious business. And nobody takes this duty as seriously as the United States. Having what is arguably the strongest military globally, the American government spends good money (a whopping \$997 billion for defense in 2025) on various military expenses.



Among the most-costly of these is its wide array of war-ready aircraft, submarines, and vehicles. Here, we've compiled a list of the most expensive and impressive of these tools of defense. From a multibillion-dollar carrier aircraft to almost invisible planes, be prepared to learn about military vessels you never thought existed.

USS Gerald R. Ford

USS Gerald R. Ford - Cost: \$13.3 Billion

The most expensive aircraft carrier ever built and arguably the costliest individual weapon in service today, the USS Gerald Ford is America's flagship. At 1,106 feet long, the Gerald R. Ford is the first in the Gerald Ford-class ship, which began construction in 2005. The total cost is estimated to have been around \$12.8 billion in manufacturing costs, as well as an additional \$4.7 billion in research and development costs.

Seawolf-Class Submarine - USS Connecticut-- Cost \$3.5 Billion

The Seawolf-class submarine was made at the tail-end of the Cold War as a new and improved version of the Los Angeles-class submarines. Thus, it was designed with features like speeds of up to 35 knots and endure icy environments.

The B-2 Spirit

Northrop Grumman B-2 Spirit - Cost: \$2 Billion

The Northrop Grumman B-2 Spirit looks like something straight out of a sci-fi movie. Thanks to its flying wing design, it can go practically undetected by radar technology despite being 69 feet long and having a wingspan of 172 feet. What's more, the B-2 Spirit is a quiet aircraft and can only be heard coming once it's already passed overhead.

The aviation world witnessed history on June 21, 2025, when seven **B-2 Spirit Bombers** executed Operation Midnight Hammer. These flying fortresses penetrated Iranian airspace undetected, delivering devastating bunker-buster bombs to nuclear facilities. It was the most significant demonstration of American air power in decades. This wasn't just another military operation. It was validation of a technology that many considered too expensive, too complex, and too ambitious when development began in the late 1970s. The **B-2 Spirit bombers** has proven its critics wrong time and again. There are 19 in our arsenal, which are scheduled to be retired by 2032, with the B-21 Rider replacing it.

Boeing AH-64 Apache - Cost: \$13 Million

When Boeing manufactured the AH-64 Apache, it promised durability. And it looks like the company delivered, seeing as the helicopter has become the United States Army's goto all-weather chopper. It lives up to its job title as an attack helicopter.

The informative presentation offered attendees the opportunity to learn where their tax dollars go, reflecting on just a smattering of the many, many "tools" in our Country's military arsenal.


Mindful of Diana Ross' iconic song lyrics, our own 1st. Lt. Jack Barry is doing just that on behalf of MOAA and the Apple Valley Legacy Museum. And the Mohahve Historical Society, both of which he is an active member. Having come to Apple Valley in 1946 at age six, Jack is one of the few "Old Timers" still hanging around.

You may recall his fascinating presentation titled "The Early Days of Apple Valley" in which he shared what it was like to live in the Valley back in the 1940s and '50s, from a then-youngster. Word of this presentation spread rapidly and in July he made Part 1 of three of that presentation to the Apple Valley Kiwanis Club. He will be returning to the Kiwanis Club this month to present Part 2, with Part 3 tentatively scheduled for October. The Delta Kappa Gamma group—retired and active teachers—has scheduled Jack for their January 2026 meeting. Additionally, the Seniors With Inquisitive Minds (SWIM) has expressed interest in scheduling Jack for their meeting.

His "Early Days" program includes many historical photographs, most all from the digital archives of the Mohahve Historical Society. Over the past two years, Jack has been applying his photographic expertise by restoring, categorizing, and building a digital photo library for the Museum and Society—with some 2,100 images filed thus far.

The motivation for the digital library is to provide a platform on which individuals will be able to search and download historic photos and documents to meet their needs. Even more importantly, the library preserves priceless historical materials which could be easily lost, misplaced, or destroyed.


Over the past 18 months, Jack has also been applying his writing, publishing, and commercial art training by preparing 11 Society publications for re-printing. This required scanning previous editions, re-editing as deemed necessary, and producing finished new production art to send to the printer. The Mohahve Historical Society has a collection of historical books worthy of special note, like: *The Story of Rancho Yucca Loma*; *Bridges Spanning the Mojave River*; *The Arduous Road*; and the *History of Victor Valley*. These are in addition to their very popular *Mohahve Historical Books* series, the latest one being *Mohahve 7* which was just published this summer.





In August, Jack presented to us his "America's Mighty Military Arsenal" program, revealing the amazing military equipment available in our arsenal to protect this great Country of ours.

So, Jack is now "armed and dangerous" and ready to "reach out and touch someone" on behalf of not only MOAA but also the Apple Valley Legacy Museum and the Mohahve Historical Society.

The Air Force Flight Test Museum is in the midst of its most exciting transformation since 1992, when the Flight Test Museum Foundation (FTMF) erected the current facility at the corner of Rosamond and Lancaster boulevards on Edwards Air Force Base.

An aggressive fund-raising campaign is under way to move and expand the Flight Test Museum to outside the base's West Gate. The new museum will still be located on Air Force property but outside the base security fence making it accessible to the general public.

At it's completion, the \$7.75 million project will improve the experience for museum guests and provide a world-class venue for an aerospace-related science, technology, engineering, and mathematics (STEM) education program.

The 75,000 square foot facility must be funded completely by private contributions. It will include enough indoor exhibit area to house the majority of the Flight Test Museum's collection of historic aircraft and its many thousands of artifacts. Other indoor areas will include a classroom for aerospace-related STEM education programs, gift shop, museum offices and artifact restoration area. The new facility will also be large enough to host special functions and events.

The Foundation confirmed its support for the project and the initiation of efforts to secure necessary funding. "The location of the new museum will provide unencumbered access for aviation aficionados and greater opportunities for use by the educational organizations in southern California." Former FTMF Chairwoman Lisa Graysaid. "Our future STEM programs will be designed to engage youth in aerospace-related learning opportunities."

"We look forward to the community supporting what will be the largest single fund raising project for the museum," Rex Moen, Capital Campaign Chairman said. "We are confident people will make an investment to preserve flight test history and inspire future generations."




