ould you be surprised to discover that close to 50% of Christians are **not** registered to in our Legislature, who are vote?

What's the first **step** for a person who may have never participated in "politics" before? First thing, register to vote; because Vermont election law states, "At the time and place set for the town caucus, the voters of the party resid-

ing in the town shall meet in caucus and proceed to elect a town committee."

The town committee members present then elect delegates to serve on the county committee. The county committee delegates then elect state committee delegates who influence which candidates will be

(Continued from page 1) strongly supported or not. Each town can elect at least two delegates. How many more them whether the party adheres can be elected is determined by the number of votes cast (by voters) for the party's candidate for governor in the last election.

What's the **second step?** A political party? Yes!....Which one? I would want to check out where the party stands on moral issues such as those mentioned earlier. Each party should have a document called a "Party Platform" which details the beliefs, goals and objectives of the party. Call the Party Headquarters and ask them for a copy of their Party Platform, in writing. After a

review of the Platforms, ask to talk to the party chairman or the executive director and ask to its platform. Then make a decision on what party you want to be associated with and become salt & light within that party. None of them are perfect, but some come closer than others to the principles that all Christians believe in

There are currently three recognized political parties in Vermont, which are the Republican, Democratic and Progressive parties, each of which qualified in the last election by receiving at least 5% of the popular vote and have an organized party unit in at least fifteen towns. You can reach

the Republican Party at 802-223-3411; the Democratic Party at 802 229-1783 and the Progressive Party at 800-439-

Caucuses, which are held each odd year, hold their meetings between the 10<sup>th</sup> and the 30<sup>th</sup> of the month of September. The actual date is selected by each party's State Committee through its chairman. The time and place of each town's meeting is to be selected and communicated to the town or city clerk's offices.

the respective parties by calling ties in Title 17 of the "Vermont Statutes Annotated", Chapter 45, and especially sections #2303, 2304, 2305 and 2306. You'll become an "expert" overnight and well prepared to attend a caucus in September.

> If you go to the polls next year without having become associated with a party, you only have one vote which will count but you have no influence on other voters. By belonging to a party you have the opportunity to influence other party members and who they will support in the election. See you at the caucus!

## "Democracy" vs. "Democratic Republic" / "Constitutional Republic"

The form of government entrusted to us by our Founders was a Republic, not a Democracy; The Difference?

A Democracy conducts business by direct majority vote only. When an issue is to be decided, the entire population votes on it and the majority wins and rules. A Republic differs in that the general population conducts business by directly electing representatives who then vote on issues. Although a majority vote of the representatives will determine a policy; in a republic, the minority view will have some influence in the majority decision. The people, by direct vote, select their chief executive and their representatives; for this we are termed a Democratic Republic. Because we have a Constitution, we are also a Constitutional Republic.

This is important when we think of Judicial judgments made by our current "activist" Supreme Court Judges over the past seven years, which have forced their collective five opinions on the balance of Society and on the duly elected representatives in the Legislature. All it takes to change the judicial "climate" in Vermont is to elect enough Christian representatives who understand the balance of powers between the Legislative, Executive, and Judicial arms of government and the difference between a judicial judgment and a judicial opinion. The legislature is free to accept or reject the Supreme Court's interpretation of the Constitution, as it reflects the Framers' intent, not what a relativistic court thinks should be done. Judgments must be based on unchanging Biblical principles of right and wrong, not based on the Justices' "Supreme" opinions. In the Baker vs Vermont decision, the court itself admitted they didn't know any more about what was right or wrong than did the general population. However, Christians in Vermont knew what was right and wrong and knew the court had made a wrong decision. Although the Legislature had many good Christians in office, there were not enough to override the votes of the other Legislators. All the more reason to put more practicing Christians in office in the 2004 elections.

What can Pastors (or their assistants) do without running afoul of the election laws?

- 1. They can preach on the moral teachings of the church and scripture as they relate to Public Policy issues.
- They can discuss the positions of candiand on a non-partisan basis at church functions.
- They may distribute surveys, voting records, and political statements of candidates on a nonpartisan basis.
- 4. They may recognize a church function.
- They may urge their 5. congregations or parishes to register and vote.
- 6. They may conduct non-partisan voter

- registration tables on the premises.
- They may invite candidates to speak to Church members, preferably in a church hall or function room. to hear their views on issues of interest to the congregation or Parish members, and to respond to questions from them.

The above are not hard and fast rules but guidelines and should be treated as such. We hope dates on moral matters vou find them helpful as a tool to spark discussion with your Pastors.
