# The "Pulpit Initiative"

his initiative was ance Defense Fund (ADF) together with many courageous Pastors, as a legal effort to secure the right of Churches and Pastors to speak freely from their pulpits to their congregations; and to act freely, from a scriptural basis, on political matters without improper censorship/ regulation by the government. Because of a 54-year old regulation that legal scholars from all spectrums agree violates the First Amendment, many government officials, particularly the Internal Revenue Service (IRS), seek to limit what preachers may preach about. Specifically, they don't want Pastors telling their congregations what the Bible says about political issues and the agendas of particular individual candidates (for office).

In the words of Alan E. Sears, President, CEO & General Counsel of the ADF:

"Dozens of Pastors all across the Country are challenging these limits on their sermons so that if the government tries to penalize clergy when they preach freely from their pulpits about candidates and elec-

This student suddenly realized that he could be both a lawyer and a Christian. "The Alliance Defense fund showed me what my school was teaching me and how to combat it. I received the tools, the step by step process to follow to go back into the classroom and challenge my professors." The student concluded with the following thought: "I know that what I learned will go with me throughout my career into whatever doors God opens for me."

Sears subsequently decided to tap into the leading law schools, recruited the top students throughout the country, and began a program of his own using the principles he learned at the Blackstone Fellowship.

His first goal was to train 1,000 ADF attorneys. Yet it soon became clear that the early dream was too small, especially with nearly 1,000,000 lawyers in America, plus the explosion of same sex marriage now? In a recent ADF release cases and other assaults on America's Judeo-Christian values and religious freedoms, and so many other needs.

Several years ago, this writer became aware of the above organization and its leader. Founded by several Christian



Ministries, such as Campus Crusade and its leader, Dr. Bill Bright: Focus on the Family and its leader Dr. James Dobson; the late Larry Burkett of Christian Financial Concepts; the late Dr. James Kennedy, and respected Christian leaders Marlin Maddox and William Pew. Their insight and trust in God's providence appears to have been most prophetic, and led to their hiring of Alan Sears to become the visible leader of the new Ministry.

Why this topic and information to his Ministry's supporters, Sears felt it was necessary to set the record straight to dispel the IRS contention that a 54 year old regulation limits what preachers may preach about. Sears explained that "We've won zoning cases...and freespeech cases..and we're de-

fending churches in cases for the right to hire church workers who share the church's religious convictions and not hire those who don't. All of these were within our Ministry's mandate to defend religious freedom and clear a path for the Gospel." The Pulpit Initiative is another crucial step in defending religion by blocking efforts of aggressive government bureaucrats to exert censorship over the local church."

Note: Before the Pulpit Initiative even launched, the ACLU and its ally, the Americans United for Separation of Church and State, raised shrill voices and raced to print with accusations that completely missed -or deliberately misconstrued the effort. ADF's adherence to the truth really bothers and angers these organizations who are bent on

wiping out any vestige of God in America.

In his recent notes to supporters Sears concluded, "Encouraging a pastor to freely exercise his constitutional rights is a compelling example of empowering Christians to exercise their faith, and apply scripture to every aspect of life, including the selection of our national leaders and public policy."

The Alliance Defense Fund has rightly earned our thanks for retaining our Christian values in legal case wins, over and over again. Of course his ministry can only succeed if they are generously supported in their efforts with our prayers and, where possible, with our financial support of his work.


#### (Excerpt from Part 1)

They never intended for Christian principles to be divorced from public affairs . . . As Edmund Burke explained: "All that is necessary for evil to triumph is for good men to do nothing."

One of the founding fathers of the United States of America, Noah Webster,



delivered this admonition: Let it be impressed on your mind that God commands you to choose for rulers just men who will rule in the fear of God (Exodus 18:21).. If the citizens neglect their duty and place unprincipled men in office, the government will soon be corrupted. If government fails to secure public prosperity and happiness, it must be because the citizens neglect the Divine commands, and elect bad men to make and administer the laws.

And Charles Finney, a prominent minister in the early 1800s, succinctly declared: The time has come that Christians must vote for stability, to be restricted in honest men and take consistent ground in politics or the Lord will curse them . . . God cannot sustain this free and blessed country which we love and pray for unless the Church will take right ground.

It is time to believe and to behave differently. We are not a minority --- we are the majority!
