## **Constitution Corner**

#### **Article One, Section 8 of the** U.S. Constitution; Amendments IX and X

The recent attempts by the U.S. ers Granted to Congress. Congress to pass legislation establishing a governmentcontrolled healthcare system have deeply divided the nation. The Christian Action Ministry decided to look at the actual wording in the U.S. Constitution to see if such a piece of legislation passes the test of constitutionality. In other words, does the U.S. Constitution give our federal government the power or authority to take over and run the current, mostly private healthcare delivery system in the United States? Does the wording of the U.S. Constitution establish the federal level, through Congress, as the holder of the rights over the healthcare delivery system in the United States?

In order to answer that question, it is necessary to read Article One, Section 8 to see do that. We will summarize the list of powers Congress is given in the U.S. Constitution. This is referred to as the enumerated powers section. Since we are summarizing, this is not the actual long wording of the document. Our readers must read the actual long word- with other nations). ing in these sections themselves, bearing in mind we are summarizing. It is the duty of

every individual U.S. citizen to know his/her Constitution.

# Article One, Section 8: Pow-

**Subsection (1)** Congress has the power to collect taxes, to pay the nation's debts, and to provide for the common defense and general welfare of the nation; (2) to borrow money; (3) to regulate commerce; (4) to make laws regarding naturalization and bankruptcies: (5) to coin money and fix weights and standards; (6) to punish counterfeiting; (7) to set up a postal system and roads; (8) to promote science and the useful arts: (9) to establish lesser courts under the Supreme Court; (10) to punish piracy; (11) to declare war; (12) to raise and support armies for two years at a time; (13) to establish a navy; (14) to make rules for the regulation of military forces on land and sea; (15) to provide for calling out the militia; (16) authority to whether Congress is allowed to organize, train, discipline, etc. the militia; (17) establishing the seat of the U.S. government (eventually Washington, D.C.); (18) the ability to make laws to carry out any powers granted above or powers granted elsewhere in the Constitution (such as the ability to sign Treaties

> These sections must then be read in conjunction with

Amendments to the Constitution IX and X, which state that unless the U.S. Constitution explicitly grants certain rights to the federal government, the rights and power belong to the individual states and to the people. If the Founding Fathers and Framers of the U.S. Constitution meant for the federal government to assume power over this area, they would have said so explicitly. They did not. The power to provide a healthcare delivery system in the U.S. belongs to the individual states and to the people. If that were not true, we would have had a federal government healthcare delivery system in the U.S. from the beginning of our nation. We did not. That was not the intent of the Founders. They explicitly set up a military, a postal system, a banking system, a highway system, etc. but not a healthcare system. Their intent was to limit the scope of federal government power, and share power between the federal, state, and local/individual levels. This was the system our Founders thought best to keep the powers of the federal government limited. They did not mean for the federal government to possess total control over all aspects of the lives of its citizens, even in the face of the "general welfare of the nation" wording in Section (1), which applies to the nation as a whole, and not as mandates concerning citizens as indi-

viduals. That is one of the reasons our nation's early settlers and founders fled from Europe: loss of individual liberty (religious and otherwise). Federal control of a total medical care system like those found in Europe and Canada are constrained by the U.S. Constitu-

We are a Constitutional Republic, not a pure democracy. The United States of America operates under several legal founding documents. None of the three branches of our government can do whatever it/they want(s) to just because they vote to do it. They must respect the Founding Documents, the rights of individual states, the rights of the people, and the rule of law. All such laws and rulings must be in conformity with the wording of those documents, or the laws and/or legislation would be unconstitutional. If the citizens and the states don't like this fact, they can always amend the Constitution. We'll discuss that in a later issue.
