he Lord is not slow concerning his promise, as some count slowness; but is patient with us, not wishing that any should perish, but that all should come to repentance.
(2 Peter 3:9 WEB)

As Christians, we know a little about repentance, but what do we know about national repentance? How would it come about? What would it look like?

May I recommend a book? The Power of Return, by John Goyette, (2010) Shippensburg, PA, Destiny Image Publishers, Inc. The author, John Goyette, and his wife, Linda, began Green Mountain Christian Center in Bennington in the late 1970's and John is still senior pastor there. The Power of Return is a thorough study of 12 national revivals recorded in scrip-

ture. Each is unique, but there are some common elements to all of them: a strong, godly leader; a shared vision; the Word of God; unity; obedience to authority and, of course, opposition.

Who were the strong, godly leaders in ancient Israel? Only one of them was what we would call a member of the clergy. Only Ezra was descended from Aaron, although Samuel was from the tribe of Levi. Who were the other ten leaders? There was one general, Joshua, one governor, Zerubbabel, one palace worker, Nehemiah, and seven kings. Which brings us back to the question, what would national repentance look like in this country? We've had presidents call for a national day of Thanksgiving or "Humiliation, Fasting, and Prayer," and Lincoln's

proclamation was in response to a resolution by the Senate, but when have we "turned from our wicked ways?" (2 Chr. 7:14)

I had to ask this question when South Carolina's governor called on the state's legislature to vote to remove the confederate flag from outside the State House, the speaker of the State House in Mississippi similarly insisted the emblem be removed from his state's flag, and Alabama's governor ordered the flag removed from public grounds.

Christian individuals and even whole denominations have repented of their roles in slavery and race relations, but is there any record of southern civic leaders accepting Lee's military defeat as a divine rebuke of the "peculiar institution"?

Civic leaders are now saying, "You know what, states' rights aren't as important as individual rights. The state cannot exist without the individual." Did it really take an additional 150 years of injustice to concede have you asked yourself, that truth?

Yes, elected officials often seem to go whichever way they sense the political winds are blowing, but God looks on the heart and He,

after all, is the judge. Do you grieve over other national sins more than what is Daniel confessed the sins of touched on here? Can you and I do more than just pray for national repentance? Are we a "repentance constituency"? When you vote, would this candidate lead in repentance?

Let's not be self-righteous Northerners here. I know Vermonters with slaveholding ancestors and

Vermont's history is not without blemish. When his nation (Daniel 9:3-19), he consistently said, "We," not "They," even if he, personally, wasn't guilty of the sins he confessed.

He has shown you, O man, what is good. What does Yahweh require of you, but to act justly, to love mercy, and to walk humbly with

your God? (Micah 6:8 WEB)

## Supreme Court refuses to review non-citizen voting in Federal Elections

I t would seem like a nobrainer—to vote you should be a citizen.

However, the Supreme Court refused to consider letting states require evidence of citizenship when people register to vote for federal elections. An appeal from Arizona and Kansas was rejected in June of 2015.

The states were seeking authority to require poof of citizenship before registering to vote. The Court's refusal to hear the case is a victory for the Obama administration and voting- and minority-rights groups that battled the two states in court. It leaves intact a decision by a U.S. agency that blocked the states from requiring proof.

The Court seemed to defer to the federal form's requirement that prospective voters swear that they are citizens, under penalty of perjury.

Does that make sense? If you asked someone seeking to vote illegally if they were doing it legally, what would you expect for an answer?

It's the second high court defeat on the issue for Arizona. The state has a law that requires evidence of citizenship, but the Supreme Court ruled in 2013 that it couldn't be enforced when people use a standard registration document known as the "federal form" to register to vote for Congress and the president.

That 7-2 ruling left open the possibility that Arizona could impose its requirements through a different avenue. The court said the state could submit a request to the agency that developed the form, the U.S. Election Assistance Commission, asking it to tell Arizona voters they needed to supply proof of citizenship.

A 1993 law lets states use their own voter-registration forms as long as they also accept the federal form. Arizona and Kansas both demand proof of citizenship from would-be voters when they use the state registration application.

Arizona and Kansas said in their appeal that they now have two different voter lists — one of people eligible

only for federal elections and one of those who can cast ballots in state elections as well.

Why is this important? A close election can be swayed by a few votes, and if those votes are coming from people not eligible to vote, they can negate the votes of those who are eligible.

It is expected that Kansas and Arizona will continue to seek ways to keep their voting lists limited to citizens.

"It is emphatically the province and duty of the Judicial Department to say what the law is. Those who apply the rule to particular cases must, of necessity, expound and interpret that rule. If two laws conflict with each other, the Courts must decide on the operation of each. So, if a law be in opposition to the Constitution, if both the law and the Constitution apply to a particular case, so that the Court must either decide that case conformably to the law, disregarding the Constitution, or conformably to the Constitution, disregarding the law, the Court must determine which of these conflicting rules governs the case. This is of the very essence of judicial duty. If, then, the Courts are to regard the Constitution, and the Constitution is superior to any ordinary act of the Legislature, the Constitution, and not such ordinary act, must govern the case to which they both apply."
