Medical Center's Board of Trustees, without fanfare, and without notice to hospital staff, voted to change their decades-old policy of limiting their practice of abortion on hospital premises to rare cases of what they termed "medically necessary." As a result of the vote in the fall of 2017, elective abortions are now being performed as part of the UVMMC's "family planning" services. Why? What prompted the sudden policy change after 45 years?

he University of Vermont A bit of history is in order to connect some of the dots and much of it has to do with one central figure: the new Chair of the UVMMC Board of Trustees, Allie Stickney. As a former CEO of Planned Parenthood of Northern New England headquartered in Williston, Stickney has made a career out of abortion advocacy, taking top level positions within the Planned Parenthood network. From Williston, Ver-Manhattan, New York, Stickney built up her resume by dedicating herself to this highly controversial organization.

> The Vermont controversies involving Planned Parenthood are numerous and have often involved Planned Parenthood's radical ideas of sexuality for the young teens they come in contact with. To name just two instances, public outcry led to cancellation of the raunchy "Safety Dance" geared for students in the late 1980's, and in 2005, the Vermont Depart-

ment of Health shut down the Planned Parenthood sponsored "Man Phone" website, once it was found linked to pornographic materials. For more examples, go to www.vrlc.net and type SCANDALS in the search engine.

Nationally, Planned Parenthood scandals include the release of undercover videos capturing their employees callously discussing the sale of aborted baby body parts with research labs willing to pay for everything from fetal tissue to organs ranging from eyes to hearts.



Today, Planned Parenthood is the largest provider of abortions in the State of Vermont, the United States of America and in the world.

In 2019, Meagan Gallagher, CEO of Planned Parenthood of Vermont, proudly testified before committees of the House and Senate in Montpelier that the organization performed 1,100 abortions out of the 1,200 or so performed in Vermont in 2018.

Planned Parenthood Federation of America faces other ongoing investigations, as well as the loss of federal funding. Adding to the organization's headaches, numerous states have already moved to slice Planned Parenthood's state funding and/or have re-distributed the funding to other, less controversial, health care providers.

However, here in Vermont Planned Parenthood exerts near total control over the legislature and does so without media scrutiny. In the 2019 legislative session, the pro-abortion super-majority in the Legislature granted the abortion business broad immunity with passage of H. 57 - a bill written to ensure unlimited, unregulated, and unrestricted abortion throughout all nine months of pregnancy. The legislation goes further than any other anti -life legislation in the country, providing that all public entities and all other branches of government would be prohibited from restricting or interfering with abortion – even to protect viable babies or the safety of their mothers.

Governor Phil Scott signed the legislation into law, thereby endorsing and embracing the extreme legislation.



To add insult to injury, Gov. Scott also granted state tax dollars to Planned Parenthood after they refused to follow the rules for the federal Title X monies. Phil Scott has made it clear in his responses to constituents that he agrees with Planned Parenthood and has referred to abortion as "reproductive health care services." As such, Governor Scott has declared that our local taxpayer dollars should support Planned Parenthood's treatment of abortion as "just another method of family planning" even though the funds come from those of us who pay taxes and consider it morally offensive.

Just as the public was to discover that Governor Scott had previously set aside \$800,000 in 2018 for Planned Parenthood, the organization revealed through their tax filing that they had transferred over a million dollars to their political advocacy funds. Planned Parenthood of Vermont has substantial property and considerable cash on hand. Those assets will be used to take legislators out of office who dared to disagree with Planned Parenthood last year and bravely stood on the floor of the House to say so.

Nationally, Planned Parenthood Federation of America spends millions on political elections in order to protect their agenda of unlimited, unrestricted abortion throughout all nine months of a woman's pregnancy. Planned Parenthood's network of clinics is far better known for being the single largest provider of abortions, and for political activism, than for offering a full range of health care services for women.

In some states, hospital boards would consider Allie Stickney a liability on the basis of her affiliation with Planned Parenthood. Instead, her association with the abortion business appears to have paved the way for her to become the Chair of the Board of Trustees of Vermont's largest teaching hospital.

If those Vermonters who expect health care systems to recognize the value of every human life become dismayed and angry, those in charge of hospital policy will have to shoulder some of the blame - especially if they have allowed hospital policy to enact such a



monumental change, "under the influence" of the state's largest abortion business.

Similarly, Vermont legislators and Governor Scott will have to shoulder the blame for how they allowed themselves to be "under the influence" of one of the most radical, scandalridden, activist organizations in the state.

Recently, the smallest baby ever born (at 8.6 ounces, Sabine weighed about the same as an apple) has left the California hospital where she was considered a "micro-preemie", has gone home with her family and is thriving. The current pro-abortion majority in Vermont is on a collision course with science when it comes to their denial of life in the womb. The history books will document what happened here in 2019 and future generations may well judge harshly those who held so little regard for human lives.

But Governor Scott and those legislators who voted for H. 57 bear further responsibility for turning our once respected local form of government into an arena that allows the corrupting influence of power and money to rule the day. It is also entirely possible that our hospital systems will continue to be corrupted by similar political pressure, power and money.

If Vermonters do not rise up and cry foul now, it does not bode well for the future of our beautiful state.
